Claims submitted after the 5<sup>th</sup> of the month will be processed the following month.

You must submit and activate your fiscal year 2007-2008 calendar electronically before we are able to process any payments. Your calendar must be submitted on-line using your common logon user name and password at <https://www.ade.az.gov/commonlogon/Login.asp?Mode=Logon>. After clicking on LEA Calendars, you will find a manual that will walk you through submitting your calendar. Please note no payment will be issued without a current, active calendar submitted.

# *Permanent Special Education Institutional Voucher Daily Rates for FY2008*

*Pursuant to Arizona Revised Statute 15-1204, below are the statutory formula funding daily rates for school year July 2007 through June 2008. Rates are calculated based on Arizona mandated 180 school session days. Institutions will not be funded for any days beyond Arizona 180 mandated session days.*

## *Student funding eligibility age requirements -*

- 1.) Must be 3 years of age*
- 2.) Last day of funding is the day prior to a student's 22nd birthday.*
