SUBJECT: April 15, 2008 Basic calculations for Equalization Assistance Report (APOR 55 - 1) and Equalization Assistance and Additional State Aid Detail Report (APOR 64)

The April 15, 2008 apportionment reports applicable to the FY2008 equalization payment for your school district are posted on your district's home page on the ADE web site (<http://www.azed.gov/districts/default.asp>). The following items have been included in the April 15, 2008 APOR calculations:

- **ADMS data:** These student counts reflect the results of the FY2007 processing of student detail data as of June 30, 2007, as well as any additional 15-915 corrections through March 31, 2008. - **District Sponsored Charter School ADMS:** Student Counts are based on Fiscal Year 2008 100th day ADM, 100th day SPED and actual ELL data successfully submitted and processed by ADE as of 4:00 p.m. on Monday, March 31, 2008.
- **Rapid Decline, Audit Expense Adjustment and Type 03 HS Tuition:** All adjustments are included based on your submitted adopted budget as of July 15, 2007. Any changes to these amounts reflected on your adopted budget successfully submitted to ADE as of February 28, 2008 will be included on the districts' April 15, 2008 equalization calculation. Please check the submission status of your budgets and budget worksheets. Per A.R.S. 15-905 (E), FY2007 adopted budgets should have been submitted electronically to the Arizona Department of Education by July 18, 2007. - **Transportation Support Level (TSL):** Revised Route and/or Vehicle Inventory Report adjustments submitted before March 31, 2008 are reflected in the April 15, 2008 equalization calculation. - **Comparative Miles Adjustment - Vehicle Inventory vs. Route Miles:** The FY2007 comparative miles adjustment is included in this month's apportionment. Please review the district's Comparative Miles Report (TRAN40-2) which can be viewed on the district/charter home page at <http://www.ade.az.gov/Districts/EntitySelection.asp>. - **Advance Based on 100th Day Growth/ Advance Based on Growth:** Included for eligible districts submitting a signed growth request form found on ADE's web site at <http://www.ade.state.az.us/schoolfinance/Forms/GrowthForms/>. If the district submitted a form but did not receive growth reflected on page 2 of the APOR 55-1, it may be due to missing or late submission of student detail data.
- **Assessed Valuations:** TY2007 data by district and county have been revised to reflect final approved TY2007 assessed values from the county Board of Supervisors as of August 2007. TY2007 figures are used in the calculation of state aid in FY2008.
- **SRP Voluntary Contributions:** TY2007 data by district and county have been revised to reflect final FY2007 figures. TY2007 figures are used in the calculation of state aid in FY2008.
- **Additional State-Aid (Secure Payment):** The TY2008 Additional State Aid amounts have been revised to reflect the FY2007 data reported by the Department of Revenue in October.
- **Base Level Amount:** For FY2008, the Base Level Amount has been increased to \$3,226.88 per weighted student count. \$30.68 of this amount is designated for non administrative salary and benefit increases.
