Monitoring Visits

- ❖ Corrective Action Follow-Up visits have been set up and you should have received notification.
 - Letters are sent to the Superintendents with ELL Coordinators receiving a copy.

- ❖ Spring monitoring notifications will be mailed late September / early October.

- ❖ For a leg-up on a successful monitoring experience, come see the “Dos and Don’ts of SEI Compliance” breakout session.

Title III Grant Applications

- ❖ The allocations are in and Grants Management is open for your applications.
 - ALEAT plan should be in the system when you apply for Title III.
 - Title III items must be supplemental-above and beyond what you're providing for other students and not required by law.
 - Remember Professional Development **MUST** be included in Title III.

- ❖ Completion Reports
 - Should match what items were on the application that was approved.
 - File a revision prior to a completion report if items change after approval.
 - Warning Letters and tracking

Title III Grant Applications Continued

❖ Districts and Private Schools with ELLs

- A timely and meaningful consultation takes place to determine if and how the private school's ELLs will be provided support by the district.
- Materials & Equipment are only allowable if there's a program and must be retained by LEA.
