

**BACKGROUND INFORMATION:**

Pursuant to A.R.S. 15-204, allow acceptance of \$20,000 in federal funds from the National Endowment for the Arts in support of **Arts2Go**. **Arts2Go** is a one-year pilot project, created in collaboration with the Phoenix Art Museum, the Arizona Opera, Childsplay and the Arizona Commission on the Arts, to support artistic learning for participating teachers and students in conjunction with Arizona's College and Career Ready English Language Arts Standards.

This pilot will allow the Arizona Department of Education, in collaboration with the named partner organizations, to experiment with interactive professional development delivery in arts-related areas. Project work products will include teacher and student artifacts showcasing their ability to closely read exemplary works of art, as well as podcasts of the webinars themselves, all of which will be available as professional development resources in the Arts and College and Career Ready literacy areas on the ADE website. At the end of the project, the Department will have a template by which to design, develop and produce additional arts-related webinars for use by Arizona educators.


