BACKGROUND INFORMATION:

Laws 2012, Chapter 300, Sec. 2., required the Board to approve the Move On When Reading (MOWR) literacy plans for specific Local Education Agencies (LEAs) to receive K-3 Reading Support funds. In June 2012, the Board approved the procedures by which reading plans would be submitted, reviewed and approved, thus allowing distribution of funds to those LEAs.

Nine reviewers have been trained and are in the process of reviewing submitted LEA literacy plans. Each month, the Board will receive a list of LEAs plans deemed to contain sufficient criteria for Board approval and release of K-3 Reading Support funds.

As of the printing of these materials (February 14, 2013), the LEAs below have had their reading plans reviewed, and are recommended for State Board approval. *Please note that staff will update this document prior to the Board meeting in order to include any additional LEA plans reviewed and recommended for approval.*
