SUBJECT: Application for Capital Transportation Adjustment for the Purchase of a Transportation Vehicle (A.R.S. 15-963)

Applications and the FY04-05 Statement of Assurance (if applicable) must be received by the Department of Education, School Finance by February 6, 2006 at the close of business at 5:00 PM ADE time. **Late submissions cannot be processed.** All funds will be allocated to applying districts per a formula established by SBE.

The approved Capital Adjustment for Transportation amount for your district will be reflected on page 3 of 4 of the February 15, 2006 Basic Calculation for Equalization Report - APOR55-1.
