SUBJECT: May 15, 2006 Basic calculations for Equalization Assistance Report (APOR 55 - 1) and Equalization Assistance and Additional State Aid Detail Report (APOR 64)

The May 15, 2006 apportionment reports including the APOR 55-2 Sudden Growth Report are posted on your district's home page on the ADE web site (<http://www.azed.gov/districts/default.asp>). The following items have been included in the May 15, 2006 APOR calculations:

- **ADMS data:** FY05 Student Detail data successfully submitted as of August 31, 2005 and reports generated by ADE as of March 9, 2006, unless additional action has been taken to correct FY05 data through a 15-915. Contact the Data Analyst team at 602.542.5695 or by email at (SchoolFinance@azed.gov) if you have concerns regarding the student counts used in the calculation. If you require SAIS technical assistance, please complete the request form available on the System Training and Response (STaR) Team webpage at: <http://www.azed.gov/schoolfinance/STaR/>
- **Advance Based on Growth:** Included for eligible districts submitting a signed growth request form found on ADE's web site at <http://www.azed.gov/schoolfinance/Forms/GrowthForms/>. If your district submitted a form but did not receive growth reflected on page 2 of the APOR 55-1, it may be due to missing or late submitted Student Detail.
- **In order for growth to be included on the final FY 05-06 APOR55-1,** the district must have budgeted for growth on page 7 of 8, line 1b, of the 05-06 expenditure budget. IN addition, this budget must have been submitted pursuant to A.R.S. §15-948 and must have successfully completed processing.
- **Transportation Support Level:** Revised Route and/or Vehicle Inventory Report adjustments submitted by April 28, 2006 are reflected in the May 15, 2006 equalization calculation. Please check the district's comparative miles report, TRAN40-2. Please contact Shirley Willis at 602.542.8245 if you have any questions or concerns regarding the changes reflected in the TSL calculation on the APOR 55-1.
- **SRP Voluntary Contributions:** Qualifying levy amounts may have changed due to the SRP Voluntary Contributions being revised for the May 15, 2006 equalization calculations.

Other Adjustments:

- **DSCS ADM:** Student counts are based on 100th day ADM, 100th day SPED and actual ELL data successfully submitted as of April 28, 2006.
- **Reduction of ADM due to adult population of jails programs**
- **200th Day ADM adjustment**
- **Type 03 Tuition, Audit Expense Adjustments, Growth, and Rapid Decline will be revised after the May 15th budget revisions are completed.**
