SUBJECT: Application for Capital Transportation Adjustment for the Purchase of a Transportation Vehicle (A.R.S. 15-963)

Pursuant to A.R.S. § 15-963, your school district is eligible (see list on page 2 of this memo) to apply to the State Board of Education (SBE) for a Capital Transportation Adjustment for the purchase of a transportation vehicle. The FY 2008 Capital Transportation Adjustment Application and the FY 2007 Statement of Assurance, if applicable, have been mailed to your district. Applications and the FY 2007 Statement of Assurance (if applicable) must be received by the Department of Education, School Finance by **December 14, 2007** at the close of business - 5:00 PM ADE time. **Late submissions cannot be processed.** All funds will be allocated to applying districts per a formula established by SBE.

The approved Capital Adjustment for Transportation amount for your district will be reflected on page 3 of 4 of the February 15, 2008 Basic Calculation for Equalization Report - APOR55-1. The district APOR55-1 report is available on ADE web site at <http://www.azed.gov/districts/ReportsData/ReportsData.asp>. The district's FY2007-2008 expenditure budget must be revised by May 15, 2008 to reflect the Capital Transportation Adjustment approved by the State Board of Education. This adjustment **must** be reflected to Fund 625 (Section B of page 8), line 10. You must also increase your detailed Soft Capital budgeted expenditures on page 4 of 8 to realize this increase in budget capacity.
