Claims must be completed by the end of business **five days** after the month in which the service was provided (i.e. the August claim is due on September 7<sup>th</sup>). Claims submitted after the 5<sup>th</sup> of the month will be processed the following month.

You must submit and activate your fiscal year 2010 calendar electronically before we are able to process any payments. Your calendar must be submitted on-line using your common logon user name and password at <https://www.ade.az.gov/commonlogon/Login.asp?Mode=Logon>. After clicking on LEA Calendars, you will find a manual that will walk you through submitting your calendar. Please note no payment will be issued without a current, active calendar submitted.

# Permanent Special Education Institutional Voucher Daily Rates for FY2010

Pursuant to Arizona Revised Statute § 15-1204, below are the statutory formula funding daily rates for school year July 2009 through June 2010. Rates are calculated based on Arizona's mandated 180 school session days. Institutions will not be funded for any days beyond Arizona's 180 mandated session days.
