GENERAL INFORMATION

Arizona Board of Education rule R7-2-601 gives the Arizona Department of Education (ADE) the authority to approve foreign credential evaluation agencies that may verify that an applicant's degree(s) and/or coursework meet certification requirements. The agencies listed in this document have been approved by the ADE. Please note that the ADE will only accept foreign credential evaluations from agencies on this approved list or that meet the following criteria:

- The evaluation is from an agency with a membership in the [National Association of Credential Evaluation Services](#) (NACES) or the [Association of International Credential Evaluators, Inc.](#) (AICE); **-AND-**
- The evaluation verifies that official/authenticated educational records were submitted for review. The ADE will **not** accept foreign credential evaluations that are based on copies, screenshots, scanned copies, etc. of transcripts or other documents.
