## GENERAL INFORMATION

**Note:** Effective January 1, 2019, the ADE will only add a foreign credential evaluation agency to this list if they are a member of the [National Association of Credential Evaluation Services](#) (NACES) or the [Association of International Credential Evaluators, Inc.](#) (AICE).

## Information for Certification Applicants

- Please request a course-by-course evaluation of your out-of-the-country transcripts from an ADE approved agency.
- The ADE Certification Unit **only** accepts foreign credential evaluations from agencies on this approved list. If you submit a foreign credential evaluation from an agency that is not listed in this document, you will need to have a new evaluation completed by an ADE-approved agency.
- The original foreign credential evaluation must be mailed to the ADE Certification Unit **or** sent directly by the agency to [Certification@azed.gov](mailto:Certification@azed.gov). Copies of evaluations that are emailed or uploaded with an online application will **not** be accepted.
