Purpose and Use of the Online Sample Tests

The AZELLA Online Sample Tests were created to provide opportunities for educators to interact with students in grades three through twelve as they navigate the online format. The goal is for students to feel comfortable and confident when taking the Stages III, IV, and V AZELLA Spring Reassessment.

The samples included in this online test represent various common item types that a student will encounter on the online AZELLA Stage IV Reassessment Test. This Sample Test provides students with the format and feel of the Stage IV Online Reassessment and the opportunity to practice the use of the navigation tools within the actual testing platform.

Every year the full range of assessable Performance Indicators (P.I.) from Stage IV of the English Language Proficiency Standard (ELPS) are eligible for testing on the Stage IV Reassessments. This Sample Test does not contain a complete representation of all the item types on the Stage IV Reassessment and is not designed to encompass the full range of the Performance Indicators included in Stage IV. Therefore, instruction must continue to include all the English Language Proficiency Standards and Performance Indicators.

There are some critical differences between this Sample Test and the Spring Reassessment. This Sample Test is not scored. Proficiency levels are not provided based on the number of correct responses to the Sample Test. Student Responses are not saved once the student submits or exits any test section. Although student Speaking responses are recorded during the Sample Test session, once the test is submitted all student responses are discarded.

This User's Guide provides the directions and scripts needed to administer each section of the Sample Test: Listening, Reading, Writing Part 1, Writing Part 2, and Speaking. This document also provides a list of each item on the online Stage IV Sample Test, the point value associated with each item, the correct response for multiple-choice items, and the rubric identifier for extended responses. For extended-response items worth multiple points in Writing Part 2 and Speaking, there is an individualized rubric needed for the scoring of each item. The scoring rubrics are provided, for educator reference only, at the end of this document. Similarly, point values are provided to offer educators a general sense of the relative value of each of the items. Multiple choice items are worth 1 point each. The highest point value for any item is 4 points, and the lowest point value is .4, which only occurs with the Speaking "repeat" items. There is no score interpretation provided for this Sample Test.

The Stages III – V online test platform is called TestNav. This application needs to be downloaded onto the devices prior to testing. It is strongly recommended that students do the Online Sample Test before they take the Operational Test.

Educators may choose to utilize the Sample Test for classroom practice. One activity would be to follow a Sample Test section with a discussion of the correct responses for each item. This must be done before students submit their responses for the section. However, the main purpose of the Sample Tests is for students to become familiar with the testing platform, the navigation tools, the "Play" and the "Record" buttons, and the text box.

Test Administrators should monitor students to ensure that they are comfortable using the navigation tools and are progressing through the Sample Test at an appropriate pace for the proficiency and grade level.

The Speaking subtest is designed to be administered with a maximum of 6 students in a regular-size classroom. You can find the <u>Recommended Seating Arrangements for a</u> <u>Classroom Setting</u> document here.

Keep in mind that the Speaking Section requires the use of unidirectional, noisecancelling headphones in order to record the student responses appropriately. There is a required microphone check to verify that the equipment is working as expected prior to beginning the Speaking test. Students do not require a username and password to access the Online Sample Test. Teachers may choose to administer the entire Sample Test or selected Sections. Each section of the Sample Test is launched individually from the Arizona Sample Test landing page in TestNav.

If the goal is to simulate the actual test environment, teachers must insist that students do their own work on this test. Students should be seated so they cannot see each other's work. Creating an appropriate test environment for the Online Sample Test is another way to assist students to feel comfortable when taking the online Reassessment.

The Test Administrator will read some of the directions aloud to students, ensure that students are comfortable with the different item types, and respond to the students' questions regarding Sample Items and navigation tools. When reading the scripted directions, Test Administrators should speak clearly and fluently using a normal tone of voice.

This Online Sample Test includes pre-recorded narrative directions. These directions are offered to make this Sample Test as self-contained as possible. For your reference, transcripts of the *Audio Scripts* of the recorded directions are also provided in this guide.

There are items on this Sample Test that are the actual sample items from the online Stage IV Reassessment Test. The remaining items are similar to actual item types, but do not appear on the Stage IV Reassessment. For the purpose of administering this Sample Test, it is not advisable to alter the script or items. However, educators may want to create their own practice items modeled after these item types for use in the classroom.

The Operational AZELLA Tests require that specific administrative procedures be followed. The scripted directions, in audio format and Test-Administrator delivered, are formatted to guide you through the test administration and to help ensure proper testing procedures. The Online Sample Test is designed to parallel the procedures for the Stage IV Reassessment. Please review the directions in advance to become familiar with the scripted text and testing procedures.

Order of Administration

It is recommended to follow the prescribed test administration order (Listening, Reading, Writing Part 1, Writing Part 2, and Speaking) to emulate the student experience on testing day.

Introduction -About this User's Guide

What does the Test Administrator read?

The Test Administrator reads the TA Scripted Directions.

Examples of the format for the scripted directions are as follows:

SAY	Read aloud to students only what is marked with "SAY"
	and printed in bold type.

Text Printed in Italics Directions and information for Test Administrators are printed in italics. Text printed in italics should not be read aloud to students.

NOTE: In all directions delivered to students, recorded or TA scripted, the Test Administrator is referred to as the "teacher."

What are the **audio scripts**?

The audio scripts are transcriptions of the pre-recorded scripts included on the Online Sample Test that contain directions, sample items, and other materials that help the student navigate through the Sample Test. The audio scripts are included in this User's Guide for reference only and are not meant to be read aloud to students by the Test Administrator.

Examples of the format for the audio scripts are as follows:

Screen #X – Audio Scripts

Directions and information given to students via audio recording when students press the "Play" button on a given Screen or Sample Item.

What is a screen?

A *screen* is what students can see as they navigate through the Online Sample Test and include features such as the "Play" and record bars, tools, and icons. Screens are represented in this User's Guide with screenshots to help Test Administrators keep students on track.

Section 1: Listening

The Listening section of this Online Sample Test can be administered in a group setting. The Sample Test Listening items are recorded and formatted in the same way as the items on the operational tests. There is a limited amount of text that the Test Administrator will read from the script in this User's Guide. The Sample Test Administrator's role is to assist students with navigation questions, and answer student questions about tools and item types. The Test Administrator will need to monitor students' work to ensure they are following the directions and responding to the questions by clicking on their selected answer choice. This section of the Sample Test includes six (6) multiple choice items that are worth 1 point each. During the Listening session, students are allowed to take notes on their scratch paper.

The Stage IV Listening Sample Test items include comprehension skills from the ELPS. These include: understanding the elements of a story (e.g., main ideas, details), sequencing a series of events, summarizing the main idea and details from a presentation, and following multi-step directions.

Make sure each student has a set of headphones or earbuds in good working condition. Be sure that all desks are cleared of books and other materials not needed for the test.



TA Scripted Directions:

SAY Today, you will be taking the Stage IV Online Sample Test. This test has five parts: Listening, Reading, Writing Part 1, Writing Part 2, and Speaking.

Do not start the Sample Test until I tell you to do so. Electronic devices, such as cell phones, are not permitted during the entire testing session.

To obtain the best score possible, be sure to answer all the questions on the test. The computer will collect your answers. SAY Now, we will begin the Listening Section of the test. Talking during the Listening Section of the test is not allowed. You may take notes on your scratch paper as you listen to the passages and questions.

You can see that Section 1, which is the Listening Section, has six questions. You will respond to each question by selecting the circle next to your answer choice. If you want to change an answer, just click on the circle next to your new answer choice.

Click on the blue "Start" button.

Make sure students are now on the **Welcome Screen** (shown below) of the Stage IV Online Sample Test.

SAY Now, put on your headphones and click the "Play" button to listen to the directions.

After completing Sample A, students will be instructed to remove their headsets and wait for the teacher's instructions.

SAY Do you have any questions about Sample A?

Answer any questions that the students might have about Sample A. Make sure that all students know how to click the "Play" button, select the correct answer, and use the blue "Next" button.

SAY Click on the blue "Next" button and put on your headphones to start the Listening test.

You have now finished the AZELLA Listening Sample Test. You can make sure that you answered all of the questions by clicking the "Review" button. Check to see if there is a dark circle next to each number. A dark circle means that you did not answer the question. If you missed any questions, you can go back and answer them. When you are ready, you can remove your headset and wait for your teacher's instructions.

Monitor that students are comfortable using the "Review" button to go to an unanswered question. If a student cannot answer a question, it is ok to submit a Section or the entire test without having answered all the questions. The purpose of the "Review" tool is to ensure that a student did not leave a question unanswered by mistake.

There are 6 items on the Stage IV Listening Online Sample Test. The point value and correct response of each item are included on the table below for your reference. The item number can be found in the gray banner on the screen, above each item.

Test Administrators may choose to review the correct Listening responses with the testing group. Once a student submits his/her responses or exits the Sample Test, the student responses will no longer be available for review.

Section 2: Reading

For the Reading test, make sure each student has scratch paper and pencil. Headphones are necessary for Audio Directions, but not for the Reading items. Be sure that all desks are cleared of books and other materials not needed for the test. The students respond to each question by clicking next to their selected answer choice. During the Reading session, students are allowed to take notes on their scratch paper.

TA Scripted Directions:

SAY Now we will begin the Reading Section of the test. You must remain silent until the conclusion of the testing session. The Reading Section contains several passages followed by multiple-choice questions.

Electronic devices, such as cell phones, are not permitted during the entire testing session.

You can see that Section 2, which is the Reading Section, has 18 questions. You will respond to each question by selecting the circle that corresponds to the answer you choose. If you want to change an answer, just click on the circle next to your new answer choice.

Now, click on the "Start" button. Put on your headphones and click on the "Play" button to listen to the directions.

Reading Section Audio Scripts:





This is the AZELLA Reading Sample Test for grades six, seven, and eight. The Sample Reading Test has multiple-choice questions. Some of these questions are about a passage that you will read on your screen. Click the blue "Next" button at the top of the screen for Sample A.

Directions: Read the sentence with the missing word. Read the question. Read the four answers. Mark your answer by selecting the circle next to your answer choice. The correct answer for Sample A is "talks," which is the last answer choice. If you did not select "talks," you can change your answer now. Make sure the correct answer choice, "talks," is selected for Sample A. Raise your hand if you have any questions. If you don't have any questions about Sample A, click the blue "Next" button and go to Sample B.

Screen #3 – Directions for Sample B



Look at the <u>picture</u> of Sample B on this screen. The title of the story for Sample B is "Village Stew." This story has more than one question. You will be able to see the story with every question. You will use the blue "Next" button to go from one question to the next. You will be able to see the story for Sample B on one part your screen. The whole story cannot fit on that part of the screen at one time. You will need to use the scrollbar to read the whole story. You will see a question on the other part of your screen. Sample B is the first question for this story. You will read the story and the question before you answer the question. You might want to take notes on your scratch paper or use some of the computer tools to help you select your answer. One of the computer tools you might want to use is the highlight tool. You will mark your answer by selecting the circle next to your answer choice. Click the blue "Next" button to go to Sample B and wait for instructions from your teacher.

After listening to the directions for Sample B, students will be instructed to remove their headsets and wait for the teacher's instructions.

Reading Samples B and C provide an opportunity to assist students in understanding the features of reading comprehension items that are associated with a Reading passage. For students with limited experience with online reading tests of this type, you may need to provide more explicit directions and assistance than is offered in the script.

TA Scripted Directions:

- SAY When you go to Sample B you need to make sure that you scroll all the way down the passage so you can read the whole passage and see the pictures that go with the passage.
- SAY Some of the passages have more than one picture and some additional information that you might miss and that you will need to be able to answer the questions.

- SAY Remember that you are going to read the passage first, then you are going to answer the question in Sample B, and the last thing you are going to do is click the "Play" button to listen for more directions.
- SAY After everyone is done with this story and this question, I will tell you it is ok to click "Play."

Wait until students have selected their answers and ask them if they have any questions. After you answer the students' questions, ask them to put on their headsets and click the "Play" button.

Screen #4 -Sample B



The correct answer for Sample B is "The village people learned cooperation is good." which is the third answer choice. If you need to change your answer you can do it now. Raise your hand if you have any questions. If you don't have any questions about Sample B, click the blue "Next" button and go to Sample C.

Look at Sample C. This is the same story that you just read for Sample B, but there is a new question. Read the question and select your answer choice for Sample C. You will mark your answer by selecting the circle next to your answer choice. Last, click "Play" to continue to listen to the directions.

The correct answer for Sample C is "Because they had very little food.", which is the first answer choice. If you need to change your answer to a question, you can do it now. Raise your hand if you have any questions. If you don't have any questions about Sample C, click the blue "Next" button and begin answering the Reading questions.

NOTE: Students do not have to keep their headsets on. However, students will need headphones after item #18 to listen to the End of Section 2, Reading directions.

After completing Item #18, students will be advised to review their responses using the "Review" screen. They will then be instructed to remove their headsets and wait for the teacher's instructions. You can further assist students to use the "Review" page. You can also review the correct Reading responses with the testing group.

Students should then proceed through the End of Section and Submit process for Reading. Remind students that once they exit a section of the Sample Test, their responses will no longer be available for review.

The Writing Domain is administered in two parts. The first part of the test is Section 3: Writing Part 1, which is a series of multiple-choice questions, and the second part, Section 4: Writing Part 2 has two open-ended writing prompts.

In addition to the Writing Performance Indicators, Part 1 questions apply sentence construction and grammar performance indicators from the Language Strand of Arizona's English Language Proficiency Standards.

TA Scripted Directions:

SAY Now, we will begin Part 1 of the Writing test. You can see that Section 3, Writing Part 1, has 12 questions. Talking during the Writing portion of the test is not allowed. If it helps you to select your answer choice, you may write on your scratch paper.

Look at Sample A. Directions: Read the question and the four answer choices. Mark your answer by selecting the circle next to your answer choice. The correct answer for Sample A is "I have three kittens.", which is the third answer choice. If you did not select "I have three kittens." you can change your answer now. Raise your hand if you have any questions. If you don't have any questions about Sample A, click the blue "Next" button and begin answering the Writing questions.

Test Administrator answers any question that students may have about Sample A. Students should then proceed to answer the multiple-choice Writing Part 1 questions, the End of Section directions, and the submit process.

For the Writing Part 2 test, make sure each student has scratch paper and pencil. Headphones are necessary for Audio Directions, and for the audio recordings of the stimulus (if applicable), prompt, and checklist of the writing items. The audio recordings of the writing items are available to all students, but it is the student's decision whether to listen to them. Be sure that all desks are cleared of books and other materials not needed for the test. The students respond to each question by typing in the text box provided on the screen. During the Writing Part 2 session, students are allowed to take notes, prepare an outline or graphic organizer, or write a draft paragraph on their scratch paper.

The Speaking test is administered to students individually or in small groups. Be certain the student's response to each of the scripted questions is strong and clear. If not, ask the student to answer again in a stronger and clearer voice. Practice as much as needed for the student to feel comfortable answering the questions and managing the "Listen" and "Record" functions. Students' spoken responses for the Sample Test are recorded and available for review using the Speaking response replay feature. Similar to the operational tests, each item of the Speaking Sample Test has a maximum recording time between 15 and 60 seconds.

Score 5: Ideas are expressed and developed clearly; conventions of Standard English are successfully incorporated; sentences are varied with both simple and complex structures; writing is organized and clearly moves from one sentence to the next; writing is focused and descriptive. A score point 5 will include:

- An idea supported with relevant reasons, examples, and/or details; characters and setting as appropriate.
- Command of grammar (including syntax) and usage with few or no errors.
- Correct capitalization and end punctuation; infrequent errors in internal punctuation.
- Infrequent and/or minor spelling errors that do not impede the reader's comprehension.

Score 3: Main idea is present; few details are evident although some are general. Writing includes errors in Standard English conventions which impede communication. There is a hint of sentence variation, but attempts are often unsuccessful. Vocabulary is limited. A score point 3 will include:

- Main idea present; details randomly placed; simplistically stated character(s) and/or setting as appropriate.
- Errors in grammar (including syntax) and usage that begin to confuse the reader.
- Frequent errors in capitalization and punctuation that begin to impede communication.

- Frequent spelling errors that begin to impede reader's comprehension.
- Organization difficult to follow; transitions often missing; beginning and/or ending that may be missing.

- Some evidence of connection to the prompt/question stated or implied.

Score 2: Main idea is discernible; details are not always tied to an idea and are sometimes off topic. Errors in Standard English conventions impede communication. Sentences are often incomplete or are simplistic in structure. Vocabulary is limited and repetitive. A score point 2 will include:

- Ideas vague and/or simplistic; details sometimes unrelated; if appropriate, characters and/or setting not identified, although a name may be mentioned.
- Errors in grammar (including syntax) and usage that impede communication.
- Beginning capitalization and end punctuation are often incorrect. Internal punctuation not correct if used.
- Spelling errors that impede reader's comprehension.
- Organization non-existent; no cohesiveness among the sentences; beginning and ending missing.
- Repetitive and/or incorrect words and phrases.

Score 1: No main idea is present; there is only a list of English words and phrases with no connection to one another. The use of Standard English conventions is not evident. Sentences are incomplete or are random words strung together. Vocabulary is the repetition of a few words that offer no cohesive meaning. A score point 1 will include:

- Absence of ideas; if appropriate, characters and/or setting not identified, although a name may be mentioned.
- Errors in grammar (including syntax) and usage that impede communication.
- No consistent evidence of capitalization and punctuation.
- Spelling errors that impede the reader's comprehension.
- Organization non-existent; no cohesiveness among the words and phrases; beginning and ending missing.

Oral Reading Rubric - Decoding

Rubric ID: III-IV.OR.1 (Decoding) Stages III-IV 0-1 point Use for item #3

Rubric interpretation: Although these items are included in the Speaking section of the test, these items test Oral Reading skills found in the Reading domain of the ELPS. The decoding rubric is a scoring tool to measure correct decoding of multi-syllable words. The item in Stage III assesses students' ability to correctly decode words. The student is presented with three words and they must use their knowledge of sound-letter relationships to decode the words aloud with clear pronunciation. The rubric is defined by score points 0-1. The student must decode all three words correctly to earn a score point 1. Responses that earn a score point 0 indicate that students cannot fluently decode the three words.

These items help identify whether students are aware of the sounds represented by letters. Decoding words is a fundamental skill of fluent readers. Word-recognition skills must be developed to the point of fluency if comprehension benefits are to be maximized. Students must demonstrate competency in this skill so that they will have access to information presented in the mainstream classroom.

Score 1: Student correctly decodes all three words using understandable English.

Score 0: Student incorrectly decodes one or more words using unintelligible English.

Oral Reading Rubric – Oral Reading Fluency

Rubric ID: II-V.OR.3 (Oral Reading Fluency) Stages II-V 3 points Use for item #13

Rubric interpretation: Oral Reading Fluency (ORF) is made up of two components – Expressiveness and Words Correct Per Minute (WCPM). Each of these components has a separate rubric and contributes 50% to the student score.

Oral Reading Fluency - Expressiveness:

Expressiveness in Oral Reading Fluency is characterized by smooth, rapid reading evidenced by ease of decoding and appropriate use of phrasing, pausing, and expression to convey meaning.

Students who demonstrate competency in this skill have the ability to access information in the mainstream classroom. An incorrect response or no response earns a score point 0. Students who struggle with this skill require more instruction to access information presented in the mainstream classroom.

Score 3: Response meets one or more of the following conditions:

- Reads primarily in larger, meaningful phrase groups fluently.
- Most, or all, of the story is appropriately-paced.
- Consistently uses organizational features and contextual clues to read with expressive interpretation. (Rating equates to "Proficient.")

Score 2: Response meets one or more of the following conditions:

- Reads primarily in three- or four-word phrase groups. Some smaller groupings may be present.
- The phrasing is mostly appropriate. Some pausing and staccato rhythm may be apparent.
- Use of organizational features or contextual clues to create expressive interpretation is inconsistent. (Rating equates to "Intermediate.")

Score 1: Response meets one or more of the following conditions:

- Reads primarily word-by-word or in two-word phrases. Some larger word groupings may be present.
- Word groupings seem awkward and unrelated to the larger context of the sentence or passage.

 Reading is laborious and little or no expressive interpretation is present. The student's fluency may impede the listener's comprehension. (Rating equates to "Pre-Emergent/Emergent/Basic.")

Score 0: Response meets one or more of the following conditions:

- Unintelligible speech or foreign language
- Response is 5 words or less (silent)
- Response is off-topic (Student is speaking in English, but not reading the passage.)

Oral Reading Fluency Words Correct Per Minute:

The number of words correctly read per minute. WCPM is calculated using a pro-rating formula by which the number of words read correctly is divided by the duration of the reading (in seconds) and multiplied by 60. In cases where the student reads for the entire minute, the words read correctly is the WCPM; in cases where the student reads for less than the entire minute, a WCPM score is extrapolated.

For each score point, 0-3, each AZELLA item has a specific performance range of WCPM which is based on the difficulty of the item. The ranges shown below reflect the AVERAGE range for all items at a Stage. See APS score charts for cut scores for each AZID.

Speaking Rubric

Rubric ID: II-V.S.4 (Extended Response) Stages II-V 0-4 points Use for items number: #2 and #4 through #12

Rubric interpretation: The AZELLA 4 Point Speaking Rubric is a scoring tool that measures correct oral English responses to given stimuli in two or more sentences. The items in Stages II, III, IV, and V assess students' ability to orally respond to stimuli using correct grammar and understandable English. The rubric is defined by score points 0-4. Students who correctly respond to two separate questions using correct English grammar and intelligible English earn a score point 4. Some items will ask a student to respond in two or more interrogative sentences.

Score 4: Student formulates a response in correct understandable English using two or more sentences based on given stimuli.

- Student responds in complete declarative or interrogative sentences.
- Grammar (including syntax) errors are not evident and do not impede communication.
- Student responds with clear and correct pronunciation.
- Student responds using correct syntax.

Score 3: Student formulates a response in understandable English using two or more sentences based on a given stimuli.

- Student responds in complete declarative or interrogative sentences.
- Sentences have minor grammatical (including syntax) errors.
- Student responds with clear and correct pronunciation.

Score 2: Student formulates an intelligible English response based on given stimuli.

- Student does not respond in two complete declarative or interrogative sentences.
- Student responds with errors in grammar (including syntax).
- Student attempts to respond with clear and correct pronunciation.

Score 1: Student formulates erroneous responses based on given stimuli.

- Student does not respond in complete declarative or interrogative sentences.
- Student responds with significant errors in grammar (including syntax).
- Student does not respond with clear and correct pronunciation.

- Student formulates responses in non-English.
- Student does not respond.

Scoring Repeat Items

Use for item #14

At every Stage the AZELLA includes 10 repeat items. Educators are encouraged to practice repeat item types with students so that they are familiar with this format and can respond comfortably when encountering these items on the actual test.

The ten repeat items as a whole count for 4 points of the actual Speaking test of the Stage III Reassessment. Although each individual item is only worth .4 point, the electronic scoring engine used for the AZELLA Spring Reassessment is trained to measure multiple characteristics of the student's oral response.

There are three general characteristics that the Speaking "Repeat" items are scored on: accuracy, fluency, and pronunciation. For the purpose of scoring AZELLA Sample Test "Repeat" items, the following definitions for *Fluency* and *Pronunciation* are provided.

Fluency: Smooth, rapid speaking evidenced by appropriate rhythm, phrasing, pausing, and word emphasis in continuous speech.

Pronunciation: Accurate pronunciation as evidenced by the ability to produce consonants and vowels, applying stress clearly and accurately in sentence context, and utilizing accurate phonological forms (phonemes and lexical stress) in everyday words.
