



# Important Timelines for 2020-2021

# Implementation of New SEI Models

- EL legislation passed and signed into law on 2/14/19 changed the minimum required daily minutes of ELD to:
  - 120 minutes K-5
  - 100 minutes 6-12
- SB1014 required the State Board of Education to approve research-based SEI models for districts and charter schools for 2020.
  - ✓ Pull-Out Model
  - ✓ Two-Hour Model
  - ✓ Newcomer Model
  - ✓ 50-50 Dual Language Immersion
- LEAs are expected to choose from the approved SEI models for implementation beginning School Year 2020-2021.



# Arizona's Language Development Approach



# Important Considerations

- Targeted and explicit English language development at the appropriate level of language proficiency is for ELs only.
- Grouping exceptions are no longer an option for Targeted ELD.
- ELs have access and opportunity everyday to grade-level content alongside native English-speaking peers.
- English learners should not be segregated for the majority of their day.
- Individual Language Learner Plans (ILLPS) are no longer an option.
- The 4-hour model is only an option as part of a Newcomer Program.

# Implementation of Revised ELP Standards

- The Arizona State Board of Education approved the ELP Standards in December of 2018.
- During School Year 2019-2020, ADE has been working with the ELP Standards committee to create resources and training to support implementation of the new standards.
- LEAs are expected to start including the revised standards in lesson plans during School Year 2020-2021.
- AZELLA will continue to be based on the 2010 ELPS; therefore, a map aligning the 2010 ELPS and the Revised ELPS will be provided to LEAs for use in planning.

# Important Considerations

- The English Language Proficiency Standards, grade-bands are divided into Reading Foundational Standards (K-5 only) and 10 ELP Standards.
- The ELP Standards are organized according to a schema that represents the following types of communication: ***Productive Communication, Receptive Communication, Interactive Communication, and Language.***
- The ELP standards are written to align with Arizona's ELA standards, intended to build language in a way that provides access and opportunity to grade level content.

# ELP Standards in Relation to Communication Types

Standard #:	Standard:
1	Construct meaning from oral presentations and literary and informational text through grade-appropriate listening, reading, and viewing
2	Determine the meaning of words and phrases in oral presentations and literary and informational text
3	Speak and write about grade-appropriate complex literary and informational texts and topics
4	Construct grade-appropriate oral and written claims and support them with reasoning and evidence
5	Adapt language choices to purpose, task, and audience when speaking and writing
6	Participate in grade-appropriate oral and written exchanges of information, ideas, and analyses, responding to peer, audience, or reading comments and questions
7	Conduct research and evaluate and communicate findings to answer questions or solve problems
8	Analyze and critique the arguments of others orally and in writing
9	Create clear and coherent grade-appropriate speech and text
10	Make accurate use of standard English to communicate in grade-appropriate speech and writing

Standards 1 and 2 represent **Receptive Communication** (Listening and Reading).

Standards 3-5 represent **Productive Communication** (Speaking and Writing).

Standards 6-8 represent **Interactive Communication** (Listening, Speaking, Reading and Writing)

Standards 9-10 focus on the **Language** (Vocabulary/Grammar) required to support Standards 1-8.
