Menu Planning

Observation: During the month of review, SFA served K-8 meal pattern for parent pick-up / distance and Answers for the National School Lunch learning due to grade grouping K-8 being the most popular age group for the community. Additionally, staff was unable to determine age grouping for kids during parent pick-up. In-person learning resumed prior to the on-site review and parent pick-up was also available at that time. SFA continued to serve in- NSLP or SBP meal pattern for the age/grade groups person students (grade grouping 9-12) and parent pick-up (K-8 most common age grouping) K-8 meal pattern. SFA communicated plan with SFSP Specialist, implementing the age grade/group requirement however, was not aware grade grouping 9-12 inperson students should be provided 9-12 meal pattern because they are the only population served in that area.

Referred to SP 09-2017 2017 Edition of Questions Program's Seamless Summer Option # 44. [Revised] Do SFAs operating SSO have to follow the age/grade group requirements?

SFA is currently serving grade grouping 9-12 inperson students the 9-12 meal pattern.

SFAs offering SSO must follow the established at the site. However, SFAs operating open and restricted open sites that have difficulty may work with their State agencies to make accommodations. These accommodations may include using a single age/grade group meeting the minimum meal pattern requirements for the most common age/grade group attending the site. This holds true for both school and non-school sites. All accommodations must possess a reasonable iustification for the need to deviate from age/grade group requirement and be added as an addendum to the agreement between the SFA and State agency. Additionally, these accommodations only apply to open and restricted open sites where meals are served to all children in the community on a first come/first served basis. All other sites that serve an identified group of children, including closed enrolled sites and camps, must follow meal pattern for each age/grade established in 7 CFR 210.10 and 7 CFR 220.8.
