Income Eligibility 1 & 2 Guidance

Articles over the last two years in the Grader shared information regarding the various measure of poverty and how they work together and when they do not. It is important to remind everyone that Income Eligibility 1 & 2 must be entered in the SIS system for the individual students in order for them to be counted in any of the public reported Accountability data sets.

The requirements for LEAs to report student level Income Eligibility I and II indicators has not changed. Accountability, other programs, and grants will each consume the Income Eligibility I and II indicator data for various purposes; this includes the P-EBT program.

SPECIAL NOTE: Income Eligibility Indicators I and II are not utilized for P-EBT benefit determinations only when a school participates in one of the Special Provision Options of the NSLP; students attending these schools are automatically eligible for P-EBT, contingent upon the learning model reported for the school.



Static File Inquiries and Data Correction Windows

There will be three releases of the static file starting in early June. Each release serves a unique and distinct purpose. Please be sure to review the Grader, and any communication from Achieve, for announcements regarding these files and to not miss important dates. Please reach out to Achieve@azed.gov should you have any questions.

1. Static File Version 1 – Early June – This file will be the enrollment, program, and FAY validation/correction file.
 - a. The following items detail what should be checked:
 - i. The file should be carefully reviewed to ensure all students that a school expects to be included, based on enrollment dates, are not missing
 - ii. The file should be carefully reviewed to ensure program enrollment is correct:
 1. Special Education is dependent upon October 1 status
 2. Income Eligibility is updated throughout the school year
 3. English Learner is dependent upon having an identified EL need
 - iii. FAY should be reviewed for accuracy
 1. Students are considered FAY if enrolled within the first ten calendar days and continuously enrolled through Monday, May 3. FAY status is used for ELA and Math Assessments and all calculations (except for EL, chronic absenteeism, and graduation)
 2. Students are considered AZELLA FAY if enrolled within the first ten days of the calendar year and continuously enrolled

until the last day of the original EL testing window. AZELLA
FAY is used for EL calculations

- b. All corrections to the file must be completed by **July 15** through a school/district/charter holder SIS to be accurately recorded and be reflected in future releases
2. Static File Version 2 – August – This file will include any student’s aligned assessment and growth data, and students who may have had corrections made in the school’s SIS
- a. The following items detail what should be checked:
 - i. Only students that had valid assessments and were not left in any of the assessment correction applications will have assessments aligned to the student
 - ii. Only students that had a valid assessment from 2019 and were not left in any of the assessment correction applications will have previous assessments included
 - iii. Only students with assessments from i and ii will receive growth in the following grades/subjects:

- b. Any questions or concerns regarding missing assessments or data should be sent to Achieve@azed.gov. Accountability will work with Assessments to identify issues with the data and take corrective action if required.
3. Static File Version 3 – September – This will be the final file.



Static File Codebook

The Static File codebook will be made available when the first version of the static file is released. The following is a list of changes from last year’s codebook:

Opening of 2020-2021 A-F Self-Report Data

The A-F Self Reporting Data application opened on ADEConnect on May 3rd, 2021 in order for schools to submit their self-reported data components (CCRI, Credits Earned, and On-Track to Graduate). The application will close on **July 30th, 2021 at the end of the business day**. After this deadline, schools will no longer be able to submit data for the 2020-2021 school year. Year-End Procedures for Withdrawing Concurrently Enrolled 12th Grade or Early Graduating Students

Guidance: Schools that concurrently enroll students should consistently use the W1 code to withdraw the student prior to that student receiving the G code at the school issuing the diploma.

Support:

An Arizona student may only graduate from one school after meeting the high school requirement stated in [A.R.S. § 15-701.01](#). This guidance is to provide the process for properly exiting students from concurrent enrolled schools and to ensure the integrity and quality of graduation rates in the state.

Exit and withdrawal codes are specific to the student's membership at the school and are not aligned to the courses for which they are enrolled. Students who are concurrently enrolled must finish all required coursework and receive credit prior to receiving a graduation code. The school that has the student concurrently enrolled (not issuing the diploma) needs to exit the student with a W1 prior to the graduation code being assigned by the school issuing the diploma. Example: A student may receive a diploma from High School A, but is concurrently enrolled at High School B for CTE courses. In this case, High School B should exit the student with a W1 prior to the student being exited from High School A with a G.

STC Grade Scale Availability for Fiscal Year 2021 and Forward

ADE's Accountability, AzEDS, and ASU's Decision Center have been working on the use of Student Teacher Course data and its potential value in research over the past two plus years. One area that needed support and clarification was final course grades and the diverse submissions in that area. There will be a soft rollout of the following changes/reporting for STC. Because of the workload, stress, and changes the pandemic brought upon schools, districts, and charter holders, this new reporting for FY21 is

OPTIONAL for the field. It will remain optional in the 2021-2022 school year. The optional status will be re-evaluated prior to the 2022-2023 school year.

Schools, districts, and charter holders have their own unique grading based on the needs of their entity and approved grading scale. By using a three tier method, analysis can be accomplished despite the variance that exist in the field.

CodeValue	Short Description	Additional Information
Above Average	Above Average	Final grade that means the student performed better than expectation, higher than average. Comparable to Bs, As on a typical A-F scale.
Average	Average	Final grade that signifies average performance. That may be a C on a typical A-F scale, a "P", passing on a pass/fail scale.
Below Average	Below Average	Final grade that states a student performed below average. That may be a D or an F on a typical A-F scale, a "F", failing on a pass/fail scale.

Regardless whether a school uses pass/fail, traditional A-F grades, check marks, or smiley faces, they can be mapped to one of the three descriptions. Please reach out to AzEDS or your SIS vendor on the processing of this new data point.

Data reporting or findings by ADE and our ASU partners from the work with this new data point will be shared upon its completion with readers of the Grader.



Fiscal Year 2022 Approved Alternative Schools

Fiscal Year 2021 A-F Business Rules

The draft of the FY 2021 A-F Business Rules will be posted to the Accountability website on our [Resources page](#) when the static file is released. The A-F Business Rules detail how components for state accountability will be calculated. The largest change this year concerns the growth component. Normally SGP is calculated by comparing a student's current year test scores to last year's test scores. However, this year data from FY 2019 will be used to calculate skip year growth due to the lack of assessments in FY 2020. SGTs are not included in this year's business rules as there is a new assessment scheduled in the 2021-2022 school year. Where appropriate, the Business Rules identify which year data is being drawn from. Per SB2402 letter grades will not be assigned to schools this year and final points will not be calculated. EL Amendment Sunset

The EL Amendment App found within ADEConnect has assisted LEAs and ADE in addressing data issues for the A-F State Accountability system that may have occurred in English Learner data. Over the last few years, two major things have occurred: the development of AzEDS and changes in the appeal process for A-F State Accountability. Based on those changes, the EL Amendment application has become outdated and unnecessary. EL data has significantly improved, and schools can now appeal a letter grade based on data. Therefore, the EL Amendment Application will be retired. This does not impact the EL Reason application which is still a federal requirement for reporting why students were not assessed.



Pupil Withdrawal Analysis: Updated Pupil Withdrawal Form

The Pupil Withdrawal Monitoring has helped focus, refine, and provide resources in improving the coding and calculations of Graduation, Dropout and Persistency. A new Pupil Withdrawal Form is available and can be found [here](#). We recognize that schools may have forms still available in a paper version. Please feel free to exhaust those forms. If needed, the new code can just be written on the form. As a reminder, here are the new codes for FY22. More supports/resources on the use of codes will be found on the new form. In addition, based on feedback from the end-users, there are Withdrawal Code Update fields that can be utilized when applicable.

Pupil Withdrawal Analysis: Cohort Analysis Review

As stated previously, the Pupil Withdrawal Monitoring has helped focus, refine, and provide resources in improving the coding and calculations of Graduation, Dropout and Persistency. Arizona saw unprecedented mobility in the 2020-2021 school year. The two scenarios warrant further analysis of the integrity of the future graduation rates. We will be taking a deeper look into the coding surrounding the cohort assignment to ensure it is working as intended. As more tools have become available, such as the Student Teacher Course data, verifying a student's cohort is more visible and can be validated through more than just withdrawal codes.
