The **Pharmacy Support Services** program prepares students to prepare medications, provide medications and related assistance to patients, manage pharmacy clinical and business operations. The **Pharmacy Support Services** program includes instruction in medical and pharmaceutical terminology, principles of pharmacology and pharmaceutics, drug identification, pharmacy laboratory procedures, prescription interpretation, patient communication and education, safety procedures, recordkeeping, measurement and testing techniques, pharmacy business operations, prescription preparation, logistics and dispensing operations, and applicable standards and regulations.

The **Pharmacy Support Services** program is designed and delivered as a coherent sequence of school-based and work-based supervised learning. The **Pharmacy Support Services** students develop leadership, social, civic, and career skills through participation in the Career and Technical Student Organization HOSA (Future Health Professionals).

The **Pharmacy Support Services** instructional program prepares students for entry-level employment, further training, and/or post-secondary education for these and other occupations: Pharmacy Technician, Pharmacy Sales Assistant, Retail Pharmacy Technician, Mail Operations Pharmacy Technician
