
2019-2020 Title IV-A Spending Data

In January 2018, the first round of Title IV-A allocations was released to Arizona LEAs. That year, Arizona LEAs received just over \$8 million in funding. Within three years, we have seen Title IV-A funding more than triple.


In the 2019-2020 school year, Arizona received a total allocation award of just over \$24M dollars. Of the 667 total numbers of LEAs in Arizona, 485 were eligible to receive Title IV Part A funds. Of these eligible LEAs, 281 retained some or all their Title IV-A funds.

Through our programmatic monitoring conducted in the FY21 school year, there is overwhelming evidence that Title IV-A programs across the state are making a big difference for students and staff.

The numbers are in for the 2019-2020 school year, showing the total amount of funds spent was just over \$14M. The pie chart below indicates the amount of funds spent by category.

Even though many students were not physically in the classroom for much of the year, music and arts education programs continued in creative ways, virtual field trips helped students feel connected to the world around them, and STEM and STEAM Education program supported students' well-rounded education.

SAFE & HEALTHY STUDENTS



In the Safe & Healthy Students Category, LEAs funded social and emotional learning programs not only for students but also for staff. School leaders recognized the need to provide mental health services and counseling to students to help process the unique challenges brought on by the COVID-19

pandemic. Funds were also leveraged to provide teachers and staff social and emotional programs to help them support their students. Schools provided specific interventions as dropout prevention strategies and more opportunities for parent and family engagement. Learning may have been online for most of the year, but the climate and culture of these environments continued to be supported by Title IV-A.



EFFECTIVE USE OF TECHNOLOGY

The Effective Use of Technology category continued its upward trend as schools and teachers settled into blended and distance learning. With the approval of the CARES Act Waivers for both the 2019-2020 and 2020-2021 school years, schools were able to leverage Title IV-A funds to meet the

ongoing needs of students and teachers. Schools provided professional learning on a wide variety of technology tools and equipment to support student engagement and academic achievement. The Title IV-A Team was identified as a Technology Infrastructure Consultant for the field, answering questions and supporting district and charter leaders as they endeavored to provide technological solutions to all their students. Title IV-A funds supported things like device purchases, Wi-Fi access, and broadband infrastructure.

TRANSFERABILITY DATA

Under ESSA, LEAs may transfer funds they receive under certain programs to other programs to better address state and local needs. In the 2019-2020 school year, 62% of LEA funds retained their Title IV-A identity while 38% were transferred to other program areas. Additionally, a small portion of Title II-A funds were transferred into Title IV-A.



Under ESSA, Title IV-A & Title II-A funds may be transferred to the following programs:



LEA Allocations & Grant Applications

Title IV-A allocations are calculated by formula and based on the LEAs' prior year Title I, Part A allocation. State Education Agencies are further required to ensure no LEA receives an allocation less than \$10,000. LEA Title IV-A allocation amounts can be viewed on the Title IV-A website homepage under the Allocations Tab.





Arizona Arts Education Standards & 2021 SEL Updates

The Arizona Arts Education Standards were adopted in 2015 by stakeholders across Arizona. The standards were modeled after the National Arts Standards https://www.nationalartsstandards.org/. They are organized around the four core artistic processes of Creating, Performing/Presenting/Producing, Responding, and Connecting and focus on developing students' artistic literacy for 21st Century Success including active participation in the creative industries sector. This year the standards were updated to also include SEL competencies for greater opportunity for integration of social & emotional learning through the arts.

Arizona Arts Education Data

The Arizona Arts Education Data Project is a partnership between ADE Arts Education, Arizona Citizens for the Arts, and the Arizona Commission on the Arts. The project is part of the National Arts Education Data Project by Quadrant Research and analyzes student access and enrollment in arts education courses. Last year, project partners published updated analysis of arts course enrollment data for the 2018-2019 & 2019-2020 school years.

2019-2020 KEY FINDINGS

- 89% of students had access to at least one arts discipline; 76% of K-8 students had access to the state-required two disciplines.
- 67% of all students participated in arts education courses. This represents more than 767,000 students. The percent participation rate has declined from 71% in 2019.
- Students without access to arts instruction increased to 11.3% from 8.6% in 2019.
- Arts enrollment was highest among students in elementary schools (79%) and lowest at high schools (48%).
- Schools where a high proportion of students were eligible for free or reduced-price lunch (FRL) were more likely to lack arts education (25%) than schools with a lower proportion of FRL-eligible students. However, overall arts participation was also highest in schools with a high FRL-eligible population (72%).
- Music (47%) and Visual Art (43%) have the highest student participation. However, there has been a decline from 2014 for both (Music=52% and Visual Art=50%).
- Among students without access to the arts, nearly twice as many attended a charter school (18.1%) vs. a traditional school (9.9%).
- The arts participation rate was highest in schools where the majority of students are Hispanic (73%) and was lowest in majority-Native American schools (59%).
- Schools in mid-sized suburbs had the highest arts participation rate (81%); schools in distant rural locales had the lowest rate, 50%.

HISTORY


The 2020-2021 school year marked the second year of the Arizona State Seal of Arts Proficiency program. This diploma seal is awarded to graduates who complete minimum arts pathway requirements throughout their high school career. R7-2-321 was signed into law by Governor Doug Ducey on May 14th, 2019 and board rule for this law was adopted by the State Board of Education on October 28th, 2019.

HOW TO PARTICIPATE

LEAs who wish to administer the State Seal of Arts Proficiency must apply to ADE Arts Education by September 15th outlining procedures for program administration. Approved LEAs will submit a student achievement report by April 15th of each school year. LEAs will receive diploma seals by May 1st of each year to place on qualifying student diplomas.
