What we do now

Services provided at farms and migrant sites:

- Basic health checks (blood pressure checks, glucose checks and first aid) Aguila, Harquahala and various sites in Mesa
- Health education
- Dental kits (toothbrushes, toothpaste, floss)
- Provide eligibility assistance for Sliding Fee Scale, AHCCCS and Marketplace

Outcomes

- Increased the number of migrant and seasonal farmworkers:
- **2016** (990) **2017** (1334) **2018** (1499) **2019** -(1443)
- Patients became engaged in their own health
 - Built a relationship with Martori Farms and developed a workflow.
 Within this workflow the farm would call us directly to schedule a same day appointment for the patient. In doing so, it would avoid an emergency hospital visit.
- In Wickenburg, the hospital saw a drop in seasonal farmworker emergency patients as a result of our visits and health education at the farm.

Our Vision

- Develop an Advisory Committee/Board made up of organizations/individuals that work/support/service MSFW population
- A more comprehensive program that addresses needs beyond health care
- Developing a needs assessment to determine what those needs are
- Partnering with organizations that provide direct services to this population
- Partner with other organizations that provide a service, but not currently to the population
- Obtain grants/funding private/public to sustain and build the program
- Grow population served by 10% by connecting them to the health centers and bringing appropriate services directly to them
- Redesign Madrecitas event into a more informational and educational

What have we done to date?

 Requested data from the County from completed survey that included migrant and season farmworkers; income, community issues, health conditions, and barriers to access healthcare

 Applied for Grants to be able to purchase a Mobil Unit and visit the farm workers at their job to provide health care services.

- Arizona@Work Partnership
 - Migrant and Seasonal Farmworker Orientation
 - Adelante information sheet and other partners in packet
 - Opportunity to present directly to H2A workers
 - Identify needs they have outside of care
 - Provide update and information on pesticide exposure on workers to Adelante physicians

Next Steps continued

- Developing workflow diagrams of Adelante:
 - Pre-offsite health screening preparation (schedule staff, medical/office supplies, logistics, medical equipment)
 - Health screening off-site workflow
 - Eligibility process and needs
 - Entering encounters into EMR

The Adelante Sliding Fee Discount program allows patients to pay variable rates for services depending on household size and income.

Services available through the program include:

- Doctor's visit
- Women's health, prenatal/maternity care and family planning services
- Dental services

We also work with other organizations who offer liding fee discounts, including for labs and x-ray: The sliding fee schedule is based on Federal Poverty Level guidelines and are updated yearly to ensure that a non-discriminatory, uniform and reasonable charge is consistently and evenly applied.

All applicants for AHCCCS and the Sliding Fee Discount Program must provide documentation which may include verifying residence, income and family size.
