4 The most recent verification summary report was Discussed that verification summary not accurate. Specifically, the VSR did not accurately report the total number of approved applications. The VSR reported 172 total applications while the verification sample size was based on 215 total applications.

The verification sample size used was not correct Discussed correct calculation of sample based on the number of applications eligible for verification. Because the reviewer could not confirm the total number of approved applications, the reviewer was unable to determine if the correct verification sample size was chosen.
