1 Introduction

In accordance with Article 15 Empowerment Scholarship Accounts Rule 7-2-1503 Department Responsibilities, the Arizona Department of Education and the Empowerment Scholarship Account Program present this quarterly report to the Arizona State Board of Education. This report reflects data and information from quarter 4 of fiscal year 2021 and covers the time from April 1, 2021 to June 30, 2021. As stipulated in Rule 7-2-1503 item 5, this report includes the following:

- a) The number of students in the program disaggregated by eligibility, grade level and the school district or charter school associated with each student;
- b) The annual award amount associated with each student;
- c) The number of ESA applications received, approved, and denied in the preceding quarter, including the justification for the denied applications;
- d) The number of applications processed within 45 days of receipt and the number of administratively incomplete applications;
- e) A summary of any parent input or feedback collected pursuant to R7-2-1503(6) and how the Department is responding to concerns submitted as part of the process;
- f) Information on the private financial management firm contracted to assist with financial management of the program, including:
 - i. The number and eligibility type of accounts utilizing the firm,
 - ii. The number of providers and vendors on the firm's platform,
 - iii. Communications and training provided to parents,

2 Students in the Program

This section includes the number of students in the program disaggregated by eligibility, grade level, and the school district or charter school associated with each student.

As of June 30, 2021, there were 9,669 active students in the ESA program. By comparison, there were 9,718 students in the program during quarter 2 and 9,831 in quarter 3.

2.3 Students by Associated School District or Charter School

Under most circumstances, a student must have previously attended a public school in Arizona for at least 100 days of the prior school year to be eligible for an ESA. This section provides information regarding the associated schools active ESA students attended prior to joining to ESA program.

As of June 30, 2021, ESA students previously attended 380 of the 667 total number of school districts and charter districts (referred to as local education agencies or LEAs) in Arizona. The complete list of students by associated LEA can be found in Appendix A.

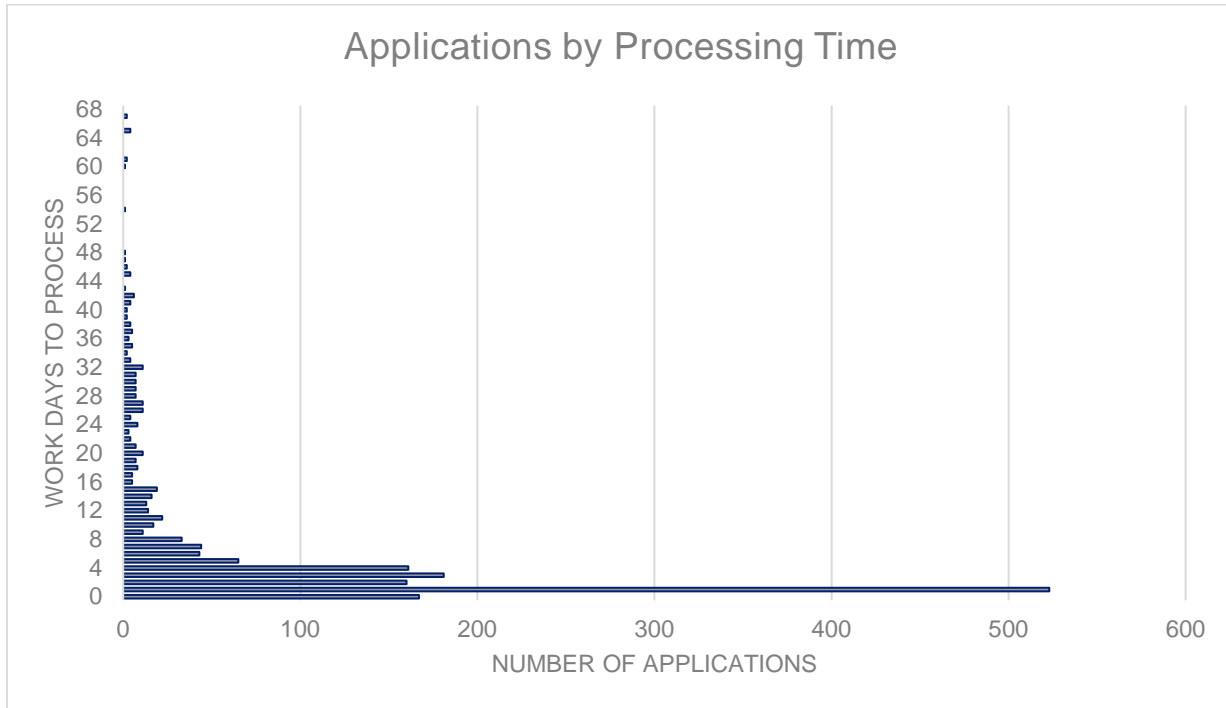

6 Parent Feedback and Response

This section includes a summary of the parent feedback that has been collected by the ESA program. It also includes a list of current and upcoming action steps to address the feedback shared by ESA families.

6.1 Parent Feedback

The ESA program solicits parent feedback through the following processes:

- ESA Parent Advisory Council
- Written comments
- Electronic surveys
- Ad-hoc meetings

Feedback is collected throughout the year, with both regularly scheduled dates for meetings and comment periods, as well as ad-hoc requests as determined by the Department. Feedback will be reviewed and summarized by the Department and considered before final decision making on the item for which input is being collected. The Department will report to the State Board of Education a summary of the feedback collected and the response or relevant action taken by the Department in its Quarterly Report pursuant to R7-2-1503 (5).

Parent Advisory Council

The Department convened one Parent Advisory Council (PAC) meeting during quarter 4, on May 27, 2021 and included agenda items such as implementation of prepaid debit cards and updates on program communications, marketing, and outreach. A summary of the feedback received is included below. May 27, 2021 Summary

The May meeting agenda included revisions to the 2021-2022 Handbook, information on the private financial management firm, training for new Account Holders, and an update on outreach and marketing.

The following comments were shared by council members regarding the ESA Town Hall meetings:

1. Having 2 time slots was helpful for the diverse schedules of ESA parents.
2. Post the slides and the video so parents who could not attend the 2-hour meeting can still be informed. The link could be available for ESA parents after they log in.
3. Accepting many questions was helpful and taking the time to listen to concerns was validating for parents.

The following comments were shared by council members regarding the ESA program communications:

1. Honor written or verbal communications.
2. Accept voicemails, especially when concerns have been escalated.
3. Respond to help desk requests promptly.
4. Provide accurate solutions based on the content of the questions submitted by parents.
5. Explain specific reasons for denial of expenses when the denial is communicated.

ESA PAC members also shared recommendations to develop resources on how to use ESA funds. Specifically, how to use funds for private school, online classes, college, tutors, therapists, paraprofessionals, curriculum, supplementary items, reading books, and associated goods.

Written Comments

During quarter 4, ESA stakeholders were provided an opportunity to submit written comments to the Parent Advisory Council in advance of the meetings. There were no written comments received for the May 27, 2021 meeting.

Electronic Surveys

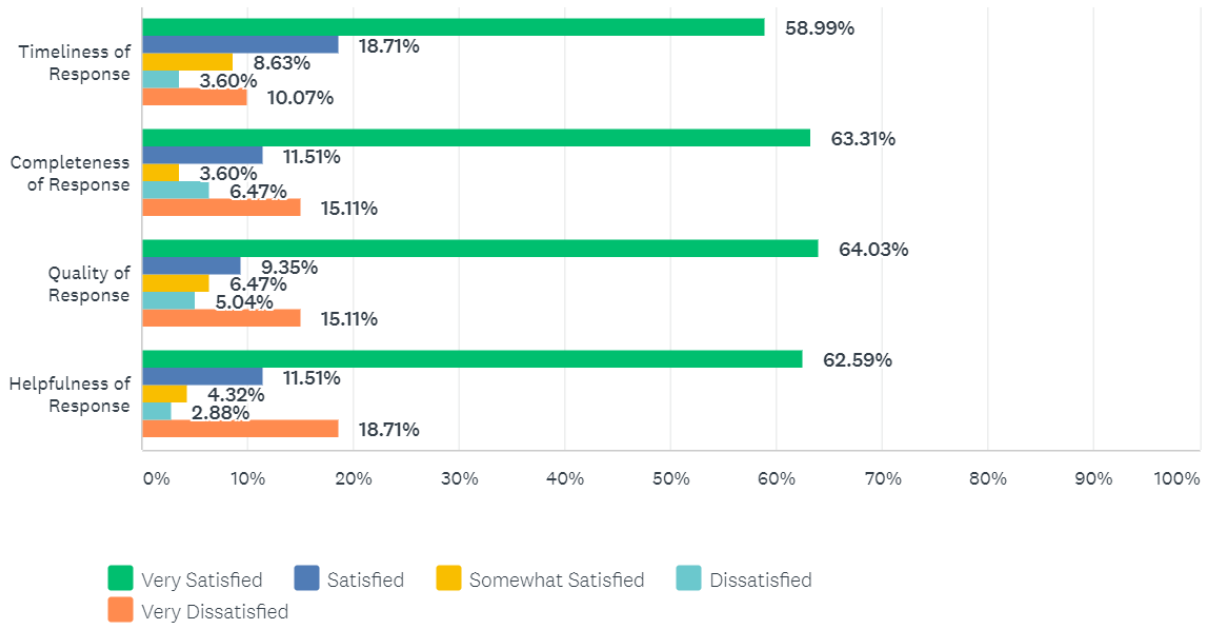
The Department continues to provide a survey link to all tickets received through the Department's HelpDesk for families to provide feedback on the timeliness, completeness, quality, and helpfulness of the response regarding their request. Families are also given an opportunity on the survey link to provide general feedback. During quarter 4, the Department received 140 responses to HelpDesk-linked surveys.

The Department also continues to allow families to provide general program feedback through a survey available on the ESA website. This survey focuses on the ESA program, banking systems, ease of navigating the ESA website/portal, customer experience with the private financial management platform, and overall ESA communication. This survey has garnered limited responses to date. A total of 10 responses were submitted during quarter 4 through this form.

Summary of Help Desk-linked survey responses:

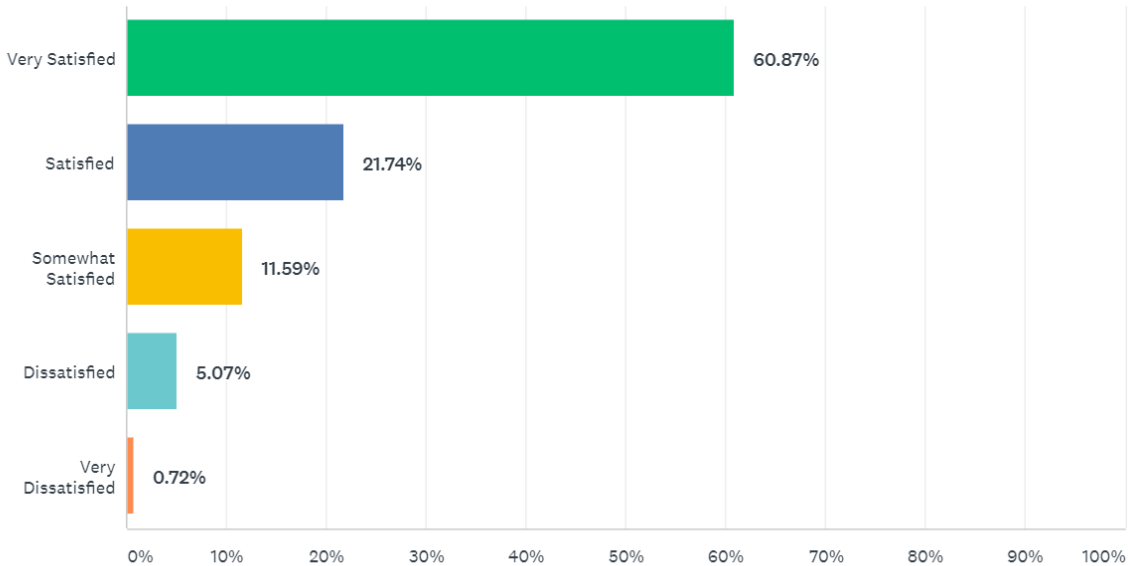
Based on your recent interaction with ESA staff, please indicate your level of satisfaction...

Ad-Hoc Meetings

Two virtual town hall meetings were convened in quarter 4, on April 19, 2021.

Session 1: 1pm-3pm attended by 64 stakeholders

Session 2: 4pm-6pm attended by 49 stakeholders

Format

- Informational updates by ADE staff with most of the agenda set aside to listen to parent/public feedback.
- Agenda allotted more time for more comments than needed, providing time for ADE staff to respond during the meeting.

Recommendations and requests made by participants:

- ESA Parent Advisory Council to create content for the monthly ESA newsletter that is distributed by ADE via email.
- Improved and expanded communication with parents – should not have to be part of a parent Facebook group to get information.

Additional concerns raised:

- Approval process delays purchasing and delivery of items and materials critical for education.
- Coupons and discount codes cannot be used in the CW platform resulting in higher costs.
- Notification of right to appeal is intimidating to parents and should be avoided when possible.
- ADE's application deadline for Q4 of school year 2020-2021 closed February 1. Approved applicants should be enrolled in the program within 45 days of application.

6.2 ADE Response to Feedback

Communications and Training

The Department continues to review and update its communications strategy for sharing information with prospective and existing Account Holders. During quarter 4, the Department established a new position to facilitate communications with the families and stakeholders. The Director of Communications and Engagement will develop and lead implementation of communications and engagement for the ESA program including staff professional development, marketing, community outreach activities, statewide seminars and trainings for applicants and account holders. The position has been filled and will begin at the end of July.

In addition, the Department made changes to the monthly newsletter based on parent feedback regarding formatting and content. The April newsletter is included in Appendix C.

Expense Approval Process

In response to parent feedback regarding consistency and timeliness of the expense approval process, the ESA program team is undergoing continuous improvement for processes and procedures and is conducting ongoing staff training.

The Department updated the Board during its May meeting regarding enhancements to the Database of Allowable Expenses. The Department is evaluating the current functionality of the database and exploring opportunities to improve searchability and integration with the financial management vendor.

Appeals

In response to parent feedback on the Department's facilitation of the appeals process, the Department is working with its Assistant Attorney General and the State Board of Education to streamline the appeals process and conform to recently adopted legislative changes.

Debit Cards

In response to parent feedback concerning the need for additional purchasing options outside the existing features of the financial management platform, the Department worked with representatives from the Arizona State Treasurer's Office and the private financial management firm to provide a debit card option beginning in quarter 1 of school year 2021-2022. Existing ClassWallet Account Holders were eligible to request a prepaid debit card in the ESA portal beginning May 15, 2021 and Bank of America Account Holders were able to make the request soon after. The first transaction was made on June 29, 2021. As of July 19, 2021:

- 2,137 new debit cards have been provisioned
- 232 cards activated
- 29 users made 51 transactions

The Department will continue to monitor parent feedback on the new debit card feature and work with the Treasurer's Office and the vendor to adjust when necessary and appropriate.

April 19 Town Hall Follow-up

7.2 Providers and Vendors

As of June 30, 2021, there were 1,681 vendors/providers in the ClassWallet application, and an additional 124 private schools registered for Direct Pay. By comparison, there were 1,339 vendors/providers registered in the platform during quarter 2 and 1,582 in quarter 3.

7.3 Communications & Trainings

The private financial management firm, ClassWallet, facilitates training for parents who use the platform to spend ESA monies. In addition, the Department has posted a short informational video on the ESA website that is specific to the Arizona ESA program at <https://www.azed.gov/esa>.

Training will be available throughout the year. Training sessions are offered in the am and pm to provide flexible options for participation. Previously recorded training videos, upcoming training dates and registration information will be made available on the ESA website under the ClassWallet Live Training drop down at <https://www.azed.gov/esa/classwallet>.

As referenced in section 6.2, the Department worked with representatives from the State Treasurer's Office and the private financial management firm throughout quarter 4 to provide a debit card option beginning in quarter 1 of school year 2021-2022. The process and timelines for this transition were communicated to the Parent Advisory Council, to the State Board of Education, at the ESA Town Hall, in the April newsletter, and in a reminder email sent on June 24 regarding what to expect during the transition period. The communication sent to families on June 24 is included in Appendix E.

7.4 Parent Concerns and Responses

There was no information submitted to the Department by the Treasurer's Office nor the vendor for this section for quarter 4. Relevant parent concerns submitted directly to the Department are addressed in section 6.1 of this report.

7.5 Other Requests

There were no additional requests identified by the Board for this report.

General

1. What is the link to ESA’s website?

Response: www.azed.gov/esa

1. Where do I go for ESA updates?

Response: The ESA team distributes monthly newsletters to all active Account Holders on the ESA program to the email address on file. The ESA website: www.azed.gov/esa also provides families with important upcoming dates, training materials, and resources.

2. Why is my quarterly funding delayed?

Response: Quarterly funding will be made available by the 30th of each funding month. Funding may be delayed for the following reasons:

- Signing a contract in the last two weeks of the funding month will result in delays for the funds, as it takes time to set up accounts and request the funds
- Failure to submit an expense report by the deadline (BofA card holders)
- Failure to make a purchase/payment in ClassWallet by the quarterly deadline
- Failure to attest to no expenses for the quarter (ONLY if no expense were made; ClassWallet and BofA)
- Outstanding disallowed payment not received
- Failure to fix and resubmit any rejected expenses

3. Can the Department provide trainings and materials in Spanish?

Response: The Parent Handbook for school year 2021-2022 will be translated into Spanish and published on the ESA website. The Department is exploring options for translation services on other key documents, trainings, and live meetings.

4. Is there a list of approved items/curriculums?

Response: Yes, a list of approved items & curriculums can be found on the ESA website: <https://www.azed.gov/esa/esa-allowable-items>

5. How do I update my child's disability category and annual award amount?

Response: A student's category of disability can be updated by submitting your district evaluation or IEP to: <https://helpdesk.azed.gov/app/itdesk/HomePage.do>

A student's annual award may be updated if there is a change in their category of disability. Awards are determined based on:

- a. District/charter school last attended (for incoming Kinder/Preschoolers this is your district of residency)
 - b. Grade level
 - c. Category of disability (if applicable)
6. How do I apply for additional funding due to additional need?
- Response:** Additional funding may be disbursed if there is a change to the student's category of disability during the contract year, based on documentation of an updated district evaluation or IEP.
7. Do I need to provide documentation for a purchase that is listed on the list of Allowable Items?
- Response:** Located on the [Allowable Items database](#), there is a column indicating the *Determination* status for each item. If the expense determination is listed as 'Approved', the item can be purchased without additional documentation. If the expense determination is listed as 'Approved with curriculum or course of study,' the Account Holder must submit a curriculum or course of study with the purchase approval request to demonstrate it meets the definition of a supplemental material.
8. Why can't I use ESA funds to purchase a computer for my student who is not identified as a student with a disability?

Response: The current ESA law prohibits use of ESA monies on computer hardware or other technological devices, except for qualifying students with disabilities.

9. What is the timeline to use STO scholarships (Displaced/Disabled) if I have also been approved for the ESA program?

Response: A student may accept a displaced/disabled pupil STO scholarship and use it for payment to their private school for the quarter(s) prior to accepting an ESA. Meaning that if you are awarded an ESA for example for quarter 3 (regardless of date monies are disbursed) you may use your student's STO scholarship for the quarter 2, but not for quarter 3 payment to your school, as ESA awards you a full quarterly amount.



ClassWallet

1. How can I view all of my transactions in the online platform?

Response: ESA is working diligently with ClassWallet to make comprehensive financial statements available to all Account Holders by May.

2. Where can I view my account balance in the online platform?

Response: Your student's account balance is available on the student's home page.

3. Can ClassWallet provided a receipt for purchases?

Response: The vendor or provider with whom the purchase is made is the responsible party for providing receipts or invoices for each payment or order(s). Account Holders receive a confirmation email from ClassWallet after a purchase is made through the platform.

4. What is the process for refunds in ClassWallet including timelines?

Response: There are two paths to obtaining an account credit. If an Account Holder brings a refund request to ClassWallet's attention, a representative can generally confirm and credit the account within 48 - 72 hours (if there are no complications.) If a credit memo is submitted directly by the vendor or provider with whom the purchase was originally made, it may take up to 30-45 days for the refund to be credited to the account.

5. Is there an ability to track purchases (orders) in ClassWallet?

Response: Currently, ClassWallet does not have the ability to provide tracking for orders. The vendor with which the purchase was made is responsible for providing order tracking information.

6. Can ClassWallet show the names of each child as parent toggle between accounts at the top?

Response: A parent can see each student's name as the toggle between accounts. The message on the blue top bar will say: *Hello Student Name* or *Welcome Student Name*.

10. How do I get reimbursed in ClassWallet?

Response: To have a payment or purchase reimbursed, you must:

1. Link the bank account that you wish to have reimbursed. This can be done by clicking on the *Link Account* icon located on the student's home page (you will only need to link your account once for each of your children).



2. ClassWallet will send two micro-deposits for verification, that will need your attention in order to complete the process.
3. Once your bank account is linked, you may request reimbursement for review through the ClassWallet platform.



ClassWallet Prepaid Debit Cards

1. How do I request a debit card for SY 2021-2022?

Response: A parent will have the ability to request a debit card by logging into their child's ESA portal. A pop-up message will appear asking if you wish to opt into a debit card. Please keep in mind that you do not need to opt in immediately, you may request a debit card at any time.

2. Will there be training provided for the new debit cards?

Response: Yes, ClassWallet will include the use of debit cards in their trainings beginning this summer.

3. Can I use the debit card to pay for individual courses at vendors such as Out School?

Response: Per ClassWallet, vendors such as Out School, who are not currently in the platform, may be paid with the debit card.

4. Can I use the debit card to pay private tutors?

Response: Yes, you may use your debit card to pay private tutors not listed on the financial management vendor's platform.

11. Do I have to submit a quarterly expense report for ClassWallet debit card transactions?

Response: There are no quarterly expense reports required with ClassWallet, however, you will need to submit invoices for each student using the ClassWallet mobile app or your computer.

12. How will I receive the ClassWallet debit card?

Response: The debit card will be mailed to the mailing address on file with ESA, if you need to update your address or verify that the correct address is on file, you may do so by accessing your student's account on the ESA portal. You can also update your address if needed.

13. Whose name will be on the debit card?

Response: The Account Holder's name and the name of the student will be embossed on the card.

14. Can I pay tuition with the debit card?

Response: Tuition at a K-12 private school (brick and mortar) needs to be made through the Direct Pay feature in the platform. Payments to online learning programs as well as tuition payments to universities and colleges can be made with the debit card.

15. Can the debit card be used for all vendors (approved purchases) regardless of whether the vendor/provider is in ClassWallet?



Response: The debit card is intended for vendors and providers not listed in the platform and will have merchant classification code (MCC) restrictions, including payments for private school tuition.

16. Do I have to ask ClassWallet for permission to use the debit card to pay for vendors outside of ClassWallet?

Response: No, you will not need to request permission to use your debit card to make purchases at vendors and providers not listed in the platform.

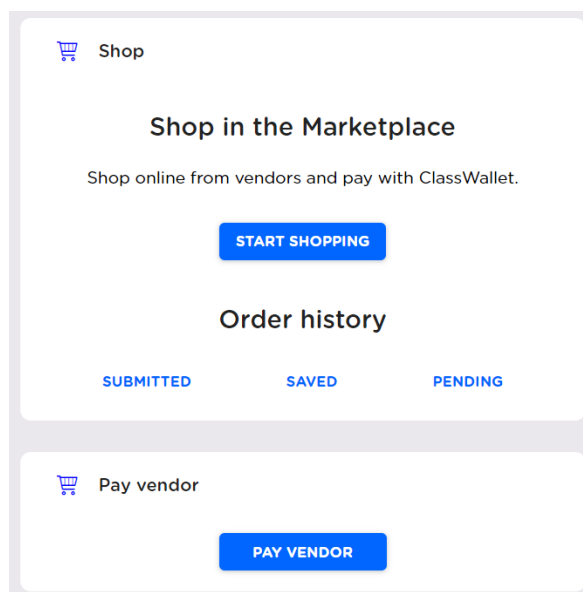
Here is what to expect:

- Your bank card will close on July 1, 2021 (make any required payments or purchase no later than June 30, 2021).
- It will take 7-10 business days to fully complete the migration into ClassWallet; this includes establishing the account(s) and funding any leftover monies from your Bank of America account(s).
- Starting July 1, 2021, you will not have access to your student's ESA monies until the migration is complete and your account(s) are fully set up and funded in ClassWallet.
- Any remaining funds on your bank card will be transferred into your new ClassWallet account and Quarter 1 (2021-2022) will be disbursed into your new ClassWallet account(s).

*If you have more than one child receiving ESA funds within ClassWallet, you only need to link and verify the bank information in ONE account. Twenty-four (24) business hours after verifying the micro/penny deposits, you will be able to see the bank linked in the other ClassWallet account(s).

4 – ClassWallet debit card

ClassWallet now offers a new feature; the ClassWallet debit card is available to all ESA families. Please keep in mind that to receive a debit card, you must opt-in. You may do so, by accessing your student's account on the ESA portal and selecting **YES**:



A few things to keep in mind:

- Debit cards will arrive within 7-10 business days, after your ClassWallet account is established.
- The card will arrive in a white envelope from either Fincentive or ClassWallet.
- The card is branded ClassWallet and is blue and green and will have your child's name and your name on the front.
- Once you receive the card, please follow the instructions to activate it. It is best to activate it through the ClassWallet application.
- The ClassWallet card cannot be used to pay tuition at a private school.
