Small School Transportation Adjustment Application Process

Eligibility

<u>A.R.S. 15-963</u>

A district can apply for a capital transportation adjustment for the **PURCHASE** of a **STUDENT TRANSPORTATION VEHICLE** if it meets the following:

- ➢ Has a student count of fewer than 600 in grades K-12.
 - Type 03 (Elementary not in a High School) Districts exclude grades 9-12
 - Definition of Student Count is prior year ADM
- Transports as eligible students at least 1/3rd of the total student count of the school district.
 - Based on Transportation Support Level data
 - o Prior Year
- Has an approved daily route mileage per eligible student transported of more than 1.0, computed as prescribed in <u>A.R.S. 15-945</u>, subsection A, paragraph 4.
 - Based on Transportation Support Level data

Calculation Cap

A.R.S. 15-963

Total of all Small School Transportation adjustments for school districts in a county for a fiscal year can not exceed 20% of the total amount distributed to a county for that fiscal year in Small School Service Program Funds as provided in <u>A.R.S. 15-365</u>, subsection F.

Example:

Apache County Small School Service Program Funds: \$60,920.42

Apache Small School Transportation Adjustment Limit: \$12,184.08

The total distributed to all eligible districts who submitted applications in Apache county cannot exceed 20% of \$60,920.42, or \$12,184.08





Calculation Scenarios

- Multiple Applying Districts:
 - Eligibility determined for multiple districts in one county and email sent
 - Multiple districts apply
 - Eligible Students Transported and Daily Route Miles totaled for applying districts in that county and each district's % determined
 - That % is multiplied by available award to determine each adjustment amount for each applying district
- > 1 Applying District:
 - Will get the lesser of Amount Requested or Available Amount
- Request Less Than Available to Award:
 - The only time the Amount Requested is considered in relation to the amount awarded is if you request less than what is available to give to your district
 - Rarely see this; usually only if only one eligible district applies in a county

In accordance with A.R.S. 15-963 school districts may apply to the state board of education for a capital transportation adjustment for the purchase of a student transportation vehicle if the district meets all the following requirements:

1. Has a student count of fewer than six hundred in kindergarten programs and grades one through twelve.

2. Transports as eligible students at least one-third of the total student count of the school district.

3. Has an approved daily route mileage per eligible student transported of more than 1.0, computed as prescribed in section 15-945, subsection A, paragraph 4.
