Menu Planning

1 A waiver was not submitted to ADE for meals with meal pattern deficiencies by component, per meal service when the meal pattern was not followed. Specifically, the minimum 3/4 cup of vegetables was not served at lunch on one day during the review period, April 8, 2021.

Discussed that ADE is permitted to provide meal reimbursements when the meal pattern is unable the minimum 3/4 cup of vegetables was not to be met by the SFA providing the meals due to shortages and/or supply chain issues. SFAs must maintain daily records of meals with meal pattern written assurance that if the meal pattern deficiencies by component, per meal service.
