**Menu Planning** 

1 A waiver was not submitted to ADE for meals with meal pattern deficiencies by component, per meal service when the meal pattern was not followed. Specifically, quantities during the review period did not meet minimum amounts required by the meal pattern; the weekly 1/2 cup starchy vegetable subgroup was not met.

Discussed that ADE is permitted to by the SFA providing the meals due to shortages and/or supply chain issues. SFAs must maintain daily records of meals with meal pattern deficiencies by component, per meal service. To support the claim for reimbursement of meals, the SFA is required to provide a meal pattern waiver request form to ADE.
