ESSER Funds Updates

> ESSER LEA Data Reporting

- ✓ The **US Department of Education** has just **released new guidance** to states that serves to update previously released requirements for ESSER (I, II and III) grant data reporting by states and LEAs
- ✓ This update includes changes to current data elements, the removal of some elements and sections, and the inclusion of new items. Upon review, these changes include, for example, the removal of the requirements for LEAs to report obligations of funds, and data regarding allocations to high poverty schools for Maintenance of Equity (MOEquity)
- ✓ ADE is pausing the ESSER Data Reporting process through the GME ESSER Reporting Supplement, and is suspending the previously announced deadline for submitting these data of December 17th
- ✓ ADE will provide an update regarding next steps in the coming weeks as these new requirements are reviewed internally and with organizations such as CCSSO, and as additional information is released by USED

- ✓ New Deadline for LEA Submission of ESSER III grant: February 1, 2022

- ✓ Reminder: Local LEA ESSER III Plan Requirements
 - Stakeholder Engagement: Please visit the ESSER website for a <u>ESSER III and Community Input</u> Partner Toolkit
 - Once completed, the plan must be publicly posted on the LEA's website
- ✓ Safe Return to In-Person Instruction Plan: November 24, 2021
 - All LEAs receiving ESSER III funds must submit a Safe Return to In-Person Instruction and Continuity of Services plan to ADE by November 24, 2021

ESSER Funds Update

> ESSER III Application for State Funds

- ✓ ADE is glad to announce the application ESSER III State Funds. With the approval of ADE's ESSER III state plan, our agency was awarded the final installment of ESSER III funding, including SEA discretionary dollars that will be allocated to subrecipients to fund initiatives that support student success and recovery from the COVID-19 pandemic
- ✓ The application is open to a wide variety of partners, including community organizations and other entities that support students and families
- ✓ These funds are intended to support programs aimed at accelerating and enriching learning and increasing learning opportunities particularly for our most vulnerable student populations. USED has developed three lanes that the types of programs applicants put forth should address:
 - 1. Learning Loss or disrupted learning
 - 2. Summer enrichment
 - 3. Comprehensive after school programs
- ✓ Within each of these lanes, ADE has identified three priority focus areas applicants should aim to address:
 - 1. Enrichment & reinforcements for learning
 - 2. Mental, behavioral, and physical health support for students and educators
 - 3. Student and family re-engagement and support for critical transition periods
- ✓ Applications must be submitted by December 10th
