### **Aggregate Expenditures Reports**

- ARS <u>15-911</u> requires an annual report by 11/1 on aggregate expenditures of local revenue as defined in the <u>Arizona Constitution</u>.
- \$1.15 billion over the limit in FY 2022
  - Based on original budgets and budget revisions submitted on or before 10/29
  - BUDG-AGD report extracts values from submitted budget files
  - Revenue from the 0.6% sales tax (Prop 301 extension) has been included in the calculation, no other changes
- BUDG-AGD reports are on the School Finance website and show the calculation for each district



- Allocations have been published and the first payment was distributed on 11/5
- Funding awards based on FY 2019 assessment results and poverty measures
  - Updated student counts
- Based on percentage of students passing FY 2019 assessments



- \$400 per student count
  - Top 13% of 60%+ FRL schools
    - At least 42.50% average passing
- \$225 per student count
  - Top 27% of 60%+ FRL schools
    - 36.00% to 42.50% average passing
  - Top 13% of all schools
    - At least 65.14% average passing



- Average passing:
  - Average of the percentage of all students passing all assessments English Language Arts and Mathematics
  - FY 2019 assessment data is on Accountability & Research Data <u>webpage</u>
- Poverty cohort based on the greater of:
  - % eligible for free or reduced-price lunch
  - % income eligibility 1 or 2 on 10/1/18
    - SUPP72 report in AzEDS
    - Students generating fundable ADM
- Student Count
  - Prior for districts, current for charters

- Submission reports are published on the school finance website
- Revisions will be possible February 1 through March 1
  - Districts that did not submit in October may submit at this time
