<p>1 Quantities observed during the review period did not meet minimum weekly grain amounts required by the meal pattern. Specifically the daily Chef Salad only credits to 1 oz/eq. of grains resulting in the weekly totals falling beneath the 8 oz/eq minimum. This was NOT determined to be a repeat finding from the previous review cycle and did not contribute toward fiscal action calculations or termination of performance-based reimbursement (extra 7 cents).</p>	<p>Discussed how current system allowed for this to happen and potential changes that could be made to ensure it doesn't continue (e.g., changes in serving utensils, recipes, etc.). Discussed with cafeteria staff how to properly identify and count reimbursable meals, as well as procedures if a student does not select a reimbursable meal.
