## Authority and Regulations

Congress has not granted USDA-FNS authority to extend waivers that have been in place during the Public Health Emergency

- Code of Federal Regulations
- United States Department of Agriculture FNS
- ADE Health and Nutrition Services



### 100 Waivers

USDA approved Arizona to action over 100 waivers across Child Nutrition Programs; 13 remain active until June 30, 2022.






### Remaining Flexibilities

ending June 30, 2022

- Meals offered to all students at no-cost without collecting meal applications
- Parents/guardians pick-up meals and creative ways for distribution of meals
- Summer meal service sites open regardless of socioeconomics/income status
- Higher rate of meal reimbursement
- Reimbursement for meals that did not meet the meal pattern due to supply chain disruptions or learning models



#### **Actuality of Summer Participation**

Expect summer meals to trend downwards to pre-pandemic July participation





# USDA's imact on school meals now and beyond

- Emphasis on nutrition benefits from food and the linkage to well-being
- Nutrition education
- Nutrition standards for school meals
  - Transitional standards for grains, milk, sodium
  - Proposed Rule expected by SY23-24
  - Aligning to the Dietary Guidelines for Americans



#### **"Build Back Better"** USDA Inititaves to strengthen the food system

Local Food for Schools Cooperative Agreement \$4.3M available to AZ

\$8.7M Local Food Purchase Assistance Cooperative Agreement Program Additional \$6.5M NSLP Entitlement Assistance funds SY22-23

\$21.9M Supply Chain Assistance Funding via Commodity Credit Corp
