# **Coordinated Early Intervening Services**

Coordinated Early Intervening Services (CEIS) are services provided to students in kindergarten through grade 12 (with a particular emphasis on students in kindergarten through grade three) who are not currently identified as needing special education or related services but who need additional academic and behavioral supports to succeed in a general education environment. The IDEA (20 U.S.C. §1413(f)(2)) and its regulations (34 CFR §300.226(b)) identify the activities that may be included as CEIS: (1) professional development for teachers and other school staff to enable such personnel to deliver scientifically based academic and behavioral interventions, including scientifically based literacy instruction, and, where appropriate, instruction on the use of adaptive and instructional software; and (2) providing educational and behavioral evaluations, services, and supports, including scientifically based literacy instruction.

#### **Program Reporting**

It is expected that each student participating in CEIS have the one or more of the corresponding programs reported to AzEDS under Support Programs.

- Coordinated Early Intervening Services- Behavior
- Coordinated Early Intervening Services- Math
- Coordinated Early Intervening Services- Other
- Coordinated Early Intervening Services- Reading

## Integrity Rules

Only certain support program type integrity rules apply to CEIS programs. These rules are outlined in the <a href="SPED Integrity Rules Reference">SPED Integrity Rules Reference</a> document. The relevant integrity rules that will run on CEIS supported programs are:

Code	Description	Error Message
50019	If the support Program Entry Date does not fall within the active Membership/Track interval, report the discrepancy as an error.	No active membership was found for the Program Entry Date submitted.
50027	If the First or Last day of Support Program participation is not a valid session date in the calendar for the track identified in the membership during the fiscal year indicated by this end date, then report the discrepancy as an error. In case of AOI or membership type = D the date can be any date between 7/1 - 6/30 of the fiscal year.	Support Program Start or End Date falls outside the calendar.

### **AzEDS Portal Reports**

#### INTEG15

Students failing support program integrity rules can be reviewed in the INTEG15 Student Data Integrity Report AzEDS Portal report.

Selecting Support Programs under Integrity Category will display only students failing support program rules. For CEIS programs, only the rules listed above would apply.

### SUPP10

Submitted CEIS program data can be validated using the SUPP10 Support Program Data Verification Report in the AzEDS Portal under the Report heading Support Programs.

This report provides a single page for each school site and program reported within that site.

The SUPP10 report contains the District Student ID (if reported), State Student ID, Last Name, First Name, Middle Name, Gender, Service Entry Date, and Service Exit Date.
