The definition of "curriculum" can and will become problematic as written. Many families, mine included, have children who learn differently and require curriculum that is modified and adjusted to fit their needs. As we do this, there are supplemental items that are not explicitly listed but necessary for our children to access the curriculum and learn the objectives we are teaching. Public school teachers, specifically special education teachers, modify curriculum on a daily basis in order to fit the needs of their students. As parents in this program, we should be given some grace to do the same.

I worry that the disallowed list casts a dark shadow over the allowable purchases. There should be more items considered as "educational materials" that do not require curriculum to be submitted.

I would really love some input from teachers, educational therapists, support staff, that have knowledge and experience that can help justify the differences of educational items vs supplemental. Where, and when to force curriculum to be submitted needs some adjustments as well.

As an educator who was in Arizona public and charter school classrooms there are very few curriculums that specify the brand, type, or gives explicit specifications for supplemental or associated goods. Think about it, a big publisher let's say like Pearson creating a curriculum that states an Ipad 9 or, a macbook Pro, or a Lenovo ThinkPad are required to use the curriculum. That would be a death sentence for that curriculum publisher. They want to be accessible for ALL students and districts, and I know right here in our state there are districts that would in no way shape or form be able to afford those specifics. ESA staff requiring specific associated goods and supplemental materials be listed is downright discriminatory. If my works best on an Ipad as an exceptional learner and it is not listed in curriculum, and is denied based on that stipulation, you have blatantly discriminated against civil rights. ESA should not be requiring specific named items be in the curriculum.

When teaching, there are times when an idea that I know will help my learn a concept based on what we are learning. With everything that has been going on with ESA including rescinding pre-approvals, I am looking at this handbook in fear mode; as I am sure many parents are because we have been super stressed out for weeks dealing with you guys and the constant changes that haven't been communicated to us in any formal matter.

What are your top concerns about the handbook?

1. The definition of supplemental materials on page 8 and page 16 of the handbook draft does not include or enforce the updated SBE rule below that was put into place to assist our children in attaining the Supplemental Materials they need to succeed based on their individual learning styles and needs:

On October 26, 2020, the Arizona State Board of Education adopted rules for the ESA program to meet the requirements of Laws 2020, Chapter 12. The portions of rule that will be effective starting 11/1/2020 are R7-2-1501 and R7-2-1505. Pursuant to A.A.C. R7-2-1501 (14):

14. "Supplemental materials" referenced in A.R.S. § 15-2401(2), means relevant materials directly related to the course of study for which they are being used that introduce content and instructional strategies or that enhance, complement, enrich, extend or support the curriculum.

The way it is written in the handbook undermines the rule and takes out the necessary verbiage that was put in place to ensure our kiddos could have items approved that would support, enrich and enhance a curriculum.

My needs to have hands on learning experiences. I learns best when given the ability to visualize and work with information in many different ways. For instance a curriculum unit on Dinosaurs works best for when presented with models of different dinosaur species that can hold and play with while we discuss the attributes of each one. We would also pair a unit like this with documentary videos and an art project that correlates with the topic. may even use a Lego manipulative to build a dinosaur habitat which is hands on STEM learning.

Allowing to be creative while learning and adapting the lesson to needs with the use of supplemental materials helps to retain the information. does not learn like the students with a workbook and a textbook because has an 'the student's the need for supplemental materials that may not be documented within a curriculum that was written specifically for students and not for Students. It is very hard to find curricula covering all subjects that has been written specifically for students on and another visually and another may need every available option presented until an option works.

It is currently a fight to get any supplemental materials approved under this chopped up definition of supplemental that the ADE Staff are trying to push.

The supplemental items we need to get our to focus on work are not listed by brand name within a curriculum. When a parent explains thoroughly how a supplemental item is going to be used in an educational setting that benefits their childs learning style that should be sufficient and it falls in accordance with the SBE rule that states a supplementary item can be used to enhance, complement, enrich, extend or support the curriculum.

This also pertains to subsection 8

2. Page 8 subsection 5: cases where reimbursement is the only option.

In regards to reimbursement being the only option to purchase approved items: This is a discriminatory practice against low income families who cannot afford to pay out of pocket and therefore their children do not have access to the same level of education as do children of parents with higher incomes who are capable of paying out of pocket. This needs to be looked at by the department and a remedy needs to be put in place such as the concierge option that used to be available through Classwallet. The option was available and needs to be reinstated or MCC code restrictions need to be lifted.

Parents are knowledgeable on what they are allowed to purchase (when ADE is consistent, which they have not been). We will however seek pre-approval when in doubt. We just aren't sure now if pre-approvals are valid.

Pre-approvals should help with ensuring that there is no fraud as long as those pre-approvals are upheld and honored by the department.

Unfortunately, as it stands now, parents have no faith in the pre-approval process anymore as the department has attacked those who went through the required avenues to get pre-approvals and then rescinded those approvals after the fact. We don't feel safe making any purchases right now. This is affecting our children's educations and our mental health as parents and teachers. This makes for a toxic relationship between parents and ADE Staff. The stress we are all feeling has to be affecting our children. I hope you all are aware that your inconsistencies and constant modifications of rule interpretations are affecting all ESA families including the kids that ESA is meant to support.

3. Page 16: states that the allowable item database is updated regularly which is not true. There are many links that are out of date and do not work. Also, many items that we have had approved since it has been instated are not included on the list.

4. Page 16: we have had board games and Legos (manipulatives) denied in the past or we have been instructed to provide additional highlighted Curriculum.

5. Page 17 states that supplemental materials must be recommended or required. This goes against the updated rule below. Curriculums and lesson plans do not specifically list any and all supplemental items that could be used to help out individual learners to achieve educational success. It is the parent/educator who knows best which supplemental items will help their children to grasp a concept. Many of our IEP kiddos learn best through STEM/Art/Music/Hands On projects that pertain to the specific subject being taught. So if we are covering a society or culture as part of a curriculum being able to show the student various parts of that culture through various lessons that include cooking regional foods, creating regional or historical art, and listening to or composing music from that region should all qualify as supplemental. These individual items may not be written or specified in a curriculum or lesson plan. As the educator we should be able to explain the need for any supplemental items as they relate to the topic/curriculum/lesson we are teaching.

To think that everything our unique learners may need to thrive and grasp a concept or topic is going to be clearly listed in any curriculum or lesson plan is absurd. I am teaching a child with **second** and **second** needs lessons that allow for materials to be provided in as many formats as possible to ensure the information is absorbed and understood. That is the point of ESA to be able to educate our children based on their individual needs. That is why the following rule was instated in the first place to ensure we didn't have to go through this process all over again. It was meant to ensure common sense was applied when approving supplemental items that pertain to a curriculum.

This is ridiculous. We are not teaching them by candle light. I mean calculators are electronics and they are on the approved list. This needs to be updated to reflect that.

Gym Equipment - Gym equipment is required to teach our children physical education which is taught in public schools. We need to have access to the same tools in order to ensure our children learn how to lead healthy lifestyles now and in the future. There are many P.E. Curriculums that require the use of gym equipment. This should be redacted from the list as these items should be approved for all kids.

Kitchen Supplies - Home Economics has been taught in public schools since they were established. Our children should have access to hands on learning opportunities which include life skills and utilizing kitchen supplies to learn how to cook/bake for self sustainability. This is a basic life necessity and kids should be allowed to learn how to take care of themselves. Cooking/Baking also teaches educational fundamentals such as math and literacy. There are many curriculums available that teach various forms of cooking and baking and require the use of kitchen supplies. Kids in public schools have access to cooking supplies and classes. Our children should have that same access.

Magazines - even those that would be considered non-educational are in fact reading materials and magazines that focus on specific topics are very important resources especially for special needs kiddos whose attentions are many times focused on very specific topics.

Play Equipment - how is this defined? Without defining this you are leaving it open to interpretation by both parents and staff. Please articulate the meaning.

Warranties & Protection Plans - why would these not be covered. We have destructive children and you do not want us having to repurchase items.

7. "The Department is authorized to audit all expenditures and may request further information if needed from the Account Holder at any time. 21"

Also in regards to page 48:

Are pre-approvals valid? Can we trust what you say? Many parents can not afford to pay back these expenditures which is why we seek pre-approvals in the first place to ensure that we have our bases covered.

That it provides a variety of information. The Educational Materials list has been expanded to include some much needed items!

What are your top concerns about the handbook?

1) This is by far my biggest problem with this current draft: that supplemental items have to be required or recommended by the curriculum. The problem with this, is most curriculums DON'T have everything one might use specifically written in it on purpose. They do this so the curriculum REQUIRES very little so it can be more accessible to more people. But it doesn't mean there are not a variety of things you can get that would enhance and improve a child's study of that curriculum. This language takes away from that opportunity for students to have a much deeper learning experience. Curriculum is written generalized for anyone who might want to use it- it is not personalized for a student. That is what parents can do with supplemental items: use them to personalize their child's education and enhance it in the way most beneficial way for their child. Supplemental items SHOULD include anything that deepens and increases a child's learning experience with that curriculum.

2) A better streamlining of what is needed for extracurricular activities, meaning credentials. Some are listed, but other sports are not, such as hockey, and parents don't know what to try and provide. If a student is registered in a nationally recognized league, or even a local league, it should be approved.

3) Legos should NOT be considered a supplemental item, but instead be categorized as educational materials. Plainly said, there is no difference between math base 10 blocks and legos, except one hooks together. Legos are a math and science manipulative and should be categorized as such. There is a tremendous amount of research proving how using Legos increases mathematical skills. It is also a perfect way to bring math and science (ie engineering) into other subjects, such as history. While studying a history curriculum, as a way to enhance and deepen a student's involvement in it, a parent can provide a historically accurate Lego set for the child to do some hands on learning with. SO MANY children benefit from this.

4) The wording that supplemental materials have to be required or recommended by the curriculum, approved by the department. This wording is extremely subjective, and essentially leaves everything to the whim of the person approving that day. Also, as said above, most curriculum purposefully DO NOT list specific items in their curriculum, to open it up to more people to use. Often, it is assumed by the curriculum what is needed: example a kids cook book may not list a spatula as a required item, but uses a spatula for cooking. It's implied that you would need one while not explicitly stated. Other examples include learning to crochet books. They often do not have a specific list of required items, but through looking through the lessons, you see what you will need. Having that language of "required or recommended" is too specific and will essentially eliminate most items that would be highly valuable for a deeper learning experience.

5) Only children with disabilities need vocational training? I think all children need vocational training.

6) The disallowed list contains "Electronics." I almost thought this was a joke at first. We live in the age of technology, where everything is run by 1's and 0's, and we are preventing our students from having access to computers and technology? That doesn't make sense at all, and prevents our students from being prepared to enter a world wide competitive working environment. Things like LeapFrog products are absolutely educationally enhancing, but because they have batteries they are not allowed? I can't even believe this is a real thing in the age we live...

7) I am really happy that gym memberships for the student are allowed. But I can not for the life of me understand why Museum and Zoo memberships for the student would not be allowed? They are inherently educational. And again, most curriculums will not REQUIRE a student to go to the zoo or museum, because some may not have access to one, and would therefore not be able to complete the curriculum. But it's inherently valuable to take a student to these places often and they should be allowed without a curriculum. Learning happens in many different forms. Most children in this program probably learn differently than public school children. We should understand that their learning experience is going to look different, and that is great because it's how they learn.
8) Play grounds and play equipment should be allowed. I can't even begin to cite all the research on how IMPERATIVE play is for children, especially children with special needs. Public schools have playgrounds and play equipment because they know children need it to enhance their learning. We should be given equal treatment in that regard.

It's a guide to help new families and provide consistency for the new ade staff as well. It helps organize different ways and options to use ESA funds for education of children with diverse abilities and learning needs.

What are your top concerns about the handbook?

Too many things are being disallowed even though they are not disallowed in statute. The SBE rule was to provide consistency and allow learning with diverse hands on just as should be. Items do NOT have to be explicitly required by a curriculum (ade staff has recently began denying all items not specified in the curriculum exactly to that make / model number and that should not be the case). The items according to the SBE rule the supplemental items can be required, or items that enhance / support the curriculum which means they extend the learning of the lessons so would not be explicitly required. SBE staff spoke at length about this and now the new Ade Staff is changing it again to be only required or they deny everything. In addition, class wallet transition plan was "sold" / marketed to families with the idea that the ade staff personally approves each purchase so no more worry about ade changing their mind to make you pay back items, and that exact scenario they said would be prevented is still happening. Even items that follow the handbook, the ADE staff is approving class wallet orders, then later going back to demand repayment, which SBE and ADE assured parents last year during meetings, that would stop. The handbook should not be used as a weapon more restrictive to education options than the statute! When ade staff approves a purchase via classwallet process or via helpdesk they have approved it! They should not be going back and demanding repayment on their items they approved and changing their mind. The handbook and SBE rules were supposed to provide consistency and that is not happening.

Also, there is a section where there are items allowed that don't require curriculum and the ade staff still is denying them saying send in curriculum, such as a globe or math manipulatives. Ade staff needs to learn the handbook. It wastes time for everyone most importantly the kids who need the educational items.

When does this handbook go into effect? I am assuming, by the dates listed, that it's the 2022-2023 school year (beginning July 1), but, I just want to be certain that is clear, since the draft date is March 28, 2022.

As an overall note, ESA parents need to understand the hierarchy of ADE/SBE/ESA, and also where to easily find the statute/rules/guidance available to them, for the program. We all want to understand the rules, so we can provide a quality education for our ESA students. This information is NOT always readily available to us.

Also, pertinent dates should be able to be quickly found. The table of funding dates and quarter dates has disappeared. If this has been adjusted, that is fine, but parents need to know this, so that we can plan/schedule our children's education accordingly. The last 2 quarters have been funded early (which is marvelous), but the uncertainty of either not having funding dates, or the ambiguity of the 15-30th of the first month of the quarter is frustrating to so many. Timelines should be clearly defined, as well. Everything from help desk tickets, to direct pay vendor requests, and marketplace orders. Parents should have access to know what an appropriate response timeframe will look like.

Preschool is learning through play, as is MOST learning done via Montessori, Charlotte Mason, and many other homeschool curricula, and is very developmentally appropriate for SPED kids. The state of Arizona does not REQUIRE that formal education begins before age 6, yet the current ESA policies do not support that, or even align to the developmental age of many of our SPED kids. Can the handbook be flexible enough to address this? This concern also ties into the current definitions of curricula, manipulatives, etc.

Can we add a simple reference page at the end with helpful links? Links like the parent guide, SBE rules, help desk and contacts, etc.?

Translated versions should be available. There is definitely a need for all ESA materials to be translated into Spanish, and other languages of students under the purview of ADE. A parent cannot be accepted to agree to and abide by something they cannot understand.

Table of Contents listed twice, as well as "Contents". This is redundant, and can be sufficiently one use of "Table of Contents."

Introduction (Pg 1)

What is the Parent Guide, and how can parents find it? A link may be appropriate here.

Page 2

All references to Kindergarten (full, half-day and tuition payments) have been removed from the handbook. Is this something parents need clarification on? It would also be very useful to note that preschool and kindergarten only receive half of the funding amount, because AZ doesn't fund them as full-day programs.

Page 3

Spelling/spacing issue (Holdersof any change(s)) Where will changes and their dates be listed on the ESA website? Perhaps a dedicated page, with a link in the handbook would be

appropriate.

The procedure for updating contact information, especially with ClassWallet is not clear. Once changed with ESA, it needs to be separately changed with CW, which many people may not know. Contact information also needs to be changed with debit card, which is not clear either. (I ran into this, personally, this year, so I know others will too.)

Thank you for moving information about the help desk forward in the handbook. It makes more sense here.

Page 4

What are the remedies for privacy and confidentiality breaches? Safeguards should be in place, and parents made aware of them.

Page 5

(Including Schools) has been removed from the first paragraph, and is actually important. There are known schools that claim they need access to the online portal, or to keep the card, and new parents won't know this isn't appropriate. There has been discussion around this, this school year.

Page 6

#3. Parents need instructions to find Statute, and SBE rules, as well as the parent guide & handbook, and allowable items list, etc. If we are required to follow them, we need to know where to find them, and what ADE's interpretation of them are.

It has always been really confusing, the way written, whether or not ESA parents are allowed to service OTHER ESA families. Many ESA parents are vendors within Classwallet, and even outside of the framework. It would be really helpful if clarification could be in writing. It is my understanding that 1. ESA parents ARE allowed to be vendors, and service ESA students, provided that they are not their own children, and that they do not take the funds directly – but what does that mean? Can they only accept a payment through Classwallet? Can they accept a payment using the debit card? Please consider clarification. (also page 11)

Page 8

Reimbursement as acceptable payment - this should not even be an option, as it is not equitable for ALL, and does not allow for all ESA students to have EQUAL access to educational opportunities. There are many online schools that are allowable expenses for students, which are coded as such that the debit card does not work. They do not fit the "brick and mortar school" restriction, yet we cannot access them, because of that MCC code block. ESA/CW/ADE has the ability to unblock these codes, and should do so, to allow all students full access to educational opportunities. If this cannot be done, then the concierge process should be reinstituted within ClassWallet.

Footnote 8. supplemental does not include the entire SBE definition (also on 16) in the footnote. Where is AAC R2-7-1501(14)?? Perhaps another link is appropriate here?

The allowed items list should really be referenced here, so that people know where to look to find it. Also, when changes are made to the allowable items list should be noted publicly. Just as policy and changes, and their dates are noted (or should be) publicly. Under "services provided by a public school", the thought is not complete "... and extracurricular ..." Extracurricular what?? Footnote 5. How can reimbursement EVER be a requirement? If there is not a way to pay for ALL educational needs within CW, or directly with ESA funds, there needs to be a better option. Reimbursement is not equitable for all, and not how the rule should ever appear to be written.

Page 9

Where does a parent find AAC R7-2-1508(C), and what does it say? If it's in the handbook, it should be written out, or linked, for easy access.

Perhaps there should be a section where clearly defined invoice & receipt requirements can be found, all together. Having to search through multiple sections of the handbook is counterproductive.

Page 10

Art supplies have long been a gray area. Disallowed consumables are now listed as only paper, pens, & markers. What if those things are recommended or required by the curriculum (there are curricula that recommend or require specific paper, pens & markers)? (also page 17)

Has the Kindergarten Tuition section been removed? Is that no longer an issue for parents? Funding is different for preschool & kindergarten. on the whole. and there are parents who will need the specifics of that.

Pages 13-15

So many spelling/spacing issues. Please proofread & correct.

Page 16

Legos ARE manipulatives - manipulatives need expansive definition by the Department. SPED children, and truly ALL children, learn by different methods, and MANY children learn in a very hands-on way – manipulatives are very common in AZ public school classrooms – INCLUDING Legos.

Mentions "grade level"—does this mean our students are restricted to their "cohort" grade level? This does not work for disabled and many times homeschooled students (My own and for example, is a so in terms of handwriting & manipulatives, often is at a so in terms of working memory, a functions more in a so in terms of range).

Do educational CDs include books on tape (audiobooks)? What CDs, specifically, would NOT be ok? Music? (also page 17)

Page 17

What is the difference between "art supplies" and "supplies" as referenced under supplemental materials?

What is a parent to do if common sense says that an item is recommended or required in order for learning to occur, but the curriculum does not list those exact 2 words?

Under documentation it lists Activity guides and learning guides – does that mean if the item INCLUDES those, it counts as documentation, and can be ordered at the same time as the supplemental items??

What about a "learn to _____" book in an order with supplemental items? Does that not constitute a curriculum (using common sense)? I.e: What if a cookbook has "suggested items" is that the same as required? A book that says "learn to play baseball", and the cart contains all baseball-related items, etc.

Page 19

Spacing/spelling issue under services provided by a public school (speechand debate)

In re: to uniforms for public school expenses – handbook does say can be required, which is a change, is the submission of that request the same as supplemental items?

Page 22

description of SPED provider

4th line spacing/spelling issue (paraprofessionalservices)

Clarification is necessary for "requirement" and "specific need"... how specific do SPED providers or IEP/MET/Eval need to be?? Does my provider need to go out and hunt down specific Amazon links, in order to request these items? Is it simply in the verbiage they choose to use to request these items? Please define and explain.

The link provided for SPED service providers is painfully out of date, and doesn't even list Autism as one of the categories of SPED need. This needs to either be updated, or corrected, to align with ESA student SPED categories.

Page 23

Any reference to the help desk really should be accompanied by specific instructions to access the appropriate category. If this is not doable, perhaps a "cheat sheet" for the help desk could be created, so that parents can know which paths to take, and which categories to choose.

Pages 23-16 Overall spacing/spelling/grammar issues. Please proofread.

Page 24 "Equine" therapy has been omitted, and simply says "therapy"

Page 31

Why do only "preschool severe need" students need new IEPs?

Page 34

Why is there even a list of disallowed items (which has expanded from one page to 3)? This does not align with the statute (which only disallows 3 items/categories - Consumable Educational Supplies, Computer hardware and technological devices, and Transportation). What constitutes "climbing equipment", "gym equipment", "gymnastics fees" (and why are gymnastics fees singled out?), "play equipment", "playgrounds"?

Why would warranties and protection plans NOT be allowed, especially for assistive tech devices? It would stand to reason that it would protect the device and save funding for the ESA/student, in the long run. And, we all know how hard kids can be on things like this.

Why no gymnastics fees, and why are they singled out, vs. all the other sports fees? Is this specific to competition fees, level fees, or classes too?

Page 39

Is "Home (Force.com) supposed to be a link? This is listed a couple of places within the document, and doesn't make a lot of sense. Under "Pay Vendor" it would be helpful to note that the vendors in this section have already been vetted by ESA, and provided acceptable credentials. Parents are not required to collect or submit for these vendors, provided they are using the Direct Pay functionality. If paying outside of CW, they DO need to collect and submit the vendor's credentials.

Pages 39-40

What about reimbursements of items, after contract acceptance, but before funding access has been given? Or, from the beginning of the quarter to the date of funding? Is that spending/reimbursement to all, or only new accounts? Especially in the middle of the school year – many people hit the ground ready to run, but there is such a delay in getting their accounts set up, etc., it would be nice to know that their spending is covered, etc.

Page 42

Last line (mayresult)

Page 44

States that the Department/ESA can audit at any time—should be changed to within 2 years, which was defined in the 2020-2021 school year.

Some purchases may "post" to CW on the date made, but a receipt may not be available until several days later – shouldn't there be a grace period? I realize that there are parents who are extremely behind in uploading receipts, and this is more meant to bring them into compliance, but to arbitrarily shut off an account, without that bit of grace is not right either.

Footnote 21 needs to be written out. Again, the audit window is 2 years, shouldn't that be noted, so that parents are aware? The notice of reviews and audits – is that a program-wide notification, or cherry-picked to those who are being reviewed/audited? How will we receive notification of an audit of our account?

Under invoices for tutors, paraprofessionals, or therapists: #6: How specific does this "proof of method of payment is required" need to be? Why does this even matter? As long as it is paid, and proof provided, this should be sufficient.

Categories could use definitions (educational materials/items, supplemental, associated goods, etc). Parents get confused, and don't know which category to use, as those lines are blurry.

Page 48

Wouldn't the already-provided documentation be closely considered when items are approved? Why would something that doesn't have the appropriate documentation be approved in the first place? What is the recourse of the parent if ADE/ESA decides to "change their mind" after an approval is already given/purchase made? ADE/ESA should be accountable to their decisions, so that parents aren't on the hook for 2 years.

ESA Account Specialist who then gives the approval to spend the funds.

b. in the same way when a parent/guardian submits a helpdesk request to use the funds it is either approved or denied by an ESA Account Specialist regarding the purchase.

These were to be a safe guard for parents/guardians regarding spending of the funds. BUT now that is not true, ESA is demonstrating that they are not to be held accountable for the decisions ESA/ESA Account Specialist made, and the Children are taking the fall for it. I have seen posted and talked to many parents/guardians who are afraid to spend funds on their children even if they have a preapproval for the item. Again, the children are the ones who lose in all of this.

The handbook NEEDS to provide a safeguard when an item is approved by an ESA/ESA Account Specialist, it is approved! period...

2) ESA is now implementing that only a select type of curriculum will be accepted to approve a supplemental item. In addition, the curriculum MUST say that item is recommended and or required, these words must be there.

a. Curriculum is not required to have a list of recommended and or required section in it. Most curriculum will imply the need for an item, or even allude to it.

b. There are so many types of curriculum out there. As there are many types of teaching styles. There are so many things that can be used as curriculum. What parameters is ESA using to select which curriculum will be allowed to use when requesting supplemental items.

c. In today's age of the internet, there are so many advantages and one big one is that curriculum can be uploaded and does not need to be put into print. I have been told by an ESA Accounts Specialist, that if a curriculum is on the internet in a number of different forms, it will not be accepted.

d. Many times base curriculum for our family is a starting point. We then go to other sources to add to and expand specially for our Special Needs Child, or any child. In most cases, it is the other sources that we use as supporting curriculum that has the items listed out that we will need to use to help teach our child.

i. In the past few months, these supporting curriculum has been denied as curriculum and can not be used to request supplemental items. This goes against the whole idea of creating a learning environment tailored for our children.

I am also seen parents trying to appeal decisions and being told they are not allowed to appeal because they are appealing the procedure - not the action. I am also concerned that the handbook was supposed to be provided to parents quite a while before it was actually supplied to the parents. Esa had a deadline, they failed to meet it and in turn the parents suffer and are forced with less time to turn in comments. An extension should be provided for the parents to Have adequate time to review this extremely long handbook, while we are trying to educate special education children at home instead of Esa deliberately turning in the handbook late and cutting down on the time we have to respond.

I also wanna point out that the previous Esa staff example **and a background and experience in special education**... The entire last year she was in charge we spent many many hours working alongside Esa staff to create more opportunities in the handbook... I feel that the purpose of New management this year seems to be to eliminate parent input, eliminate parent communication with esa, Eliminate guidelines that make the program more assessable, eliminate most of the approved items on ADE website for ESA students that previous esa staff and parents spent countless hours to develop last year so that the esa department could have more time to be productive to parent approvals and requests, they've failed to add back most of the approvals they removed without cause or permission by ADE. And now looking at this handbook it seems the new management wants the take the program backwards in productivity and accessibility, make definitions less clarifying and communicative. I am deeply deeply concerned that this is a direct result of management having absolutely no experience in child background, no experience in educational background, no experience in special education background, and no experience in learning. I feel like many of my comments were likely represented by at least one other person but you have no way to know how many of us feel the same way when they are not tallied in some way so we can indicate agreement.

The most egregious change is to make the curriculum say that a certain item is "required" as there are literally very few curricula that will do that. The "enhances" verbiage accounted for this obvious limitation and should be reinstated. The reason for curriculum not stating really specific items is because often public schools do not want curriculum that specifically states a certain item by brand name or specific details of the items required. For instance, if the PE teacher need a soccer net, there isn't a soccer curriculum saying that they need to use a certain soccer ball or net. And really the curriculum likely does not say "soccer ball" either as it is implied that you need a soccer ball to play soccer. This feels like just a way to make us not be able to use our funds to help our children.

The handbook needs to allow us to buy appropriate consumables like paper and ink cartridges so we can print items like worksheets for our children to use. The schools are allowed to do this so why can't those of us that educate at home? Logical consumables like pencils and paper and ink should be allowed just like they are at public school. And no, the curriculum is not going to say that you need paper in order to do the work. It is assumed that you need "paper" and you really need to hire employees with an educational background so they can look at our submissions and make logical decisions on what is approved.

Once an expenditure is approved by your staff, you can NOT go back and disallow it. That is not fair. If your staff can't understand the rules well enough to make an accurate determination, then it is unreasonable for the parents to do so. And if you make a mistake, then it should fall in our favor, not yours. Make the rules more clear so both your staff and the parents understand it, but allow the approval to stand once it was already made by your staff.

The approval database is not user friendly nor is it kept updated. Stop telling us to use it until that is fixed. And also we are told that you are backlogged with approval requests. You have funding to hire more employees so please do so. That is why you are given funding. Instead you keep asking parents to do your employees work like highlighting curriculum. We do and the employees don't take the time to notice it. Your employees are getting paid but the parents are not. Please train them.

I would like to know why Class Wallet is not required to issue a monthly statement to us so we can see a running total including where we are refunded when we return things. More than once the refund did not make it back to our account after I received an email saying that it was credited. Also why is Class Wallet using a personal American Express card on our orders to pay for items. I can see it when I place an order and then if I make a return, the return value doesn't show up back in my account unless I call Class Wallet and ask for it to be returned. I assume it is instead going to that personal American Express account. That seems very suspicious and most people don't have the time to check on it. Also why is Class Wallet is not paying those same taxes to Amazon, therefore, they are collecting taxes themselves as profit which I think is illegal. If the business accounts do not pay taxes, then that savings should be passed along to our child not to Class Wallet

Concerns:

1) There are no safe guards for parents/guardians who follow the protocols set by ESA, when using the ESA funds for their children. a. The entire purpose of Class Wallet is that when a parent/guardian requests to use the funds, the request is first reviewed by an ESA Account Specialist who then gives the approval to spend the funds.

b. in the same way when a parent/guardian submits a Help Desk request to use the funds it is either approved or denied by an ESA Account Specialist regarding the purchase.

These were to be a safe guard for parents/guardians regarding spending of the funds. BUT now that is not true, ESA is demonstrating that they are not to be held accountable for the decisions ESA/ESA Account Specialist made; Families and Children are taking the fall for it.

Many parents/guardians who are afraid to spend funds on their children even if they have a pre-approval for the item. Again, the children are the ones who lose in all of this.

The handbook NEEDS to provide a safeguard when an item is approved by an ESA/ESA Account Specialist, it is APPROVED! 2) ESA is now implementing that only a select type of curriculum will be accepted to approve a supplemental item, (ie, not from a manufacturer). In addition, the curriculum MUST say that item is recommended and or required, these words must be there. This is extremely limiting as *most* curriculum isn't going to use that language.

a. Curriculum is not required to have a list of recommended and or required section in it. Most curriculum will imply the need for an item, or even allude to it. It assumed that common sense is being employed. For example, if one is taking a photography class, one will *need* a camera.

b. There are many types of curriculum. What parameters is ESA using to select which curriculum will be allowed to use when requesting supplemental items?

c. With the vastness of the internet, there are so many advantages and one big one is that curriculum can be uploaded and does not need to be put into print. I have been told by an ESA Accounts Specialist, that if a curriculum is on the internet in a number of different forms, it will not be accepted.

d. In the past few months, supporting curriculum has been denied and has been unable be used to request supplemental items. This goes against the whole idea of creating a learning environment tailored for our children, many of who are already struggling due to disabilities.

ii. These items were not being denied because they were not allowed, but because the curriculum did not fit in the "requirement" now set by ESA.

3) With regard to special needs preschool age children, it is very difficult getting items needed for them to succeed in the area of play. There are many studies done on the importance of preschool play and the development that is accredited to it. Here are few links showing the importance of preschool play;

a. It would be nice to have this area explored and expanded on so that we are able to buy supplemental items for our children for the purpose outlined in the links above.

b. and for our children who have a diagnoses that one or more of these areas are lacking.

The ESA program is an amazing opportunity for children with a wide variety of abilities and needs to be able to learn, grow, and thrive. I am concerned however that instead of assuming the best of parents, they are viewed with suspicion - like a sneaky child trying to get away with whatever they can. While there may be a rare, rogue case I promise you that the vast majority (99%) are seeking to educate their children in a way that will result in deep lasting ways. Please come alongside and help provide an amazing education that will result in preparing this next generation to thrive.

Pg. 10 #5 I thought parents with an LLC could provide services, clarification on that.

Pg. 12 In regards to the definition of curriculum: many ESA recipients are special needs and do not work at a typical grade level. Also, most publishers do not list specific items as "required or recommended" as to keep the curriculum approachable and usable for many different situations. Curriculum definition should be allowed to "enrich or enhance" the curriculum. Common sense should be allowed in situations that item is implied such as a violin lesson book, it is implied that the student would need a violin however the lesson book doesn't specifically state one is needed.

Pg. 20 Educational Materials: Lego's should be included in this list. They are a self contained curriculum that supports STEM education. Many studies and research confirm this.

Pg. 21 paragraph 1: Strike "approved by the Department". Curriculum should be defined by the definition, not the Department. Under examples, Lego's should be moved to the approved without curriculum category as stated above, they are a stand alone curriculum supporting STEM education.

"Item is recommended or required" should include enhances or enriches as stated above publishers tend not to list specifics to broaden the use of the curriculum.

Of concern: does screen shooting the inside of curriculum violate copyright law?

Pg. 38-39 Animals (including invertebrates); does this include lab specimens, as they are required for high school Biology? If Home Economics is allowed, kitchen supplies should be allowed.

If Gym Memberships are allowed, gym equipment & bicycles should be allowed.

If Swimming Lessons are allowed and Gym Memberships are allowed, pool passes should be allowed.

Page 8-Curriculum: this needs to be revised. Approved by the department leaves way too much grey area. Different staff approve differently and consistency is often lacking. Also, when did the enhance or enrich aspect of supplemental vanish? Many curriculums do not state 100% of every item needed and is often assumed that yes, you need XYZ to accomplish these goals. Also, how kids learn is differently. If one item is listed as required it doesn't mean that it will work for every single student.

Page 16-Educational Camps-what about extra curricular camps? Those are very valuable as well as core subject camps. Also what about city camps? Those credentials are nearly impossible to get yet they are offered during summer, spring or fall breaks and would be a wonderful asset to ESA students educational goals.

Manipulatives could very easy include many hands on learning for science, art, history etc...not just math. These would all be things that "enhance or enrich the curriculum".

Page 17-Supplemental verbiage of required or recommended and approved by the department. PLEASE expound on this. This doesn't allow for flexibility of learning methods or grade level differences. A preschooler learns very differently than a 10th grader and one size does not fit all regarding approval or if lesson plans state what is exactly needed-that just doesn't happen. Also, who is "the department"? This being explained thoroughly while understanding the complexity of learning abilities in the program is quite necessary.

Supplies-how can art supplies be allowed for supplemental and not allowed all in the same section? Paper, pens, and markers are all art supplies.

Clearly demonstrates recommended or required, once again, needs to be clarified. That is largely up to interpretation of parents and students and the department may often disagree with the students learning goals and how those goals are achieved. I can clearly see a need for an item which the curriculum doesn't state but would help reinforce the topic for my student. Also, screenshots/photos/copies are PROHIBITED for many curriculums according to their copyright policies.

Page 18-STEM/STEAM computer hardware/tech devices not allowed...HOW??? It is year 2022 and most STEM/STEAM items use tech. Please clarify on this. Does this mean anything that is plugged in is disallowed? Robots, cubelets, leap frogs, kitchen appliances to help with home ec....the list goes on and on.

Page 19-online learning programs-can we submit a receipt and split it between 2 students rather than purchase the exact same thing twice? That is a waste of our students funds.

Page 20-Tuition/fees postsecondary school-what about a private online university?

Page 22-Eligible students-it would be helpful to state how to contact ESA to update category. List the email address it needs to be sent to.

Page 23-please highlight...no, just no. That is not a parent or educators job. Home educating our SPED students is more than a full time job as is. Making silly demands like this is more of a hinderance to our ability to teach.

Page 28-can't student without disabilities also attend CTEDs, JTEDs, Trade Schools, Community Colleges, and Vocational Schools??

Page 34-disallowed consumables, once again as on page 17, supplies-how can art supplies be allowed for supplemental and not allowed all in the same section? Paper, pens, and markers are all art supplies.

Not approved-live animals-what about life cycle studies? Caterpillars, chicks, etc?

Animals-even for dissecting purposes??

Page 39-please update this debit card section. It is very confusing of where the debit can and can't be used. Knowing 100% of the time which businesses are in the marketplace or a vendor is nearly impossible. It is not user friendly at all to navigate. Some places require the word The before it for example before you can find it in the vendor list. Also, when are these debit card transactions reviewed by the department? I haven't heard regarding any of them for the entire year. This needs to be stated and communicated clearly.

Credential required?? Not for all purchases...ie amazon doesn't have a credential.

Page 41-this rule needs to be revised regarding suspended debit cards after 10 days, many subscriptions or services bill at the end of the month yet their invoices are delayed many days.

Page 42-CW Terms and Conditions-CW is not the best program for user friendliness. One example, it is much easier to make Amazon purchases for things we know are approved (such as books) with the card and be able to get them with prime shipping, have access to tracking, and easier returns if needed. CW is a HUGE hassle for many things and the debit card is just plain easier for families.

Page 43-Prohibited Use-Target and Walmart both sale educational items. How is this means for suspension??? If someone tries to buy books there or a STEAM curriculum box, and the card won't run due to an MCC error-how are we supposed to know ahead of time that the MCC code doesn't work????? Before I had NO IDEA what an MCC code was and I still have no idea how to know where it's approved or not.

Page 45-CW needs to offer families this same thing, We need to see a full accounting of ALL of our expenses through the platform. Currently we cannot. When things are returned or not shipped when cancelled by vendor we do not get our funds back unless we pursue it and fight to get the funds back. Also, the taxes aren't returned either...how is this legal??? How do we pay taxes to CW for our orders yet they don't pay them to the vendors???

What entails proof of payment for reimbursement?

Page 47-Suspension of ESA Account-I know I don't get all email communications from the department or ESA and no reason why some don't come through. If you're suspending an account, a certified mail letter needs to also be sent to ensure it is actually received.

What is missing from the handbook?

Having links to ESA Az specific tutorials for ClassWallet is definitely a need. The program is not easy to learn as a new ESA user as the tutorials are for the generic CW users-not home educators.

For instance, when curriculum is created for students it doesn't always list all materials needed so it can be adapted based off of the students needs. They write it thinking some items are common sense items needed to complete the lesson. I have one child with **source** and another with **so** they have different needs and require different adaptations for learning. I thought the current wording regarding supplemental materials was the best wording and the new wording is discriminatory and problematic. My child with **so** is currently in **so** needs certain adaptations for **so** n home therapy. With the proposed wording in the handbook and recent denials, I'm very concerned about the possible disruption to **so** learning/therapies. To say an item must be required or recommended is discriminatory to those who require more assistance with learning and that's why I believe the current handbook wording is the most inclusive.

The part addressing life skills education was good, except for the fact that it states the department has final approval for life skills training and then provides a small list. I think it should have something similar to home ec and other in home life skills considering many students with disabilities struggle to learn these basic skills.

I also noticed kitchen supplies are not approved to be used with ESA funds, but I'm concerned with that listing because students in public schools have access to home ec and culinary courses. Another concern is the fact that that limits students from learning an extremely valuable life skill, especially for kids with disabilities.

I do not understand why the handbook specifically lists a slew of things as disallowed that are not disallowed in statute. From my understanding the statute specifically disallows the following;

(a) Computer hardware or other technological devices, except as otherwise allowed under paragraph 4, subdivision (c) of this subsection.

(b) Transportation of the pupil.

(c) Consumable educational supplies, including paper, pens or markers.

Many items on the disallowed list have educational value when paired with proper curriculum. I'm not advocating that these items should be allowed without documentation but rather that they should be allowed when being utilized with curriculum. Many of the items on the list are found in schools and/or utilized as part of public education; bicycles, gym equipment, magazines(as the

zoos, art exhibits, nature programs, national parks, state parks, cave tours, aquariums, event tickets, etc.)

Printing and binding should be an allowed expense because there are many curriculums such as one I utilize (Blossom and Root) that only come in a digital format and must be printed. The printing costs are more cost prohibitive than the curriculum itself.

I am frustrated that the words recommended or required are being so blatantly pushed to a degree that is often impossible to achieve. Curriculum or classes with supply lists are not being considered enough because exact brands or specific items aren't specified. The SBE definition; "Supplemental material means relevant materials directly related to the course of study for which they are being used to introduce content and instructional strategies or that enhance, complement, enrich, extend or support the curriculum" was very useful. For example, last year we studied farms. I was able to get a root view planter without it being specified in curriculum as a supplement to our farm curriculum. We were discussing crops and what parts of plants are edible and the planter allowed my see carrots, onions, and radishes, grow underground. I am also frustrated with the "approved by the department". This seems an obvious step but in the last year we've seen the department jump all over the map with what they are approving and not approving, changing things previously approved without communication. It makes it difficult to have confidence in the department's ability to be consistent and just in their approvals. Having it underscored brings me unease.

On page 8 under confidentiality, I'd like to see lawmakers, lobbyists, special interest organizations, news outlets added to the list of people our information will specifically not be given to. The data breeches in the past have been hugely detrimental to families and some of these were the sources.

I would like to see a process added for by which communications are required if families are given a pre-approval that becomes invalid or if changes are made to the online approval database by removing items or reclassifying them.

I would like to see a process specified for how and when items should be added and updated in the online database of approved items.

I would also like to see protection for families against the department if mistakes are made at the department in approvals. Families should never be held liable if the department makes a mistake in approvals. Parents have done their due diligence by getting approvals and submitting required materials. If something is found to be wrong it should spur retraining, not requests for repayments.

I would also like to see the Parent Advisory Council addressed with rules that more closely resemble an actual stakeholder board. The PAC has been decimated this year. The last meeting was held without notice to all stakeholders or our ability to attend. We need an active voice in the program.

Public schools have access to weight rooms. What bad could come from students training on gym equipment at home? How is that NOT PE and part of their education?

Museum and zoo memberships are nothing but educational opportunities even without a specified curriculum. I don't understand why these items aren't allowed. They're fantastic opportunities for children to explore their interests and learn organically without being bogged down by specific requirements listed in a curriculum. Why must we mandate what they learn when they're perfectly capable of learning through interest-led interactions. If my the science museum regularly, I have to scour the internet to find a curriculum where a science museum membership is listed as required to have access to this amazing resource. What harm would it do to have access to a museum (which are specifically created for enrichment and learning opportunities) just because my want to go there?

Pool passes too, in my opinion, fall in this category. Yes, playing in the pool would be a part of it, but it's also a fantastic way for children to exercise and socialize. It seems that anything that could possibly be used a play is disallowed. Children learn through play and these funds are supposed to help provide them access to a quality, well-rounded, education. P 47 Dept will notify the account holder via email for suspension -- this is not good practice. So many emails go to Spam, and Gmail along with other email svc providers will often block messages before they even get to Spam. Official correspondence shouldn't be relied on delivery by a tech conglomeration. Also, not everyone on ESA has consistent access to the internet, and internet is not a charge that ESA covers.

It states debit card can't be used at vendors not already in class wallet but this makes it hard to make the best used of the students funds. I think we should have the ability to use it at places like Amazon and Lakeshore for example. Amazon often has short term deals that we can't wait for approval but know it would be an approved item such as books. Amazon often has coupons you can click to add to your order which won't work with the Classwallet business account which needlessly wastes the students educational money. In the the example of a buy two books get one free while the discount comes off after the order is processed but Classwallet is not good about giving the funds back. I had one time where I got difference only after requesting it from classwallet. Another time after two emails the difference in cost due to the sale was never returned to the students account and Classwallet kept those funds. With Lakeshore you can get free shipping with codes or other discounts if we use the debit card. If we go through class wallet the shipping is high and no discounts apply so again, we are wasting money that could be used towards other educational needs.

I see event tickets has been added to the disallowed list. I'm not sure if that includes all events but there are often things beyond museums and zoos that are very educational that go along with our curriculum. My children had the opportunity to attend the Immersive Van Gogh Exhibition last year thanks to ESA. It was a great way to compliment our studies of some the Master's of Art and more intensive study into his life and work. Having that experience really brought things together for them. They got to see replicas in his handwriting of all the letters he wrote his brother, more of on his life, and then getting to be surrounded by his art. It brought to life what they had been taught and helped them connect what they had learned prior books, creating their own art and documentaries.

I wish the supplemental materials didn't seem more restrictive with only allowing required or recommended. I understand wanting to be sure the items go along with what we are learning but often curriculum will not give a required or recommended list. Especially if it is something we have pieced together to from many sources to create our own curriculum. Many great items aren't required but help with the hands-on learning. When we did a unit on sharks, we were able to get a 4d shark anatomy model which helped them to see what they were learning about in the books and about the parts of the shark. Having that tactile item aided in their learning. While not required it surely enhanced their learning. The restrictive wording could hurt students for example a child taking learning music or other skills. My started taking flute lesson through an ESA vendor and we bought a flute book through Amazon and we were able to get a flute last year. With the new rules while the lesson book does not state a flute is required or an exact one it is implied with the book and lessons one would need a flute to learn the instrument.

Even though many curriculum choices have a list of things that are used to complete the lessons, many things are going to be rejected because of the verbiage not saying that it's recommended or required. Some curriculum sets use verbiage such as "things to gather" or "useful additional items." This should be implied that the author of the curriculum is telling you the reader that is needed for the course. The other concern is that parents are not going to be able to expand on the curriculum subject by enhancing the subject because related materials are not mentioned in curriculum. This would be disallowed. That is pretty limiting, especially to families with special education/needs. Many special education students learn better with multisensory approach which uses all of the senses. So adding related materials to curriculum seems like it would be greatly restricted by not having a way to approve these items that do not have a curriculum that specifically lists them as needed. With many of the staff using this verbiage as the way to allow or disallow thing I believe it should have some kind of language that allows for this type of curriculum enhancement when it is clear the subject is related.

Parents want to see their feedback really taken seriously. Parents want to know that ADE is really wanting to work with parents to make the program work for all ESA kiddos.

The handbook doesn't explain accountability of the department. As an ESA parent, I would love to know that every transaction that is approved by the department is an allowable expense and the department won't come after my personal funds after they have approved a purchase. The department needs accountability and shouldn't be allowed to approve purchases and also allowed to audit those same purchases. This is 100% the fox guarding the henhouse and should never be allowed to be done by a government entity. Parents want to trust ADE.

ADE specifically asking the State Board of Education to add rules which allows ADE to go back to a risk-based approach is a bit unnerving and unnecessary. CW is paid for by the ESA recipient's funds. The department does not spend one single penny on the CW system. So, our children's education is paying for the demise of their own education and that is not fair to our ESA kiddos.

Essentially, CW was promised to parents and to AZ taxpayers so that absolutely no misspending and no fraud happens. But now, we have ADE staff, that for reasons that we may never know, has allowed misspending and ADE can now "audit" an account and turn parents in for purchases that ADE has allowed.

Audits by the ADE should be done for quality assurance and training purposes only, except for the CW card. CW cards should 100% be audited. I'd love to see accountability for ADE in the handbook. The handbook lacks this every year. Parents want to trust ADE. With current events and current rule changes that ADE has asked for, this is impossible without the honesty of ADE.

What is missing from the handbook?

Here are my comments at one of the ESA feedback sessions.

I listened in and took notes at last week's handbook feedback session last week, there has been some really great feedback. So, thank you to ADE for putting this feedback session together and thank you to all the parents that have taken time to share feedback. With that said, there is only one thing that I will speak on and it hasn't been mentioned yet. It's definitely something that needs to be written and explained in the ESA handbook.

I have noticed that many parents don't realize that there is a difference between an approval and a pre-approval. I didn't make this up. It's actually something that the ESA department already does but it hasn't been explained to parents. I think it's important for ADE and ESA parents to be on the same page and adding this information to the handbook would help clear up some confusion. The need is definitely there.

A pre-approval is when a CW card is used and the transaction is looked at by ESA staff AFTER the transaction has already been made. A pre-approval can only be done with a CW card because funds leave the account BEFORE ESA staff has a chance to look at the transaction. So, thats the pre-approval, its a CW card transaction.

An approval is where ESA staff look over the purchase before allowing the transaction to go through. This means that all CW Marketplace purchases made through CW's online portal, every single one of those transactions are "approvals" since every single transaction is vetted and approved BEFORE funds are released from the account.

Again, a PRE-APPROVAL is when transactions are automatic without the staff vetting the transaction, which ADE only allows with the CW card.

And an APPROVAL is when transactions are vetted beforehand and funds are released after ESA staff have already done their due diligence of making sure everything needed for each transaction is there BEFORE a transaction is pushed through. This is done WITHIN THE CW SYSTEM whether its an Amazon transaction or a PAY VENDOR transaction, a REIMBURSEMENT and even done through a HELPDESK TICKET.

A little background on CW safeguards **and a** I know that you are very much aware of this. You have been on the frontlines of school options in Arizona for a long time. Plus, you were on the ESA Task Force, which approved CW as the 3rd party vendor. So, I do know that you are very much aware of the safeguards that ADE has access to. **I and the set of the set of**

In 2019 the Arizona Department of Education wanted to ensure that: 1) The program efficiently serves parents whose children are eligible for an ESA and who choose to use the ESA program as a means to provide them a quality education. ADE was confident that CW would provide ESA parents with greater consistency and clarity concerning allowable program expenses. This verbiage comes directly from the Arizona Department of Education.

When the Treasurer's office put out a Request for Proposal for an ESA 3rd party vendor, the only company that answered that request was Classwallet. They sent in a 74 page response for the RFP to the Treasurer's office, which included how to Safeguard the ESA program so that misspending and fraud would not happen.

The safeguards to the program are the approvals and pre-approvals that I have mentioned. Pre-approvals are CW card purchases where the transactions are looked at by ESA staff AFTER funds have already been pulled from the account. It's the only process where ESA staff look at the purchase after funds have already been pulled from the ESA account.

And approvals are when transactions are vetted by ESA staff to make sure that each expense is allowed and this is where ESA staff makes sure that any and all information needed is attached before a transaction is approved which then allows funds to be pulled from an ESA account.

Safeguards are put into place to protect the ESA program. CW was put into place to streamline and simplify the spending of ESA funds to better manage the funds of ESA recipients.

Again in 2019, Superintendent Hoffman also said that "moving to CW will be more on the preventative side and more proactive to make sure ESA dollars are going where they are allowed to go" Link: https://azcapitoltimes.com/news/2019/06/13/law-or-not-school-voucher-oversight-in-the-works/? fbclid=IwAR3dFS3nxCJpJDCnt_vnkMPabuZwMDnzdxK2X9yC-RA6TSNxE2McX1soq4I

And again, in 2019 **Terminal** with the Arizona Department of Education said "There's a perfect example where a family is being advised or not understanding the law, so they're going to spend something, innocently even, on an expense that is illegal. And so we have to catch that retroactively, and now we're asking a family that's already spent the money to reconcile that,"

He was speaking about the process with the Bank of America card and why the ESA program needs the CW system.

He also stated that, "More to the point, this marketplace – kind of like an online shopping portal – will prevent parents from buying items that are unapproved.

My point in bringing all of this up is that CW was brought to the table and implemented to serve a purpose. Safeguards play a very important part in serving this purpose and should 100% be explained to ESA parents in the handbook. I don't see any reason why this information should not be shared and explained in the handbook for parents to understand. This would definitely help clear up confusion and would allow parents and ADE to be on the same page.

Many times parents will send in curriculum that is sufficient and even highlighted for the staff to clearly see where and item is required or recommended (which is the staffs favorite phrase anytime they reject something) only to have it denied still. How can we leave the decision of acceptable curriculum and course of study up to staff members who don't even look at the information sent into them?

My next issue is with ESA removing the phrase "enrich and enhance" under supplemental items. This is a vital phrase in assisting us to educate our students in the best way possible for them. Staff has repeatedly ignored this phrase this past school year. We bring it up and it's ignored and passed over as if it's already not even in the handbook. That alone shows me that this is a malicious attack on our education. If something is stated and is being ignored before it's even removed, there is clearly a problem. This phrasing was added to the handbook to help parents and ESA staff wants to remove it. What does that tell you about how the staff cares for our children? No child learns the same as another. Many children require hands on learning. As parents and educators of our children, we know what's best for them. We know what works and what does not. ESA staff has no clue!

I am also very concerned with these vague definitions that don't seem to have any answer. All of these vague definition seem to leave Esa available to reject anything at any time for any reason. I am also seen parents trying to appeal decisions and being told they are not allowed to appeal because they are appealing the procedure - not the action. We need to be able to appeal erroneous decisions. I am also concerned that the handbook was supposed to be provided to parents quite a while before it was actually supplied to the parents. Esa had a deadline, they failed to meet it and in turn the parents suffer and are forced with less time to turn in comments. An extension should be provided for the parents to have adequate time to review this extremely long handbook, while we are trying to educate special education children at home instead of Esa deliberately turning in the handbook late and cutting down on the time we have to respond.

I also want to point out that the previous Esa staff example **accompact group** background and experience in special education... The entire last year she was in charge we spent many many hours working alongside Esa staff to create more opportunities in the handbook... I feel that the purpose of New management this year seems to be to eliminate parent input, eliminate parent communication with esa, Eliminate guidelines that make the program more assessable, eliminate most of the approved items on ADE website for ESA students that previous esa staff and parents spent countless hours to develop last year so that the esa department could have more time to be productive to parent approvals and requests, they've failed to add back most of the approvals they removed without cause or permission by ADE. And now looking at this handbook it seems the new management wants the take the program backwards in productivity and accessibility, make definitions less clarifying and communicative. I am deeply deeply concerned that this is a direct result of management having absolutely no experience in child background, no experience in educational background, no experience in special education background, and no experience in learning. Parents have never had an issue following guidelines set by Esa, the past audit on parents showed there were no miss spending issues on the part of the Esa parents. The issues arise in staff constantly changing rules and approvals midyear, or rescinding approvals after they were given. Is the point of the handbook to serve the children and provide learning opportunities or not?

SBE procedures. Chain of command to escalate problems when parents feel higher chain of command needs to be involved. Timelines for requests, reimbursements, approvals - some parents are waiting a month before anyone responds. There should be a timeline for parents to be answered- Someone to hold accountability and contacts to dispute. We are told to contact supervisors in esa and then ignored. All departments in ADE have a chain of command and supervisors at district level to resolved issues that go unresolved.

Qualified service providers, the document the ADE has, it does not even include or reference students with the disability if the I fee I concerned that it could be used against us, because if you need an associated good or assisted tech for a student with an IEP category of the handbook reads that you can not order under these categories. Not all people with an have an IEP with Speech that will list AT or AG.

Also, the handbook requires that the IEP state the specific good or service. Quit often the IEP is outdated, the school staff does not hardly ever list AT or AG on an IEP. Let alone a type or brand.

I feel that this could be defined & expanded on. Really look at the average IEP on file.

Special education service provider list does not list anyone with a service to students. So we would have to jump through hoops and waste time, funds and resources to meet these requirements.

I think there must be something that can be noted.

Are we supposed to go get a new IEP and evaluation from the public schools to write all of what we need in an IEP so that we can get an approval from ESA dept. It should not be that way.

This is what it should be for students with a disability. The handbook should follow the statute and rule closely, pretty much mirror it, on this category and subject.

It does not just state, an IEP or a qualified provider. That does not make sense at all. Pursuant to A.A.C. R7-2-1505 (B)(4):

Associated goods and services that include, but are not limited to, educational and psychological evaluations, assistive technology rentals and braille translation goods and services approved by the Department. Associated goods as described in this subsection may include computer hardware or technological devices that assist in accessing educational materials or services and that are associated with the qualified student's needs. Parents that are seeking to use Program funds for an associated good or service pursuant to this subsection shall provide to the Department the special education course of study, service or educational need that the good or service is associated with.

page 34 should also make mention of *Department approves some requests with students in the program with a disability. This program was built to serve that population. We need to feel supported and the handbook should reflect that support.

Not approved, it says breakfast fees, but lunch and dinner fees should be included as well. pg 34

Camps- Needs to be defined. Is cam only for students with disabilities? If a room, board and meals are included in an educational camp, is that allowed?

Can a parent with a business that uses ESA for their family, serve other families? That needs to be further explained.
