This was determined to not be a repeat finding from previous cycle and did not contribute toward fiscal action calculations.

Specifically, during breakfast the Grab-n-Go breakfast bags 2 1/2 cup of fruit was provided and not the 5 cup minimum weekly Fruit requirement. This was determined to not be a repeat finding from previous cycle and did not contribute toward fiscal action calculations.

5 The following product could not be credited towards the meal pattern due to insufficient documentation: Pancakes. Without sufficient documentation, the reviewer was unable to determine if the quantity requirements were met. This was determined to not be a repeat finding and therefore did not contribute toward fiscal action calculations.

6 Quantities observed during the review period did not meet minimum amounts required by the meal pattern. Specifically, during lunch the Grab n Go meal on 3/23 and 3/24 provided 1/2 cup of Vegetables and not the daily 3/4 cup minimum required. This was determined to be a repeat finding from previous cycle and contributed toward fiscal action calculations.
