 - Rollover data. Student's may have two different SPED LREs reported, or rolled over Preschool LRE is reported in KG grade
- Possible Solution:
 - Check the SPED10 and STUD10 reports in the AzEDS Portal.
 - Confirm only the accurate LREs are reported.
 - Confirm Need, LRE, and Grade align to <u>Concurrent Need and Least Restrictive Environment</u>
 (LRE) Code Eligibility Matrix
