EL Reports - Quick Reference Chart

EL Report	Where to locate in ADEConnect	Purpose
EL10 - EL Data Verification Report	AzEDS Portal Application	This report provides a compilation of student EL data that has been submitted to ADE.
EL70 - AZELLA Student Test History Report	AzEDS Portal Application and Assessments Application	This report displays all AZELLA tests administered to the student with the SSID entered. This report may be generated only for a student who is currently enrolled or seeking enrollment at the district/school requesting the report. Use of this report may be monitored to ensure compliance.
EL71 - EL Program Participation Report	AzEDS Portal Application	This report documents for the LEA which students were placed into an EL Program, and when submitted, the EL Program Exit Reason. The information displayed on this report is post-integrity.
EL72 - AZELLA Roster Report	Assessments Application	This report displays all of the AZELLA Placement and Spring Reassessment Tests that were administered by the LEA/School during the Fiscal Year.
EL73 - EL Student Need Report	Assessments Application	This report displays all students in an LEA/School that have an EL Need. Once a student attains an Overall Proficiency Level of "Proficient" on the AZELLA or is Withdrawn due to SPED Criteria from EL Services, the student will no longer appear on this report. The information reflected on this report is based on the accuracy of the data submitted to AzEDS by an LEA/School for the current and/or prior Fiscal Year(s). Integrity errors, incorrect testing of EL students, and other factors - like delayed reporting by other schools - will impact this report's ability to capture an EL Need. Schools are responsible for verifying and supporting the needs of their students.
EL74 - October 1 EL Report	AzEDS Portal Application	This report compiles student level EL Program data for October 1 Enrollment purposes. Data is validated with specific integrity rules relevant to October 1 for numerous data elements. The student membership information displayed on this report is by District of Attendance (DOA) and District of Residence (DOR) and is post-integrity.
LEA Reason (for Lack of AZELLA Reassessment)	Assessments Application	All LEAs must complete the "LEA Reason for Lack of AZELLA Reassessment" due to a Title III finding from the U.S. Department of Education. Reporting this information does not remove a student from the requirement to test on the Spring AZELLA Reassessment.

Immigrant Need Codes

The Emergency Immigrant Education Program grant is a targeted subgrant of Title III. **Funds are awarded to selected LEAs who have experienced a significant increase in the number of immigrant children and youth enrolled in the current fiscal year as compared to the preceding two fiscal years.** Please make sure your Student Information System is updated with immigrant need codes by October 1, 2022. OELAS will pull data on this date to determine FY23 allocations for this funding source. Awards will be announced by the second week of October 2022. Need help with immigrant need codes?
