

## AzEDS EL Data Integrity Error Codes Troubleshooting Guide

The Office of English Language Acquisition Services (OELAS) has created this troubleshooting guide to assist Arizona LEAs in correcting EL data integrity errors on the INTEG15 Report. This document provides an additional resource for LEAs to reference and better understand the errors and possible steps for a resolution in their Student Information System (SIS).

ERROR CODE	30000
Error Message	There is more than one ELL Program specified at a single point in time for this
	need.
Troubleshooting	Check the EL71 – EL Program Participation Report to verify EL program entry and
	exit date. Revise dates as needed to ensure no program overlap exists.

ERROR CODE	30001
Error Message	Most recent Assessment did not show student to be ELL.
Troubleshooting	Check the EL70 – AZELLA Student Test History Report and verify the student's eligibility status. If the student's most recent assessment is overall proficient, this student does not qualify for EL program services.

ERROR CODE	30003
Error Message	Student must have a qualifying ELL Assessment within the current or past fiscal
	year and the qualifying ELL Assessment must be on or prior to the ELL Program
	start date.
Troubleshooting	Check the EL70 – AZELLA Student Test History Report and verify that the student
_	has a current or prior year AZELLA. Ensure student has been placed in an EL
	program on or after date of assessment.

ERROR CODE	30006
Error Message	Invalid grade (preschool) for ELL submissions.
Troubleshooting	Preschool students are not eligible for EL program services. Remove preschool student from EL program services.

ERROR CODE	30007
Error Message	Entity does not have permission to offer the ELL Program for the stated fiscal year. (An ELL Program has been submitted for a student attending school outside Arizona).
Troubleshooting	LEA does not have permission to offer an EL program. Remove student from EL program services.



ERROR CODE	30008
Error Message	Entity does not have permission to offer the ELL Program for the stated fiscal year. (An ELL Program has been submitted for an LEA that is not a school district or charter school).
Troubleshooting	LEAs that are <b>not a school district or charter school</b> do not have permission to offer an EL program. Remove student from EL program services.

ERROR CODE	30009
Error Message	There must be a corresponding enrollment for each day of an ELL Program
	participation.
Troubleshooting	Verify the student's enrollment transaction in the SIS. Ensure the enrollment dates
_	align with the EL program entry and exit dates.

ERROR CODE	30010
Error Message	Student has an existing ELL Program participation at a different school this fiscal
_	year.
Troubleshooting	<ul> <li>Option 1: Check student's withdrawal paperwork to identify prior enrolling school. In this case, prior school has not properly exited the student from EL program services and must do so. Contact prior school to request the student be exited from EL program services.</li> <li>Option 2: Check the EL70 – AZELLA Student Test History Report to verify prior enrolling school. If the prior LEA administered an AZELLA test to the student, the EL70 will display the prior school enrollment. Contact prior school to request the student be exited from EL program services.</li> </ul>

ERROR CODE	30011
Error Message	ELL Program Exit Date must be greater than or equal to ELL Program Entry Date.
Troubleshooting	Verify EL program entry and exit dates; exit date must be AFTER entry date.

ERROR CODE	30012
Error Message	Fiscal Year of ELL Program Entry Date and ELL Program Exit Date is NOT the
	same.
Troubleshooting	Verify EL program entry and exit dates to ensure they are in the same fiscal year.

ERROR CODE	30013
Error Message	Missing required element: ELL Program Exit Reason Code required when ELL
	Program Exit Date provided.
Troubleshooting	All students exited from EL program services MUST have an EL program exit reason code <b>AND</b> EL program exit date. Update SIS by ensuring both of these elements are included. EL Program Exit Reason Codes can be found at: <u>AzEDS EL Transactions At-A-Glance</u>



ERROR CODE	30014
Error Message	Missing required element: ELL Program Exit Date required when ELL Program Exit
	Reason Code provided.
Troubleshooting	All students exited from EL program services MUST have an EL program exit reason code <b>AND</b> EL program exit date. Update SIS by ensuring both of these elements are included. EL Program Exit Reason Codes can be found at: <u>AzEDS EL Transactions At-A-Glance</u>

ERROR CODE	30015
Error Message	Date falls outside this LEA's session calendar.
Troubleshooting	Verify EL program entry and exit dates are aligned with the LEA's session (school) calendar.

ERROR CODE	30017
Error Message	Student must have an ELL Program participation Exit Date and Exit Reason.
Troubleshooting	When student is withdrawn from school, they must also be withdrawn from EL
	program services. Update appropriate section of the SIS to ensure alignment with the enrollment transaction.

ERROR CODE	30020
Error Message	Need Exit Date must be greater than Need Entry Date.
Troubleshooting	Verify EL need entry and exit dates; exit date must be AFTER entry date.

ERROR CODE	30022
Error Message	Missing student ELL need for all or part of ELL Program participation.
Troubleshooting	Student must have an EL need for each day of EL program participation. Update SIS to ensure alignment.

ERROR CODE	30023
Error Message	There must not be more than one ELL need specified at a single point in time for the school.
Troubleshooting	Student can only have one EL need at a single point in time. Update SIS to ensure alignment and remove duplicate EL need.
