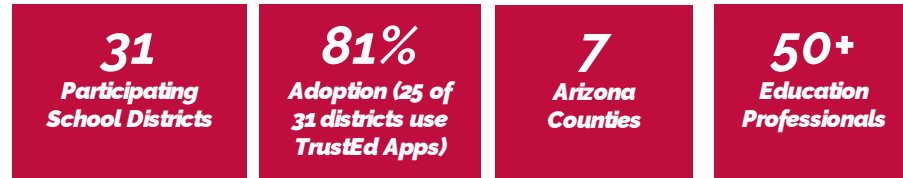

TrustEd Apps Arizona in collaboration with 1EDTECH

As K12 schools continue to adopt new online resources to facilitate learning, their exposure to security vulnerabilities also grows.

Schools participating in the **Student Data Privacy Community of Practice** are using the resources from 1EdTech to get access to expert vetting of online applications. Early adopters in this program learn from one another and advance together through collaboration and shared knowledge. The goal of the community is to define guidelines and parameters for Student Data Privacy in Arizona and support the expansion of this work across all local education agencies in the State.

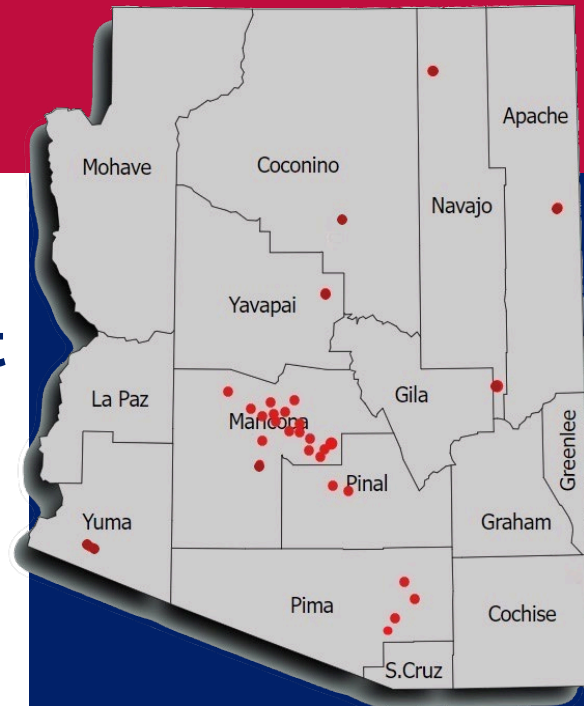
