# ABOUT OUR PROGRAM

The <u>Arizona Homeless Education Program</u> (HEP) is a federally funded program, under Subtitle VII-B of The McKinney-Vento Homeless Assistance Act. The act authorizes the federal Education for Homeless Children and Youth (EHCY) Program and is the primary piece of federal legislation related to the education of children and youth experiencing homelessness. It was reauthorized in December 2015 by Title IX, Part A, of the Every Student Succeeds Act (ESSA).

The mission of the Homeless Education Program is to ensure positive comparable academic outcomes for children and youth experiencing homelessness through implementation of the McKinney-Vento statute.

Our office provides support to the Local Education Agency (LEA) to improve the provision of comprehensive education and related services to homeless children and youths and their families. Our office strategically gathers and makes available dependable, valid, and comprehensive materials and professional development. The goal of this coordination is to provide higher quality learning experiences and improve education and other outcomes for children and families experiencing homelessness.

### **Professional Learning**

The McKinney-Vento Act requires State Coordinators to provide professional learning opportunities for LEA personnel and the LEA Homeless Liaison to assist them in identifying and meeting the needs of homeless children and youths, and to provide training on the definitions of terms related to homelessness. [42 U.S.C. § 11432(f)(6)]. In addition, the law requires States to adopt policies and practices to ensure participation by Homeless Liaisons in professional learning and other technical assistance activities. [42 U.S.C. § 11432(g)(1)(J)(iv)].

In understanding the role of the Homeless Liaison, it is helpful to know the requirements of LEAs. LEAs are instrumental in ensuring that rights and services are implemented, and the MV Liaison is the key individual responsible for making this happen at their LEA. The McKinney-Vento Act includes a "job description" for the local liaison in the form of a list of duties [42 U.S.C. § 11432(g)(6)(A)]. # **ADE Sample Forms**

Our office has created forms for your use. <u>Please check the ADE Homeless Education Program</u> <u>website</u> for additions and revisions on an ongoing basis. These revised sample forms may be adapted for use at your LEA.

#### ADE Identification Procedures Sample

This document will help guide conversations with staff and to ensure your LEA has a procedure to properly identify a potential homeless student. Train district and school staff on the McKinney-Vento Act's definition of homeless and steps to take if working with a student whose living arrangement may meet the definition. Staff members to train include school administrators, counselors, social workers, psychologists, enrollment personnel, secretaries, nurses, attendance officers, and bus drivers.

#### ADE Rights of Homeless Students Sample

Every homeless student shall have access to the same free and appropriate educational opportunities as students who are not homeless. This commitment to the educational rights of homeless children, youth, and unaccompanied youth, applies to all services, programs, and activities provided or made available. This form can serve alongside the Student Residency Questionnaire to ensure families are notified of their rights under the McKinney-Vento Act.

#### ADE Student Residency Questionnaire Sample

Use a housing questionnaire that incorporates informative, yet non-invasive, questions about a student's living arrangement as part of your district's enrollment paperwork. Use the information gathered on this questionnaire to assist with making determinations of McKinney-Vento eligibility.

#### ADE Caregiver's Authorization Affidavit Sample

This form is intended to address the McKinney-Vento Homeless Assistance Act requirement that homeless children have access to education and other services for which they are eligible. The McKinney-Vento Homeless Assistance Act states specifically that barriers to enrollment must be removed. In some cases, a child or youth who is homeless may not be able to reside with his/her parent or guardian; however, this fact does not nullify the child's/youth's right to receive a free, appropriate public education.

#### ADE Transportation Agreement Form Sample

As a best practice, it is highly recommended that your LEA develops forms, such as homeless student transportation requests, parent agreements, and inter-district transportation agreements. Forms should be easily accessible.at any school, or online. A transportation agreement is a terrific way to communicate district transportation expectations, and guidelines.

#### ADE Transportation Request Form Sample

Working with inter-district colleagues to coordinate shared transportation of McKinney-Vento students takes streamlined communication and collaboration. Developing a form to communicate your request is a recommended best practice.

#### ADE Transportation Best Practice Guidance Document

This document provides guidance and shared best practice to ensure your district is arranging transportation so that homeless children and youth participate for the full school day, neither arriving late nor leaving before the school day has ended.

#### Best Interest Determination (BID)

Local Homeless Liaisons can play an instrumental role in assisting homeless parents, guardians, and unaccompanied youth in selecting the school that will best meet the student's needs. The Local Homeless Liaison should consider utilizing the Best Interest Determination checklist. This sample form will help guide the conversation to make the best determination.

#### Dispute Resolution Process LEA vs LEA

The McKinney-Vento Homeless Education Assistance Improvements Act of 2001 requires the State Educational Agencies (SEAs) have a procedure for the prompt resolution of disputes regarding the educational placement of homeless children and youth. The process outlined in this process will aid in processing disputes at the State level.

#### • Dispute Resolution Process Family/Student vs LEA

LEAs should take necessary steps if a dispute arises over school eligibility, school selection, school enrollment. Having established a procedure ahead of time will help streamline the process and ensure your LEA are not creating barriers to enrollment and full participation.

#### ADE End of Year Notification Letter Sample

This example may be put into practice to notify parents that current services being provided will not automatically continue into the next school year. The letter advises them how to request review of McKinney-Vento eligibility if they remain in a homeless situation as the new school year approaches.

### **Technical Assistance**

Through strong leadership, and collaboration and communication with local Homeless Liaisons, the State Coordinator can help ensure that districts carry out the requirements of the McKinney-Vento Act. State Coordinators should establish clear-cut policies and procedures at the State level and communicate this information to districts in order to facilitate the smooth and consistent implementation of the McKinney-Vento Act. ### **Grants & Monitoring Updates**

The Education for Homeless Children and Youth (EHCY) program is enacted via the McKinney-Vento Homeless Education Assistance Act, and was reauthorized by Title IX, Part A of the Every Student Succeeds Act (ESSA) of 2015. Through the EHCY program the U.S. Department of Education (USDE) provides annual grant award to State Education Agencies (SEAs) to then subgrant to Local Education Agencies (LEAs). The purpose of the EHCY subgrant funds is to <u>supplement the services provided to</u> <u>all students</u> to eliminate the specific barriers to the identification, enrollment, attendance, and academic success of children and youth experiencing homeness (42 U.S.C. § 11432(g)(4)).

**Grant Application Details:** ADE awards the EHCY subgrants through a competitive and discretionary process. While the subgrant awards are contingent upon the annual state allocation provided by the USDE, the EHCY subgrants run on a three-year grant cycle. FY24 constitutes the first year of the forthcoming three-year EHCY grant cycle. Please note that the FY24 EHCY grant application will open on **March 1, 2023,** and close on **May 1, 2023**.

**Subgrant Funding Guidelines:** Selection of EHCY subgrantees will be made based on the proposed project's quality, a data-driven assessment of the educational and related needs of students, and the ability of the applicant to meet these needs. Applicants must be able to demonstrate need by having a minimum of 50 students experiencing homelessness enrolled or a homeless rate of no less than 2.9% for the LEA. An LEA may consider joining a consortium comprised of LEA Consortium Members within their service area or zip code to meet the minimum threshold requirements of this application.

**Subgrant Consortium Guidelines:** Please note that it is the responsibility of the LEAs that must join consortia to meet the minimum requirements of the application to identify, communicate, and establish consortium requirements prior to submitting an FY24 EHCY grant application.

Each consortium must establish a fiscal agent to ensure compliance with the terms of the grant, including but not limited to uploading its <u>Memorandum of Understanding (MOU)</u>, Assurances and Certifications for each LEA Consortium Member, program narrative responses reflective of the identified needs of each LEA Consortium Member, and a proposed budget that is reflective of the fiscal agreements comprised in the MOU.

**Recommended Next Steps:** LEAs should begin preparing for the FY24 EHCY grant application process by reviewing the <u>McKinney Vento Homeless Assistance Act – Funding Uses</u>, <u>draft of program narrative questions</u>, and the <u>EHCY Funding website</u> for forthcoming updates and resources. Additionally, LEAs are strongly encouraged to review their document. You should begin reviewing current internal processes and procedures, as they relate to McKinney-Vento statute, as the grant application process will require evidence of these procedures. Lastly, consider the items listed below to ensure the timely preparation and submission of the FY24 EHCY grant application: implemented in your district. Below are potential items to begin gathering for the application process. Additionally, please be prepared to provide supporting documentation related to data as the application process will be heavily influenced by data driven factors.

• Attendance procedure

- Caregiver Authorization
- Data related to academic progress through assessment data collection or grades, attendance, and graduation rates
- Dispute Resolution procedure
- District training agendas and participant logs
- Fines and fees procedure
- Identification procedure

- LEA board policies related to the EHCY program
- Missing immunization procedure
- Needs assessment yearly results
- Student Residency Questionnaire (SRQ)
- Transportation procedure
