



- How do I get access?
 - You must have an ADEConnect account.
 - Request the *AzEDS Data Coordinator SPED Reports* role from your local ADEConnect Entity Administrator.

Trending Topics Correcting Concurrencies

- Integrity Errors -40040 and -40057
- Check the SPED50 Report available in AzEDS Portal
 - Check SPED99 if the student with concurrency issue is not on the SPED50 report.
 - INTEG15 will also name the concurrent PEA in the error message.
 - If your PEA name is the only name in the INTEG15 error message, your PEA is concurrent with itself, or the other PEA has orphan data.
- Contact the concurrent PEA and document all efforts to clear up the concurrency.
 - Email
 - Phone Call
- October Data Collection Phase III
 - If concurrency integrity errors were not fixed, both PEAs will be required to complete Phase III
 - PEAs that had unresolved concurrency errors at the end of phase II will need provide documentation that efforts were made to clear up the error. If the error is due to the other PEA's inability to resolve and that is the only reason for non-reconciliation, then PEA Determination will not be affected.

Trending Topics <u>Reporting Parentally Placed Students</u>

- Two places to report Parentally Placed Students
 - During Phase 1 of SPED October 1 Data Collection
 - Parentally Placed Private School Student Survey

- Reporting students on an Independent Service Plan (ISP) to AzEDS
 - Guidance: <u>Reporting Parentally Placed students that have an ISP</u>

Trending Topics IDEA Parent indicator for Student Parent Relationship

- ESS now owners in FY24 of Data Quality Validation rule -51003 (Student has missing Parent information.)
- New flag for IsIDEAParent added to StudentParent relationship table in AzEDS
- IsIDEAParent will indicate which relationship reported meets the definition of *IDEA Sec. 300.30 Parent* and is the responsible contact for the student's IEP.
- Rule -51003 will be updated to validate for all dates of a SPED LRE, a relationship is reported with IsIDEAParent, and will be a Warning only in FY24.

Trending Topics ADM Reports

- Average Daily Membership (ADM) Reports are under the purview of School Finance. Including the SPED20 and SPED30 reports.
 - Contact School Finance for assistance with ADM Reports
- To ensure overall data quality, ESS October 1 Data Collection (ODC) and Special Education Data Dashboard (SEDD) SPED Exit will remove students failing the following integrity rule types:
 - ADM
 - FED/SPED
 - Accountability, Other

Top 3 Integrity Errors

Top 3 Integrity Errors

Integrity Error -40061

- Error Message:
 - Least Restrictive Environment (LRE) falls outside this PEA's calendar [Actual1].
- Common Issue At This Time:
 - Calendar is not yet certified.
- Possible Solution:
 - Certify the calendar.
 - <u>School Finance Calendar Guidance</u>
 - School Finance Calendar Certification instructions

Top 3 Integrity Errors

Integrity Error -40041

- Error Message:
 - Invalid age for need code DD.
- Common Issue At This Time:
 - Student over 10 years old plus reported with DD Need.
- Possible Solution:
 - Complete re-evaluation asap.
 - FY23: Re-evaluated need may be backdated to the day prior to student's 10th birthday.
 - FY24: Warning rule -40072 (Student Need of DD must be re-evaluated prior to the student's 10th birthday) will become a Failure and will fail 2 months prior to student's 10th birthday. Backdating will not be allowable.

Top 3 Integrity Errors

Integrity Error -40020

- Error Message:
 - The Least Restrictive Environment (LRE) does not comply with the Concurrent PEA and Least Restrictive Environment (LRE) Code Eligibility matrix.
- Common Issue At This Time:
 - LRE D selected for an AOI
 - LRE not D selected for a Private Day School
- Possible Solution:
 - <u>Review the Concurrent PEA and Least Restrictive Environment (LRE) Code Eligibility</u>
 <u>Matrix.</u>
