FRPL Group B Weight

- Funding for the new FRPL weight will be calculated manually for FY 2023, but has not yet been added to payments.
- Initial adjustments for the FRPL Group B weight will be added in February March and published on the School Finance website in a manner similar to funding for the Gifted Group B weight.
- The SUPP72 report in AzEDS shows students for which a qualifying need has been reported.



New Budget System Beta Test

- Thank you to everyone that volunteered to test the new budget system.
- Volunteers will receive training in the next few weeks and test the system this spring.
- If you volunteered and were not selected, we may reach out as we need additional support or for other opportunities to contribute.



Financial and Compliance Audit Reports

- Districts and charters are required to submit financial and compliance audit report files to the Arizona Department of Education (<u>ARS 15-914</u>).
- School Finance published a <u>Hot Topic</u> with instructions to upload the required files.
- Files should be submitted in the same way as budgets and AFRs.
 - Since the legacy budget system does not extract data from PDF files, the message "File Failed to Process" will display even after a successful upload.

School District Employee Report (SDER)

- School District Employee Report (SDER) data is published at schoolfinancereports.azed.gov
- Revisions are possible February 1st through March 1st
- Review the SDER96 report to confirm the Teacher Experience Index data

Transportation Reporting

- ARS 15-922 requires that districts submit transportation route data within 12 days of the 100th day of school.
- The window for submitting this data is now open.
- The <u>Transportation Reporting Manual</u> and <u>FAQ</u> are linked from the <u>Hot Topic</u> published on Monday (1/9).



ADE SCHOOL FINANCE

SECTION 4 Open Enrollment Data

- <u>ARS 15-816.01</u> requires ADE to report on open enrollment participation by district, school and county
- The report must include:
 - The number of pupils in each district and school enrolled as nonresident, resident transfer, and resident pupils
 - The school districts from which students are enrolling



- ADE collects limited data on open enrollment from districts and charters
- Maricopa Association of Governments and ReadOn Arizona significantly improved our ability to report on open enrollment by geocoding data
 - Defining the home/boundary district for each enrollment
- The data requires further review, but should provide interesting insights into open enrollment trends
