
Preschool Transitions

Best Practices

Public Education Agencies (PEAs) Best Practices for Timelines:

Data is collected from PEAs regarding the percentage of children who participated in Early Intervention and who have an IEP by the time they turn three years old.

Assign staff to monitor the PEA Notifications during the summer months as well as throughout the school year, so that transition activities can be scheduled and completed by the time a child turns 3.



Best Practices for PEAs at the Transition Conference:

The Transition Conference is a meeting coordinated and facilitated by the AzEIP Service Coordinator. It is an opportunity for families to learn about options available to them from those knowledgeable about the programs.

Inform parents about the continuum of placement options and opportunities for inclusion with typically developing children.



Best Practices to Support Family Participation in the Review of Existing Data

As part of the evaluation process, the group of people who would comprise a student's IEP team and other qualified professionals review all relevant, existing information about a child. One way to capture this information is to utilize the Review of Existing Documentation form by the Early Childhood Technical Assistance (ECTA).

A best practice is to ask the family to share information about all the child's learning environments: home, Early Head Start, other preschool, outside therapy, or other programs the child attends.



Tips and Reminders

In-by-Three *Important* Tips for Summer Months & Breaks

- •Assign 2 people to receive Part C referrals or have access to a "CtoBinbox". Create an email address specifically for Part C referrals to be monitored by a minimum of two people.
- •Respond to Part C service coordinators upon receipt of referrals. Verify child was referred to the correct district.
- Maintain contact with Part C Service Coordinators.
- •Ensure that staff are available to attend meetings, conduct assessments, and complete evaluations to ensure children are in by three.
- •Ask staff to sign up to participate in transition activities during summer.
- •Use a system to track In-by-Three Transition due dates.

End of the Year Close-Out Tasks for My Teaching Strategies Gold (TSG)



- •Spring Checkpoint is June 2, 2023
- •OSEP exits are due June 30, 2023
- •Ensure that the correct Student IDs are being used in the children's portfolios
- •Do not use default as the site; instead, use the name of the program
- Portfolio transfers to school district for OSEP Exits
- •Renew licenses, start getting those POs together
