IDENTIFIED STUDENT AND ENROLLMENT DATA

LEAs were required to submit the collected identified student and enrollment data for each site to ADE prior to April 15.

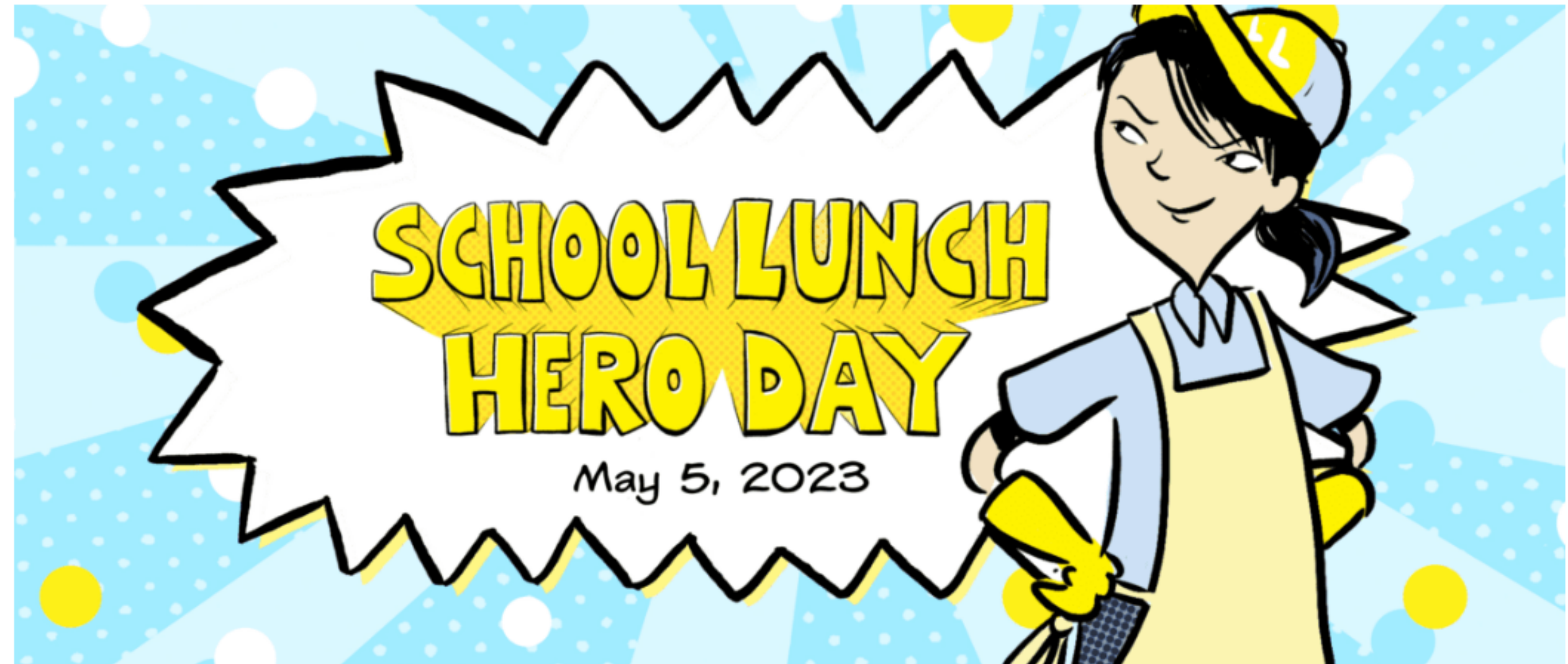

Paid Lunch Equity

GUIDANCE FOR SY 2023-2024 PAID LUNCH PRICING

For SY 2023-2024, SFAs with a positive or zero balance in the nonprofit school food service account as of June 30, 2022, are exempt from PLE pricing requirements. This can be shown with their current Annual Financial Report (AFR).

OPTIONAL TOOL FOR EXEMPT SFAS

While not required, exempt SFAs may still use USDA's PLE tool to complete the steps necessary to determine their target SY 2023-2024 paid lunch price and adjust their paid lunch prices accordingly.

Paid Lunch Equity

GUIDANCE FOR SY 2023-2024 PAID LUNCH PRICING

SFAs that had a negative balance in the nonprofit school food service account as of June 30, 2022, must follow PLE requirements when establishing their paid lunch prices for SY 2023-2024.

SFAs may use the prices they last charged students as the basis for their SY 2023-2024 paid lunch price calculation, even if those prices were charged during a year the SFA was not required to comply with PLE requirements.

If an SFA did not charge for meals during SY 2022-2023, such as an SFA that operated the Community Eligibility Provision, or Provisions 2 or 3 and is returning to standard counting and claiming in SY 2023-2024, they may use the most recent paid lunch price data as the basis for its SY 2023-2024 paid lunch calculation.

Paid Lunch Equity

RAISING PAID LUNCH PRICES

SFAs are not required to raise their paid lunch price by more than 10 cents for SY 2023-2024 from the last year they charged for paid lunches. SFAs can still choose to raise the price by more than 10 cents.

Community Eligibility Provision

APPLYING FOR THE CEP

CEP is available to sites, groups of sites, or entire LEAs that have an identified student percentage of 40% or greater. Check the [CEP Annual Notification and Publication for School Year \(SY\) 2023-2024](#) to see if you qualify.

The deadline to apply is **June 30, 2023**.

Applications for Summer Programs

SUMMER FEEDING OPTIONS FOR SCHOOLS

Children need good nutrition, all year long. The Summer Food Service Program (SFSP), National School Lunch and Breakfast Programs (NSLP and SBP), and the Seamless Summer Option (SSO) make it possible for schools to provide nutritious meals after the regular school year ends.

- **SFSP**: Ideal for sites offering enrichment, recreational or activity programs. Maximum rates of reimbursement for meals served.
- **Extending the NSLP and SBP**: Option for any school(s) hosting an academic summer school and intend on only serving enrolled students.
- **SSO**: Reduced paperwork, slightly lower reimbursement rates in comparison to SFSP.

Applications for Summer Programs

APPLYING TO SPONSOR A SUMMER PROGRAM

HNS 03-2023: Application for Summer Programs

To participate as an SFSP sponsor, submit the following by May 30, 2023:

- Management Plan
- Budget
- CNPWeb Sponsor and Site Applications

To apply for the SSO, SFAs must submit CNPWeb Site and Sponsor Applications.

SFAs wishing to extend participation in the NSLP/SBP must contact their assigned HNS specialist to confirm eligibility and discuss application requirements.

Non-Congregate Summer Meal Service

ELIGIBILITY

SFSP 07-2023: Questions and Answers #2: Summer 2023 Non-Congregate Meal Service in Rural Areas

Qualifying as a Non-Congregate Site:

- Sites must be determined as eligible to participate in SFSP/SSO.
- Only sites designated as 'rural' are eligible to offer non-congregate meal service. Sites designated as urban are not eligible to offer non-congregate meal service.
- Site applications for eligible, rural sites that are located within 5 miles of another potential or approved site that only offers meals in a congregate setting will only be permitted to offer a non-congregate meal service if the SA can verify that the sites do not serve the same population.
 - Examples: Non-congregate sites wishing to serve in proximity to sites classified as a camp or other closed enrolled site.

Non-Congregate Summer Meal Service

ELIGIBILITY

SFSP 07-2023: Questions and Answers #2: Summer 2023 Non-Congregate Meal Service in Rural Areas

Qualifying as a Non-Congregate Site:

- Sites must be determined as eligible to participate in SFSP/SSO.
 - Area Eligible: Current-year school data may be used to establish area eligibility for the SFSP and SSO, excluding camps. For a site to be determined area eligible, school data must indicate that the proposed meal site is located in the attendance area of an elementary, middle, or high school where at least 50 percent of the children are eligible for free or reduced-price school meals.
- Only sites designated as 'rural' are eligible to offer non-congregate meal service. Sites designated as urban are not eligible to offer non-congregate meal service.
 - Rural: Any area in a county that is not part of a Metropolitan Statistical Area or any "pocket" within a Metropolitan Statistical Area which is determined by the State agency to be geographically isolated from urban areas.

Non-Congregate Summer Meal Service

ALLOWABLE NON-CONGREGATE MEAL SERVICE

SFSP 07-2023: Questions and Answers #2: Summer 2023 Non-Congregate Meal Service in Rural Areas

Home Delivery -

- Requires written consent from the eligible child's parent or guardian that the household wants to receive delivered meals.
- Provide a record of how many children are eligible to receive meals in the home and how many meals were provided in each meal delivery.
- 'And Justice for All' poster is properly displayed on delivery vehicles and civil rights requirements are met.
- Local health, food safety, and sanitation standards are followed.
- Meal delivery times are followed as stated on the approved application.

Non-Congregate Summer Meal Service

ALLOWABLE NON-CONGREGATE MEAL SERVICE

SFSP 07-2023: Questions and Answers #2: Summer 2023 Non-Congregate Meal Service in Rural Areas

Bulk -

- May serve up to 10 days of meals at one time (consider food safety).
- Required food components in the correct serving sizes must be served.
- Food items must be clearly identifiable as making up reimbursable meals.
- Menus are provided with directions indicating which items are to be used for each meal and the portion sizes.
- Only minimal preparation is required, and food is not being provided as ingredients for recipes that require chopping, mixing, baking, etc.

Non-Congregate Summer Meal Service

ALLOWABLE NON-CONGREGATE MEAL SERVICE

SFSP 07-2023: Questions and Answers #2: Summer 2023 Non-Congregate Meal Service in Rural Areas

Meal Pick-Up -

- Establish procedures and processes that ensure meals are distributed only to children or to the parents or guardians of eligible children, and that duplicate meals are not distributed.
- 'And Justice for All' poster is properly displayed at pickup sites and civil rights requirements are met.
- Local health, food safety, and sanitation standards are followed.
- Meal pick-up times are followed as stated on the approved application.

USDA Foods in Schools Program Updates

**EMAIL USDAFOODS@AZED.GOV
FOR USDA FOODS REQUESTS**

The week of June 5th is the last week of deliveries from US Foods for brown box items; any remaining entitlement can be transferred to DoD Fresh to receive deliveries of fresh produce through the summer months.

- **SSO Operators:** start planning orders with remaining entitlement on surplus or DoD.
- **SFSP Operators:** check to ensure you have FFAVORS access; processing can take 2-3 weeks.


