

FY 2023 Statewide Recalculation

- Statewide Recalc completed 9/13/2023 and adjustments were applied to September Payment
 - Based on student data from 7/17/2023
- FY23 SRC BSA55 Reports are available
 - Gifted Add-on funding was updated
 - FRPL Add-on funding was updated



FY 2023 Annual Financial Report

- FY23 AFRs are to be submitted in the new Budget System
 - District AFR
 - Charter AFR
 - Deseg AFR
 - School Level AFR
 - Food Service AFR
 - K-3 Reading AFR
- Important that you do not change any formulas in the Excel File

FY 2024 Payment Schedule

- Monthly Basic State Aid Payment remains on the 15th business day of the month
- Data Capture dates remain on the 15th day of each month (weekends apply)
- Preliminary Payment emails will be sent on or about the 18th of each month

FY 2024 Payment Schedule

- Classroom Site Fund payments will continue to be made shortly after Basic State Aid payments each month
- Proposition 123 Additional Funding (\$75M) and Supplemental State Aid (\$300M) will be paid in November and May
- Instructional Improvement Fund payments in January and June

FY 2024 Fiscal Operations Updates

- Base Level Amount increased to \$4,914.71 from \$4,775.27
 - 2.9% total increase
- District Additional Assistance increased 9.4%
- Charter Additional Assistance increased 3.2%



FY 2024 Fiscal Operations Updates

- Transportation Support Level
 - State support per daily route mile increased 2.1%
 - Under 0.5 miles per eligible student: \$2.89
 - 0.5 to 1.0 miles per eligible student: \$2.37
 - More than 1.0 miles per eligible student: \$2.89
- Increase in FRPL Group B weight to 0.018 to 0.022 (approx. \$10M)
- Results Based Funding Repealed (\$68.6M)



FY 2024 Fiscal Operations Updates

- Aggregate Expenditure Limit suspended for FY 2024
 - School Finance will still be required to report by 11/1
 - BUDG-AGD Reports will still be published

FY 2024 FRPL Calculation Changes

- The FRPL ADM Generated will only be while the student is reported with the Income Eligibility 1 or 2 need.
- There will still be a comparison between the ADM Generated with AzEDS data and the Health and Nutrition Data
- Current Year AzEDS data will be used until Health and Nutrition Data is available (effective FY25)
- The larger of the 2 "ADM" numbers will be used for funding.
- Expected Rollout by end of October

Weighted ADM	235.304	286.865
Total Funding	\$1,134,423.90	\$ 1,383,737.12

FY 2024 Gifted Calculation

- The Gifted ADM Generated will only be while the student is reported with Gifted Need
- ADE Plans to implement Gifted weights in AzEDS and the Payment System sometime in FY 2024

Other Updates

- Vehicle Inventory Report
 - Deadline to submit was 7/15, but please contact School Finance if you need to submit
 - Payment system will not generate Transportation Support Level if the vehicle inventory report has not been submitted
 - Payment system will cap route miles based on vehicle inventory report data



Other Updates

- School District Employee Report
 - September 15th
 - SDER system opens to accept submissions.
 - October 15th
 - SDER system closes to new submissions and revisions.
 - Preliminary Teacher Experience Index (TEI) is calculated.
 - Revisions are possible February 1st March 1st
 - Revisions are not allowed after March 1st
