

# Overview



#### What is the October 1 Data Collection?

- Students enrolled and receiving SPED services on October 1
- Students ages 3 21 as of October 1
- Data collected by District of Residence (DOR)
- Unduplicated count by Federal Primary Need Indicator (FPNI)
- Personnel Data for teachers, paraprofessionals, and related service providers.

### Why is October 1 Data Required?

- Individuals with Disabilities Education Act (IDEA) 2004, Section 618
- Used to verify the unduplicated count of students receiving SPED services on October 1
- ADE is required to submit data to the Office of Special Education Programs (OSEP)
- Used to determine base funding for Federal Part B allocations distributed to State and PEAs
- Adjustments for new or expanding charter schools

#### Who Submits October 1 Student Count Data?

- Public School Districts
- Public Charters
- Secure Care Facilities
- AZ Department of Corrections
- AZ Department of Juvenile Corrections
- County Juvenile Detention Centers
- County Jails

Students identified as fee-for-service or vouchered to ASDB are to be counted, verified and reconciled by the DOR for the October 1 count.

### Who/What's Required: Personnel Count

- Personnel data is reported by PEAs, approved private day schools, and approved residential treatment centers that provides SPED services.
- Personnel serving students with disabilities ages 3-21 regardless of funding source (i.e., Part B of IDEA, State, or local).
- Report full-time equivalent (FTE) personnel employed and contracted to provide special education and related services on or about October 1 of the reporting year.
- ASDB will be responsible for reporting their personnel by FTE within the ODC application.

# What if I fail to submit my count?

- May result in withholding of IDEA federal funds
- Late submissions may impact PEA Determination\*
  - ESS DM oversees the validity and timeliness of 4 data points:
    - Verification Count Submission (Phase I)
    - Verification counts reconcile with final data extracted from AzEDS (Phase II)
    - Submission of SEDD (Special Education Data Dashboard) data components.
    - Submission of discipline data through AzEDS











      - LEA SIGNER: same as LEA user; however should only be assigned to SPED Director, Business Manager, CEO, or Superintendent of the PEA. Responsible for validating and signing off on data submitted to ADE

The ESS October 1 Data Collection (ODC) application collects and validates student counts for SPED students provided services over October 1. This collection is a requirement of all Public Education Agencies (PEAs), even if the agency did not serve students over October 1

# Counting Students & Personnel

#### **ODC Phase I - Verification**

- Step 1: Count your SPED students
  - Unduplicated (by FPNI)
  - Ages 3 21
  - Receiving SPED services on October 1
  - Required by all PEAs
    - By District of Residence (DOR)
  - Public School Districts ONLY
    - Parentally Placed Private/Home School Students
- Step 2: Certify your Data
  - LEA Signers Only
  - Electronic Signature

### How to count your SPED students

- Student must be receiving SPED services on October 1
- Utilize the resources found on the ESS Data Management website
  - October 1 Data Collection Manual
    - October 1 Checklist
    - October 1 Do's & Don'ts
- Use student rosters
- Ask every teacher to conduct a head count
- Query your Student Information System (SIS)
- Any method that works for you
- Do NOT rely on AzEDS data!

#### As the DOR include students who:

- Are attending a school site within your PEA
- Other PEAs (not through open enrollment)
- Are not physically present on October 1
  - Student count does not take attendance into consideration
- Have an expired IEP or evaluation if they are receiving SPED services
  - Expectation is the IEP will be in compliance as soon as possible
  - Does not apply to students on initial IEP
- Have enrolled or withdrawn from SPED on October 1

#### As the DOR include student who:

- Approved Private Day Schools
- Approved Residential Treatment Centers
- Students vouchered through ASDB but physically attending your PEA campus
  - This includes fee-for-service or co-op ONLY
- Accommodation Districts
- Head Start Programs
- Parentally Placed Private Home School Students
- Attend your PEA and reside in a Transporting Districts

#### What is NEW for FY24

- Previous year, Elementary districts would be considered the district of residence (DOR) for their high school students within their district boundaries.
- **New FY24** Arizona <u>House Bill 2124</u> amending Section 15-448.

The high school district of attendance (DOA) will be considered the DOR and is required to include the student in their student count.

### Determining student's age

- Students must be between the ages of 3 and 21 years of age
- October 1, 2002 October 1, 2020

# If October 1 falls on a non-session day - Student is included if

Enrolled on last day school was in session before October 1.

#### AND

Continued receiving SPED services on the first day school was in session following October 1.

#### Who counts the student?

The PEA where the student was enrolled PRIOR to October 1.

### Personnel Counts - Overview (the WHY)

- Section 618 requirement
- Government Performance and Results Act (GPRA) indicators
  - Number of states with at least 90% of SPED teachers of school-age students, who are fully certified in the areas in which they are teaching.
  - Number of states with at least 90% of early childhood SPED teachers certified in the areas they are teaching.

### **Personnel Counts – Business Rule Requirements**

- Employed or contracted
- On or about October 1
- Includes personnel from private agencies
- Students with disabilities ages 3-21
- Regardless of funding source (IDEA Part B, State, or local)
- DO NOT count personnel serving children from birth to age 2 (unless they also serve ages 3-21)

### Personnel Counts - Fully Certified vs Not

- Teachers reported as fully certified must meet the State standard, based on the definition of fully certified in 34 CFR §300.156(c).
- Arizona definition: A fully certified teacher is a teacher with a bachelor's degree, full state certification (intern, provisional, or standard teaching certificate), and who demonstrates subject matter competency in the academic subject areas they are assigned to teach. Except for special education, charter schools are exempt from certification.
- **Federal definition:** 1) have obtained full certification as a SPED teacher (including certification obtained through alternative routes to certification), or passed the State SPED teacher licensing examination and hold a license to teach in the State as a SPED teacher, except that a SPED teacher teaching in a public charter school must meet the requirements set forth in the State's public charter school law; 2) not have had SPED certification or licensure requirements waived on an emergency, temporary, or provisional basis; and 3) hold at least a bachelor's degree.

#### Personnel Counts - FTE Calculation

- Based on length of school day
- Full-time employees are reported as 1.0 FTE.
- Part-time employees are reported according to the amount of time they work.
- FTE can be calculated by day, week, month, or year.
- Up to two decimal places.

#### → For example:


- A half-time employee is reported as 0.5 FTE
- A quarter time employee is reported as 0.25 FTE

#### Personnel Counts - FTE Calculation Use Cases

- Calculate FTE based on a school day (6 hours):
   Part-time resource teacher works 4 hours per day.
   4 / 6 = .67 FTE
- Calculate FTE based on a school week:
   SLP visits once per week for 4 hours.
   days per week x 6 hours per day = 30 hours.
   4/30 = .13 FTE
- 3. Calculate FTE based on a school year:
  Audiologist visits 15 hours throughout the year.
  180 school days x 6 hours = 1,080
  15 / 1,080 = .0138888 (round off to .01)
