Anyone that is administering the practice tests to students may have a copy of the Teacher's Edition. The Teacher's Edition provides scripted directions, the key to the multiple-choice questions, and the Speaking and Writing rubrics.

Is a unidirectional microphone absolutely necessary for the administration of Unit 5 for Kindergarten and Grade 1? Our internal computer microphones are good at picking up sound. In the event we need to order a microphone, will a recommendation be made where to get it?

A unidirectional microphone is what is recommended by the vendor to obtain optimal recordings for the test. The Test Administrator and the student will sit opposite to each other so the student cannot see the screen; therefore, the internal microphone will not be able to capture the student responses. It is highly recommended that the LEA have and use the recommended technology.

When will the Speaking practice test be ready so we can test it and for which grade levels?

These are available now. There are sample tests for all grade levels K-12. See response above. The new Unit 5 (Speaking) Sample Test for Kindergarten and Grade 1 in TestNav is expected to be available in November.

Will the Item Specifications Documents be available for download from the ADE website once they are transferred to the correct format? Will we be notified when they're available on the ADE website?

Yes, the Item Specifications Documents will be available in the AZELLA web page as soon as the 508-compliance conversion has been completed. ADE will notify districts as soon as they are posted in November.
