• SPED72

- SPED Participation Report filtered by District of Attendance (DOA) or District of Residence (DOR)
- View student's SPED need(s) and LRE
- Post-integrity
- Details if student is passing/failing FED/SPED Integrity
- Updated: Daily after integrity processing

SPED Reports 101 Focus



• SPED73

- October 1 FED/SPED Report filtered by DOA or DOR
- Verify SPED students served on the October 1 child count
- Students are categorized in two sections:
 - Included in the October 1 count
 - Excluded due to failing FED/SPED and/or Membership Integrity
- Updated: Daily after integrity processing

• Things to know

- For SPED data: The requirements are to report any incident that results in the removal of a SPED student from their learning environment. There may be other units within ADE that have different discipline data requirements.
- The terms behavior & violation are the same.
- Currently, a bug is being investigated. When an incident is submitted, the behavior is not being reported. The DISC72 is displaying behavior = other. This is failing integrity.
- Please be sure to include entity ID in your incident ID. (1234-567.

- Reminder: Preschool Outcomes are collected in AzEDS starting school year 2024.

• Things to know:

- Assessment dates are not reported to AzEDS. The begin date of the entry outcome should align with the SPED LRE start date.
- The exit outcome date should align with the SPED LRE exit date.
- Missing preschool outcome data will result in an integrity error. Preschool outcome integrity errors do not affect ADM funding or October 1 data.

- Entry outcomes should be entered without delay, and no later than two weeks after enrollment in the program.
- Exit outcomes should be submitted within 15 days after the child exits the preschool special education program.

Special Education Data Updates

Top 3 Integrity Errors

Steps for Solving Integrity Errors

- 1. Check SPED72 report to review if any SPED students have integrity errors
- 2. Check INTEG15 report to identify specific SPED integrity errors
- 3. Pull up the integrity error tool to assist in solving the error
- 4. Review the relevant reports in the AzEDS portal to locate the issue
- 5. Make the applicable changes in your student information system, sync them to AzEDS
- 6. Check the SPED10 within a few minutes to see if the changes you made have landed in AzEDS the way you expected
- 7. Let integrity run overnight and check INTEG15 or SPED72 the next day to see if error is resolved

• Error Message:

• Missing Resident School ID for reported SPED LRE.

• Common issue:

- 30 errors at time of report
- Field is blank

Possible Solution

• Ensure resident school ID is reported

- Error Message:
 - Resident School ID must be within the District of Residence.
- Common issue:
 - 350 errors at time of report
- Possible Solution
 - Align dates of SPED Need/LRE, Enrollment and Resident School ID

• Error Message:

• Student must have a Least Restrictive Environment (LRE) with a start date > the latest exit date of a SPED Exit code 9.

Common Issue

- 134 errors at time of report
- SPED09 must have a new LRE reported at the next in session at the same site

• Possible Solution

• Ensure a new LRE is reported in the next in-session day, otherwise, choose a different exit code.
