\* Oversees BIE schools only. There are 2 types of schools monitored by the Bureau of Indian Education: 1) BIE schools (federal entities) and 2) Tribally Controlled Grant Schools (administered by Sovereign Tribal Nations or are under the direction of a Governing Board authorized by Tribal Nations). Neither of these schools are considered as Public School on Tribal Lands nor have reporting requirements to the State Education Agency.
