Re: October 1 Enrollment Data for Fiscal Year 2024

What is October 1 Enrollment Data?

To ensure compliance with federal reporting and program requirements for the fiscal year 2024, the Arizona Department of Education (ADE) is compiling data for students enrolled on **October 1, 2023**. AzEDS Reports will populate from data that Arizona school districts, charter schools, and PEAs submit via their respective student information system (SIS) to ADE and has **Passed Integrity in AzEDS accordingly**.

Student-level enrollment and program data reported by public education agencies are critically important to funding and program determinations for all education programs. ADE uses the data to manage eligibility, calculate funding of limited federal dollars, comply with federal reporting requirements, and serve as the basis for general population statistics about Arizona schools.

ADE uses October 1 data for internal and external accountability reports, such as statewide dropout rate, and to identify students in certain subgroups. Therefore, schools must review, and if applicable, correct this data as soon as possible so that we can produce accurate numbers for federal reporting.

What are the important deadlines?

The final October 1 enrollment data deadline is Wednesday, January 24, 2024. Between now and January 24, ADE requires PEAs to review and correct data submissions if there are inaccuracies. ADE encourages PEAs contact their relevant ADE program area staff for support.

What are the consequences of not submitting accurate, valid, and timely October 1 Enrollment Data?

ADE will not include any information submitted after 5:00 PM on January 24, 2024, into AzEDS on the relevant grants or reports indicated in the chart below. Incomplete, inaccurate, or late reporting from PEAs will result in delay of state and/or federal funds, potential reductions of federal grant funding and other program enforcement as relevant.

^{*} PEAs must have a director approved ESEA Consolidated application within GME for PEAs to submit Title I Support Program data to AzEDS. PEAs may continually submit Title I Support Program data throughout the data capture dates posted by School Finance.

For fiscal year 2025, ADE will revise the October 1 closing date and move it closer to October 1 to streamline the process. ADE will issue more information at the beginning of fiscal year 2025.

^{**} ESS does validations for SPED data through the ESS October 1 Data Collection process. ESS also captures on January 24, 2024. The process is dependent upon the general October 1 process.

^{***} In AzEDS, school districts and charter schools can verify their EL Program Participation data by reviewing the EL71 - EL Program Participation Report, which is available via the AzEDS Portal application in ADEConnect, and by clicking the Reports tab and selecting English Learner from the menu. Also available is the EL74 – October 1 EL Report, which compiles student level EL Program data for October 1 Enrollment purposes.
