- a. Approval of August 18, 2023, meeting minutes

V. GENERAL AGENCY UPDATES – James Scott

- a. Comprehensive Needs Assessment/PLANS
 - i. New proposed changes for FY25
 - 1. 8-12 Data Questions
 - 2. Single Sites only submit LIAP.
 - 3. Funding tags removed.
- b. Moving towards having budget narrative expectations/requirements aligned throughout all grants.
- c. Roll Out Plan
 - i. 2-3 CNA sessions at the 2024 ESSA Conference
 - ii. Technical Assistance and support to the field as needed.
 - iii. Micro Trainings & Support documents
- d. National Title I Distinguished Schools
 - i. This award started again this year. We received 75 applications and 14 were selected for site visits which started yesterday. Two finalists will be selected and will be submitted to the National ESSA Conference and will be announced in February at the conference. This is in addition to the Exemplary Awards.
- e. Final Allocations Update
 - Currently working on final allocations. We are hoping to get them into GME in the next couple of weeks. Most will be increased. Those receiving a decrease should be aware of why.
- f. Cycle Monitoring
 - i. Changes have been made to the Cycle 4 Monitoring.
 - 1. All LEAs in Cycle 4 will be monitored.
 - 2. 51 LEAs will be on-site.
 - a. Random selection

- g. New grant opportunities
 - i. FY24 EHCY Mini-Grant
 - 1. One time funding that runs through the end of December of 2023. Encourages LEAs to increase staff capacities.
 - ii. FY24 EHCY Cohort II Grant
 - 1. Will run concurrently with FY24 EHCY Cohort I. Is more long term and sustainable.

VI. <u>DRAFT REDUCTION: 21ST CENTURY – Raymond Gee & Anderson Yazzie</u>

- a. Overview
 - 21st CCLC is Title IV-B, a competitive federal grant that is funded by the U.S. Department of Education and administered by the Arizona Department of Education.
 - ii. Programs that maintain a strong commitment to improving math, reading/language arts/literacy, and science.
 - iii. It supplements the students' regular academic school day by creating a rich learning environment before school, after school, and during the summer.
 - iv. These programs offer a wide variety of classes, project-based learning activities, and hands-on enrichment opportunities.
 - v. Targeted Populations:
 - 1. At-risk students from pre-K to twelfth grade that attend schools with a high concentration of students from low-income families.
 - 2. Adult family members of students in the 21st CCLC program.
- b. Who receives funding?
 - i. School districts, consortiums and charters provide services to schools with 40% higher economically disadvantaged students.
- c. Amount of Award?
 - i. Minimum of \$50,000
 - ii. Maximum of \$120,000
 - iii. Awarded for 5 years.
 - 1. The first 3 years 100% of funds will be given, then a 25% reduction in years 4 and 5. No carryover.
- d. Reduction
 - i. Looking to reduce the grant by about 20%. This includes reducing the number of redundancies within the questions.

VII. GRANT DRAFT UPDATE - Aaron Tyler

- a. Currently working on streamlining all grants and reducing the administrative burden. Some of these changes have not been completed and will be requested again. Changes include:
 - i. CNA
 - ii. Entity Plans
 - 1. Single site LEAs will now only submit one plan.
 - 2. Funding/Programming tags removed.
 - 3. ESEA Plan Requirements
 - a. Transitions are still required.
 - b. Targeted assistance programs.
 - c. If disparity between teacher effectiveness are present, then a plan to address is needed
 - d. If serving neglected or delinquent students, you must describe what the program looks like.
 - iii. ESEA Consolidate Application
 - 1. Equitable Services
 - a. Private schools that fail to consult within 5 consecutive years may be "dropped".
 - b. Verbiage Changes
 - i. Clarity provided on Set aside 3a-e, private school approved carryover, 3c-Family/Community Engagement funds, and removing redundant statements of private school information.
 - c. New Category: No longer participating.
 - d. Removal of N/A for Charter Districts
 - i. No longer needs to be indicated.
 - ii. Charters will leave equitable services sections blank.
 - 2. Retention Stipends (Title I-A, II-A, V-RLIS)
 - a. Reduction from 3 to 2 measures of evidence of student success.
 - iv. Title I-A
 - 1. School Eligibility
 - a. Grade spans are now editable.
 - b. Eligibility allows for special eligibility.
 - c. Expanded service has new options.
 - d. Rank & serve contains clearer instructions.
 - 2. Rank & Serve
 - a. Options for ranking method.
 - 3. PPA List
 - a. Clarification
 - b. If 100% rule you must have a \$0.00 balance
 - c. If 125% remaining amount must equal set asides
 - d. For single sites with 125% rule, note will be added that LEAs are exempt from meeting the 125% rule.
 - e. Removal of "Error" if a school site receives a higher PPA

- than those ranked above.
- f. Will be verified by ADE, not automatically.
- g. Will allow for alternative ranking methods.
- 4. Consolidation of Assurances
 - a. #1-14: Required by all LEAs.
 - b. #15-19: Applicable. Individual acknowledgement
 - c. #20-25: Schoolwide Programs. Individual acknowledgement
 - d. #26-28: Targeted assistance programs. Individual acknowledgement.

v. Title I-D

- 1. FY24
 - a. 14 separate assurances and a signature
 - b. Required acknowledgement of each
- 2. FY25 Proposed Version
 - a. 12 assurances with a single "YES" acknowledgement for all 12.
 - b. 1 assurance regarding transition programs
 - c. 1 assurance regarding supplement/not supplant.

- b. Poverty Forms
 - i. Application for Free and Reduced-Price School Meals
 - 1. Unless operating a SPO (CEP, Provision2/Provision 3 non-base year).
 - ii. Income Eligibility Application
 - iii. Alternative income forms are also used when operating SPOs.
- c. Direct Certification
 - i. State system that houses assistance program data.
 - ii. Is to be used solely for the purposes for determining children's eligibility for free/reduced-price school meals.
 - 1. School Meals Free and Reduced-price Eligibility
 - 2. AzEDS Income Eligibility I and II Indicators
- d. Free and Reduced-Price Percentage Report
 - i. Annual report posted by February 15th every year.
 - ii. USDA requirement
 - iii. Calculations based on October of current year for schools collecting household applications.

- 1. % for regular NSLP operations
 - a. Based on site's October NSLP claim data from current year
 - Numerator = number of participants reported eligible for free meals + number of participants reported eligible for reduced-price meals
 - c. Denominator = total participants reported at the site
- 2. % for provision 2 and Provision 3 (Base year)
 - a. Based on site's October NSLP data from current year
 - b. Numerator = number of participants reported eligible for free meals + number of participants reported eligible for reduced-price meals
 - c. Denominator = total participants reported at the site
- iv. Calculations NOT based on current year for schools on CEP or Provision 2 or 3 non-base year.
 - 1. CEP
 - Based on site's established school level identified student percentage (ISP) multiplied by 1.6 at the time of CEP approval.
 - b. Numerator = number of students certified as categorically eligible for free meals (identified students).
 - c. Denominator = total number of participants
 - d. Percentage multiplied by 1.6.
 - 2. Provision 2 and Provision 3 (NON base year)
 - a. Based on site's October base year
 - b. Numerator = number of participants reported eligible for free meals + number of participants reported eligible for reduced-price meals (as of base year).
 - c. Denominator = total participants reported at the site (as of base year).
 - 3. Examples
- e. Direct Certification with Medicaid Data Demonstration Project (DC-M)
 - i. USDA approved ADE to partner with the Arizona Health Care Cost Containment System (AHCCCS) to administer the DC-M.
 - ii. DC-M is the use of Medicaid data files to identify children who are eligible to receive free or reduced-price meals through NSLP and SBP without the need of household applications.
 - iii. Impact has been huge.
