- Coordinate with local community-based organizations to provide services to children, youth, and their families experiencing homelessness to minimize educational disruption.
- Ensure that all children and youth experiencing homelessness receive placement in appropriate programs, such as Special Education, gifted and talented, and English Learner programs.
- Ensure that the McKinney-Vento Liaison of Record provides annual professional learning to LEA staff working with children and youth experiencing homelessness.

• Ensure that the McKinney-Vento Liaison of Record attends a minimum of eight the professional learning hours provided by the Arizona Department of Education (ADE) Homeless Education Program, the National Center for Homeless Education (NCHE), etc. each year. LEAs must provide evidence or certification of hours upon request of ADE for professional learning hours obtained throughout the year.

 - Students experiencing homelessness must be provided services comparable to those offered to other students in the school (42 U.S.C. § 11432(g)(4)).
- The implementation of an attestation of need process to determine support for supplemental services and activities.
