All Data Collection Tasks**

The Arizona Department of Education (ADE) Elementary and Secondary Education Act (ESEA) Programmatic Monitoring includes Main Requirement 5 in each of the four (4) monitoring cycles. Main Requirement 5 covers mandatory elements of the McKinney-Vento Homeless Assistance Act for which every Local Education Agency (LEA) is required to implement.

The purpose of the **Cycle 3 Main Requirement 5 Evaluation Resource** is to supplement the Desktop Monitoring Guidance Tool by providing additional clarifying information, considerations, and resources to support SEA Programmatic Monitoring Specialists in evaluating Main Requirement 5 data collection task submissions. Please note that SEA Programmatic Monitoring Specialists may also utilize this document to support LEAs in revising their Main Requirement 5 ESEA Programmatic Monitoring submissions by sharing applicable data collection task rationales, clarifications, resources, and guidance with LEAs.

The response given by the LEA in the FY25 ESEA Consolidated Grant Application will be compared to the State of Arizona McKinney-Vento Homeless Liaison Contact List to ensure alignment as the main point of contact for the LEA for Homeless Children and Youth</b></p> <p><i>The LEA's McKinney-Vento Homeless Liaison of Record contact information must be the same in both the LEA's ESEA Consolidated Grant "Contact Details" in GME and the "State of Arizona McKinney-Vento Homeless Liaison Contact List".</i></p>	<p>The McKinney-Vento Homeless Assistance Act requires LEAs to designate a McKinney-Vento Homeless Liaison to enact the educational rights of children and youth experiencing homelessness.</p> <p>Additionally, the State Education Agency (SEA) is required to publish the contact information for every McKinney-Vento Homeless Liaison in the State to remove barriers to the identification and coordination of educational rights and services of children and youth experiencing homelessness.</p> <p><b>The LEA must demonstrate that the McKinney-Vento Homeless Liaison contact information is consistent and accurate across the current ESEA Consolidated Grant and the State of Arizona McKinney-Vento Homeless Liaison Contact List.
