#### **AGE RELATED**

#### Q1: CAN A 22-YEAR-OLD BE FUNDED FOR SPECIAL EDUCATION?

**A:** Student must be less than 22 years of age at the time of enrollment. If a student receiving special education turns 22 years of age during the school year, the student shall continue to receive special education through the end of that school year. (ARS 15-764(A)(1)).

### Q2: I HAVE A KINDERGARTEN-AGE STUDENT THAT IS STILL IN PRESCHOOL AND FAILING INTEGRITY. HOW CAN I FIX THIS?

A: Students cannot be in PS if turns 5 years old before September 1st.

### Q3: WHAT IS UNGRADED ELEMENTARY (UE) AND HOW DOES THAT DIFFER FROM KINDERGARTEN?

**A:** UE is only applicable to a student who is Kindergarten age, has one or more Group B disabilities (A, EDP, HI, MD, MDSSI, MOID, OI, PSD, SID, and VI), and receives full-day instruction.

#### **EXITING**

### Q1: CAN A STUDENT HAVE AN ENTRY AND AN EXIT DATE ON THE SAME DAY AT SEPARATE ENTITIES?

**A:** No. AzEDS does not track partial-day attendance. If a student exits special education at one entity and reenrolls later that same day at another, the student would be exited in AzEDS on that day and the first full day of enrollment thereafter would be the entry date.

#### Q2: I AM TRYING TO SUBMIT AN EXIT REASON FOR A SPED NEED. HOW DO I DO THAT?

**A:** SPED exit reason is only required when a student is exiting or changing their Least Restrictive Environment (LRE). SPED needs only require an exit date.

## Q3: IF A STUDENT IS EXPELLED AND DOESN'T BEGIN RECEIVING SERVICES RIGHT AWAY, WILL THIS FAIL INTEGRITY?

**A:** If a SPED exit code of 11 (expelled but still receiving services) is submitted, the student will fail integrity **after 6 in-session calendar days** within the reporting year until a Least Restrictive Environment (LRE) code of H is submitted.

### Q4: WHY DO MANY OF MY STUDENTS SUDDENLY HAVE THE -40055 INTEGRITY ERROR DUE TO INVALID EXIT CODES NOT MATCHING?

**A:** -40055 checks for SPED Exit Date and Code to align with Enrollment. This rule is activated on May 1<sup>st</sup> to ensure exiting data is valid for all students.

#### INTEGRITY AND THE AZEDS PORTAL





#### Q1: HOW OFTEN DOES SPED INTEGRITY RUN?

**A:** Integrity runs nightly in AzEDS. The status of the nightly run can be found on the homepage of the AzEDS Portal: <a href="https://azeds.azed.gov/AzEDSPortal/SystemStatus">https://azeds.azed.gov/AzEDSPortal/SystemStatus</a>

#### Q2: WHERE CAN I FIND THE SPED REPORTS IN AZEDS?

**A:** SPED reports can be accessed in the AzEDS Portal application in ADE Connect. Please contact your Entity Administrator for access. More information on the various SPED reports can be found on the <u>SPED Reports 101</u> document.

#### Q3: WHAT'S THE DIFFERENCE BETWEEN THE SPED72 AND SPED73 REPORTS?

**A:** The SPED72 Participation Report shows students with SPED Needs and/or SPED Program Participation and FED SPED and State SPED integrity results. This report is post-integrity.

The SPED73 - OCT1 FED SPED Report provides a list of students receiving special education services with an indication of whether the student was counted on the federally reported ESS October 1 count.

#### Q4: ARE THE SPED INTEGRITY RULES DOCUMENTED? IF SO, WHERE?

# Q5: IF A STUDENT IS FAILING SPED INTEGRITY DUE TO AN ISSUE WITH MEMBERSHIP REPORTING OR ENROLLMENT DEPENDENCIES, WHOM DO I CONTACT FOR ASSISTANCE?

**A:** Open a support ticket using the 'Help' link at the top right of your ADE Connect homepage.

# Q6: IF I AM UNABLE TO FIND A STUDENT THAT I NEED TO DELETE BECAUSE OF A CONCURRENCY, WHAT CAN I DO?

**A:** Check the Student Analysis Tool within the AzEDS Portal application. Contact your Student Information System vendor with the Resource ID of the transaction(s) to delete. Review the SPED50 – SPED Concurrency Report for more information regarding the concurrency, including the concurrent PEA.

#### Q7: WHY CAN'T I FIND THE SPED07 REPORT IN THE AZEDS PORTAL?

**A:** The SPED07 Report is only available through the ESS October 1 Data Collection application during the Reconciliation Phase.

#### **TUITIONED OUT STUDENTS**





#### Q1: WHAT IS A CALENDAR TRACK?

**A:** Any site may have more than one submitted calendar in AzEDS. These separate calendars are referred to by a track number. AzEDS will use the student's submitted track number to validate in-session days against reported data.

#### Q2: HOW DO I REPORT A TUITIONED-OUT STUDENT?

A: If a student is tuitioned out to a district, the DOA (district of attendance) would report the student with the DOR (district of residence) where the student resides and is enrolled. If a student is tuitioned out to an approved private day school, vouchered to a residential treatment center or a preschooler attends a head start program, refer to the guidance available in the AzEDS Tuition-out Form: <a href="http://www.azed.gov/finance/azeds/">http://www.azed.gov/finance/azeds/</a> Additional guidance is available in our <a href="http://www.azed.gov/finance/azeds/">SPED Student Reporting - Approved Private Day School, RTC, or Head Start document.</a>

#### Q3: WHERE DO I GET ATTENDANCE FOR TUITIONED-OUT STUDENTS?

**A:** If the student is tuitioned out to a district, the DOA will report attendance. If the student is tuitioned out to an approved private day school, vouchered to a residential treatment center or a preschooler attends a head start program, you will need to contact the school of attendance to get attendance information and report to AzEDS.

# Q4: IF A TUITIONED-OUT STUDENT IS FAILING INTEGRITY BECAUSE THE SCHOOL IS NOT APPROVED, HOW CAN I GET IT APPROVED?

**A:** Private Day Schools and Residential Treatment Centers can apply for approval using the ESS Special Education Program Approvals application in ADE Connect. Guidance can be found here:

# Q5: I HAVE A TUITIONED-OUT STUDENT THAT IS ATTENDING AN APPROVED PRIVATE SCHOOL BUT FAILING DUE TO LACK OF AN ESTABLISHED RELATIONSHIP TO THE PRIVATE SCHOOL. HOW DO I RESOLVE THIS ISSUE?

#### **GENERAL QUESTIONS**

## Q1: HOW DO I REPORT A PARENTALLY PLACED STUDENT RECEIVING SPED SERVICES THROUGH MY DISTRICT?

**A:** Parentally placed SPED students in grades K-12 that are receiving proportionate share services would be reported with membership type as Main (M), tuition payer code 2, and LRE code of J. The school of attendance would be the school that they would typically attend if enrolled through the district.

## Q2: WHAT ABOUT PARENTALLY PLACED PRESCHOOL STUDENTS? HOW WOULD THEY BE REPORTED?

A: Effective FY 2020, parentally placed preschool students can no longer be reported to AzEDS and LRE code of PJ is no longer valid because preschool programs are specifically excluded from the definition of elementary grades under A.R.S § 15-101(12) which indicates that "Elementary grades means kindergarten programs and grades one through eight."

#### Q3: I HAVE A STUDENT WITH TWO SSID NUMBERS; WHAT DO I DO?

**A:** Open a support ticket with School Finance using the 'Help' link at the top right of your ADE Connect homepage to request a record merge.

#### Q4: WHAT IS A FEDERAL PRIMARY NEED INDICATOR (FPNI)?

**A:** The Federal Primary need is defined as the need that has the greatest adverse impact on the student's ability to access and progress through the general curriculum. Consult the student's IEP team to determine which need can be marked as the FPNI.

#### Q5: HOW DO I REPORT A 504 STUDENT?

**A:** IDEA is an education law – a grant statute that funds special education programs and entitles each eligible child with a disability to receive a free appropriate public education. Students receiving services on an IEP are reported to AzEDS.

Section 504, part of the Rehabilitation Act of 1973, is a civil rights statute that prohibits discrimination against individuals with disabilities. This falls under the purview of the Office of Civil Rights (OCR) and these students would not be reported to AzEDS unless they are IDEA eligible.

### Q6: I HAVE A PRESCHOOL STUDENT THAT IS AUTISTIC BUT IS NOT ONE OF THE VALID NEED CODES FOR PRESCHOOL. HOW DO I REPORT?

A: The only need codes that are valid for AzEDS reporting are: DD, HI, PSD, SLI, and VI (for a full description of these and other need codes, please refer to the AzEDS SPED Codes in the AzEDS section of the ESS Data Management website:

### Q7: HOW DO I REPORT ATTENDANCE FOR A STUDENT THAT HAS A CHRONIC ILLNESS OR IS HOMEBOUND?

A: For inquiries specific to attendance reporting for students with chronic illness, homebound status or any other enrollment scenarios, please contact the School Finance Analyst Team for assistance. SFAnalystTeam@azed.gov

#### Q8: CAN A HOMEBOUND STUDENT BE REPORTED IN PRESCHOOL OR KINDERGARTEN?

**A:** Current guidance from School Finance is yes. Preschool and Kindergarten are allowable for homebound students. #### **AZEDS SPED EXIT**

#### Q1: HOW DO I REPORT A STUDENT IN AZEDS WHO IS COMPLETING THE 8<sup>TH</sup> GRADE?

Assuming the student received services and was enrolled through the last day of the school calendar, you would use the SPED LRE exit reason SPED13 "School is out."

If the student moved to another school district prior to the end of the school year, you would use SPED LRE exit reason SPED05 "Moved, known to be continuing."

# Q2: HOW DO I REPORT STUDENTS WHO GRADUATE WITH AN "ALTERNATIVE" HIGH SCHOOL DIPLOMA (ONE THAT IS NOT EQUIVALENT TO THAT OF THEIR REGULAR EDUCATION PEERS)?

As Arizona does not provide alternative diploma options, students graduating with diplomas differing from those awarded to regular education peers should not be exited as a graduate. Please review the other questions in this document for additional guidance.

# Q3: HOW DO I REPORT STUDENTS WHO MET GRADUATION REQUIREMENTS AFTER THEIR COHORT CLASS BUT BEFORE REACHING MAXIMUM AGE (E.G., THEY GRADUATED IN 5 YEARS)?

Students in this circumstance meet the federal definition of graduating with a high school diploma and should be reported as such, using SPED LRE exit reason SPED02 "Graduated with regular high school diploma."





## Q4: WHAT ARE THE GRADUATION REQUIREMENTS FOR STUDENTS WITH DISABILITIES IF THE IEP TEAM EXEMPTS A STUDENT FROM CERTAIN GRADUATION REQUIREMENTS?

The FAQ: Graduation of Students with Disabilities in Arizona's Schools is available on the AZ-TAS (Technical Assistance System) Documents web page for guidance.

## Q5: HOW ARE STUDENTS REPORTED WHO HAVE MOVED AND ARE NOT KNOWN TO BE CONTINUING?

Students identified as moved and not known to be continuing are to be reported as dropouts, using SPED LRE exit reason SPED07.

### Q6: IN AZEDS, HOW IS A STUDENT WHO LEFT SCHOOL TO BE HOMESCHOOLED REPORTED?

If a student continues to receive special education and related services from the school, the student should not be reported as exiting the special education program. The LRE would need to be adjusted to match the student's new environment, which would be LRE J "Private school placement, enrolled by parents."

However, if a student leaves the district to be homeschooled and is no longer receiving SPED services, that student would be reported using SPED LRE exit reason SPED05 "Moved, known to be continuing."

#### Q7: HOW SHOULD TRUANT STUDENTS BE REPORTED IN AZEDS?

Report truants as dropouts, using SPED LRE exit reason SPED07 "Dropped out."

#### Q8: HOW SHOULD STUDENTS WHO RECEIVED A GED BE REPORTED IN AZEDS?

A student who received a GED should be reported as a dropout, SPED LRE exit reason SPED07. IDEA regulation 34 CFR §300.102(a)(3)(iv) states: "As used in paragraphs (a)(3)(i) through (a)(3)(iii) of this section, the term regular high school diploma does not include an alternative degree that is not fully aligned with the State's academic standards, such as a certificate or a general educational development credential (GED)."

#### Q9: HOW ARE STUDENTS REPORTED IN AZEDS WHO:

- Joined the military?
- Got pregnant (and is no longer in school)?
- Got married (and is no longer in school?)
- Is a runaway?
- Is missing/unknown?
- Exited public school whereabouts are unknown?
- Was expelled?





- Has a serious illness/injury (and is not receiving regular or special education)?
- Left school to take a job?

If a student is no longer receiving special education, report a student in any of the above situations in the dropout category using SPED LRE exit reason SPED07. Any student who exits special education and does not meet the definition of any of the other exit categories should be reported as a dropout, including students for whom there was no official notice of withdrawal.

# Q10: HOW SHOULD I REPORT A STUDENT IN AZEDS WHOSE PARENTS DECIDE THEY NO LONGER WANT THEIR CHILD IN SPECIAL EDUCATION AND COMPLETE REVOCATION OF CONSENT DOCUMENTATION?

Report the student using the SPED LRE exit reason SPED01 "Transferred to regular education."

# Q11: HOW SHOULD I REPORT A STUDENT IN AZEDS WHO LEFT SCHOOL AND ENROLLED IN A COMMUNITY COLLEGE? THE STUDENT DID NOT RECEIVE A DIPLOMA AND IS NOT CONTINUING IN SPECIAL EDUCATION.

Report the student as a dropout, using SPED LRE exit reason SPED07. Any student who exits special education and does not meet the definition of any of the other exit categories should be reported as a dropout.

### Q12: HOW SHOULD A STUDENT WHO HAS MOVED OUT OF STATE BE REPORTED IN AZEDS?

If you have evidence (e.g., a request for transcripts) that the student is continuing in an educational program, report the student using SPED LRE exit reason SPED05 "Moved, known to be continuing" category. It is not necessary for you to know whether the student is continuing in special education. You only need evidence that the student is continuing in an educational program. A transcript request is acceptable.

Suppose you have no evidence that the student is enrolled in an educational program but know that the family is no longer at their last known residence. In that case, you should report the student using SPED LRE exit reason SPED07 "Dropped out."

#### Q13: HOW IS A STUDENT WHO HAS EXITED AND RE-ENTERED REPORTED IN AZEDS?

In AzEDS, you must report each time a student is exited and re-entered. AzEDS populates the exit data tables as an unduplicated count by extracting the last known exit status for all students.

### Q14: HOW ARE STUDENTS REPORTED WHO DID NOT FINISH THE SCHOOL YEAR, BUT DID NOT OFFICIALLY WITHDRAW?

For example, how should a student be reported whose parent removes them from school 2–4 weeks before the last day, with the intent of returning for the fall term next school year? In this







case, the family has not moved from their residence; essentially, they are taking an extended vacation.

If a parent did not withdraw the student from school, and the student is simply absent, you would not report the student as having exited from special education. The student is still receiving special education services in that the student is still enrolled in a special education program. The fact that the student is not attending that program is at the discretion of the student or parent but does not constitute an exit.

# Q15: HOW IS THE EXIT STATUS REPORTED FOR VOUCHERED STUDENTS WHO ATTEND THE ARIZONA STATE SCHOOLS FOR THE DEAF AND THE BLIND (ASDB)?

ASDB is responsible for reporting SPED participation data to AzEDS, including the exit status, for students that are vouchered to ASDB. Refer to the ASDB Student Reporting resource found on the <u>Data Management AzEDS SPED Reporting page</u>.
