5 Applications selected for verification were not verified correctly. Specifically, the income documentation provided by the household supported that the eligibility status should have been changed from Reduced to Paid; however, the application was processed as eligibility status being changed from Reduced to Free. This contributed toward fiscal action calculations.
